**N. 29th St. – W. Melvina St. to W. Capitol Dr. (ST21110118):**

Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

**N. 46th St. – W. Capitol Dr. to W. Hope Ave. (ST211060120):**

Remove and replace all concrete curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

**N. 66th St. – W. Port Ave. to a point 650 feet m/l south of W. Bradley Rd.
