


Dear Ms. Jones:

We have received your claim in the amount of \$4,123.50, relating to damage allegedly sustained to your residence, garage and personal property on February 3, 2014 when the Milwaukee Police Department made forced entry at 3770 North 72nd Street and searched the premises.

This claim was received by the City on May 6, 2014. Subsequently, our investigation found that the City acted appropriately in the execution of the lawful search warrant and forced entry. Under Wisconsin Statute §893.80 (1g) this claim is deemed denied. We wish to advise you, however, that the Milwaukee Police Department indicated that the search was conducted by the FBI.
