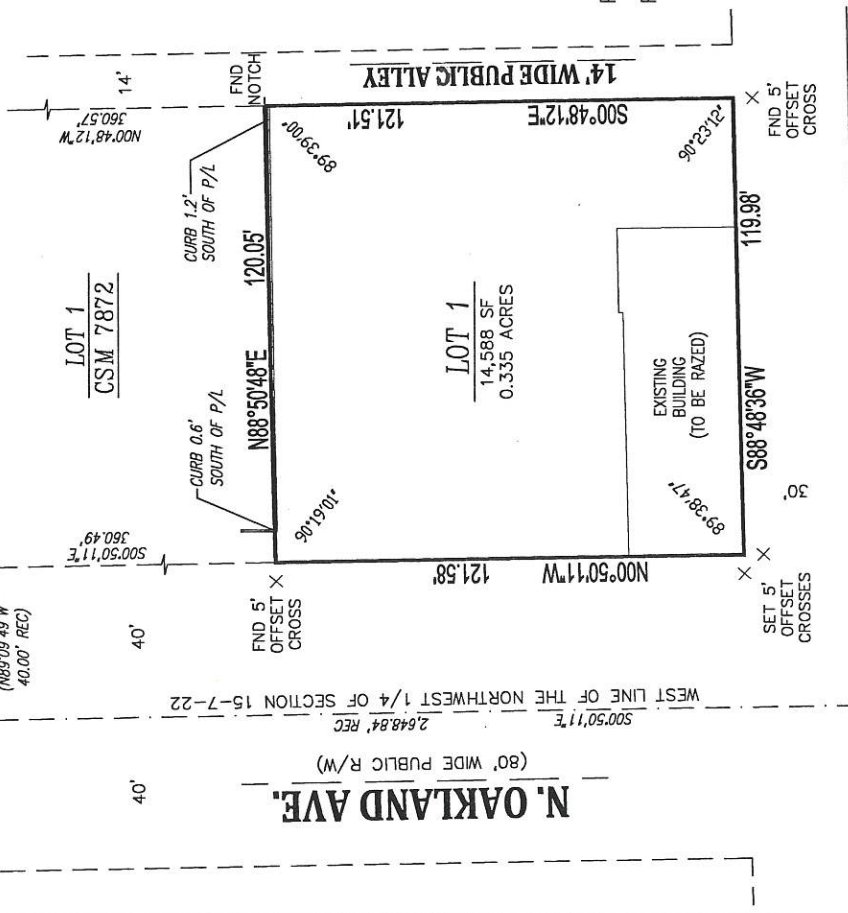

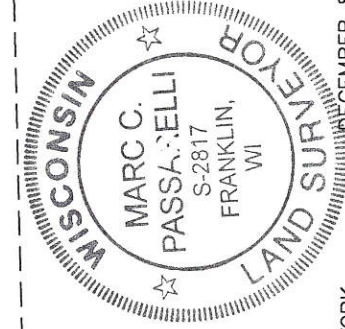


VICINITY MAP

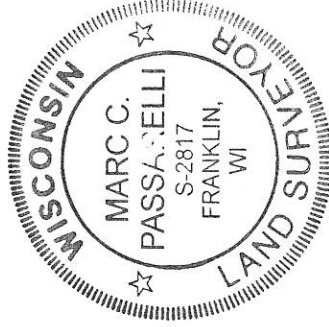
That I have surveyed, divided and mapped a redivision of Lots 31, 32 and 33, Block 3, in Forster and Brand's Subdivision and Lot 2 of Certified Survey Map No. 7872, recorded as Document No. 09376458 on January 26, 2007 in the Milwaukee County Register of Deeds, all being a part of the Northwest ¼ of the Northwest ¼ of Section 15, Town 7 North, Range 22 East, in the City of Milwaukee, Milwaukee County, Wisconsin, being more particularly described as follows: Commencing at the Northwest corner of the Northwest ¼ of said Section 15, thence South 00° 50' 11" East along the West line of the Northwest ¼ of Section 15, 812.44 feet; thence North 88° 52' 31" East, 40.18 feet to the Northwest corner of Lot 1 of said Certified Survey Map No. 7872; thence South 00° 50' 11" East along the West line of said Lot 1, 360.49 feet to the Southwest corner of said Lot 1, also being the point of beginning of the land to be described; thence North 88° 50' 48" East along the South line of said Lot 1, 120.05 feet; thence South 00° 48' 12" East, 121.51 feet to a point on the North right-of-way line of East Locust Street; thence South 88° 48' 36" West along said North line, 119.98 feet to a point on the East line of North Oakland Avenue; thence North 00° 50' 11" West along said East line, 121.58 feet to the point of beginning. 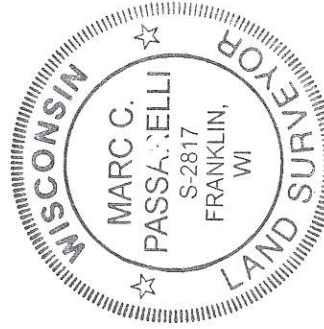
