This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/27/23 Milwaukee Police were dispatched to 3465 N. 60<sup>th</sup> St, for a Trouble with Subject complaint. Officers spoke with the employee who stated that a vehicle has been parked on the premise for over 24 hours. The employee wanted the subject removed from the property. Officers spoke with the owner of the white vehicle who stated that he was waiting for his girlfriend to get off work, and now his car won't turn over. The owner of the vehicle stated that he was waiting for a car jump so he could leave. Officers advised the employee to call in a tow if the vehicle was still at the location for a long period of time or it becomes an ongoing issue.
- 2. On 08/01/23 Milwaukee Police were dispatched to the area of N. 60<sup>th</sup> St W. Keefe Av, for a shooting complaint. Investigation revealed that a shooting occurred in the parking lot of 3465 N. 60<sup>th</sup> St. Officers observed a small trail of blood on the side walk in front of the business. An anonymous citizen relayed to officers, that he observed a victim, who appeared to have been shot in the parking lot. Officers spoke with the employees working inside the business. The employees stated that they heard gun shots in a close proximately to the business, but did not observe anything. Officers reviewed the video cameras and observed the victim walking on foot towards the business, and it appears he was struck by gun fire. The victim is then seen running from the location. The video did not capture the suspect or vehicle description.

- 3. On 07/26/24 at 8:28p.m., Milwaukee Police were dispatched to an Armed Robbery. Officers were advised the caller/victim left their vehicle running with keys in the ignition, while they were in the store. When they exited they found suspects in the vehicle, who fired on shot at the victim, and fled in the vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 4. On 10/14/24 at 11:09a.m., Milwaukee Police were dispatched to a Shooting. On arrival officers located the victim with a gunshot wound to their head. The victim was transported to a local hospital. Investigation revealed this was an altercation between the suspects and victim regarding a drug transaction and money owed. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident, which led to multiple arrests.
- 5. On 10/23/24 at 11:15p.m., Milwaukee Police were dispatched to an Armed Robbery. Investigation revealed the suspect pointed a firearm at the victim in the parking lot and demanded the victim's purse. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 6. On 05/14/25 at 1:58p.m., Milwaukee Police were dispatched to a Battery which investigation revealed did not occur at the business.
- 7. On 08/21/25 at 6:35a.m., Milwaukee Police were dispatched to a Battery. The business stated they were assaulted by a customer, however, did not want to press charges.

P.O. Lupe RIVERA and I responded to an armed robbery carjacking at the location of 3364 N 54th Street on today's date, at 8:28pm.

Upon arrival we spoke with the victim who was verbally identified Alfredo JR. LIMA (W/M, 6/24/1992) who stated he was at the gas station at 3364 N 54th Street at the 60th express gas station. LIMA stated as he was inside the gas station he observed the subjects who were arguing with another customer. LIMA described them as Subject#1(B/M, 5'10, Skinny Build, 15-16 years old, wearing white t-shirt, unknown color sweatpants, Subject#2 is (B/M, 5'4, Skinny Build, 15-16 years old, wearing bape multi color hoodie, black jeans, armed with a tan in color firearm.

LIMA stated as he walked out the store, he observed both subjects inside his vehicle. Subject#1 was seated in the driver seat and subject#2 was in the passenger seat. LIMA stated he attempted get subject#1 out of his (2016 black in color Chevrolet Traverse bearing Illinois Plate CV72239, VIN#1GNKVGKDXGJ262526). LIMA stated subject#2 fired one shot towards him. LIMA stated he last seen both subjects along with his vehicle go southbound on n 60th Street.

LIMA stated his vehicle was running at the time and the keys were in the Ignition.

Officers were able to review cameras, and the store clerk was cooperative.

While on scene, I observed the licenses posted and they were up to date.

#### **Incident Synopsis:**

Occurring on Monday October 14th, 2024, at the approximate time of 11:06am, Milwaukee Police Department, District Seven personnel responded to a shooting complaint at the location/business of 3465 N.60th St. (Express Gas Station).

Upon arrival to the location of 3465 N.60th St. responding officers located victim identified as Rashaad L. CALHOUN (B/M 07/12/99) inside a (driver's seat) a white 2024 Jeep Grand Cherokee bearing WI-Fleet Plate 22672AFT (rental). CALHOUN had sustained (1) gunshot wound to the head and was unable to communicate or describe the incident/altercation. CALHOUN had been transported to Froedtert Memorial Hospital for further medical evaluation/attention.

On scene (3465 N.60th St.) exterior video surveillance depicted the victim along with other persons interact, outside the gas station. Further investigation/statements obtained- revealed that the victim and subject(s) had an altercation regarding a previous drug deal and money owed.

Milwaukee Police Department Investigation Bureau responded and conducted a full investigation regarding.

As a result of the investigation, subjects involved in the incident had been identified and arrested with

This report is written by **Detective Dan HOVER** assigned to the Milwaukee Police Department, Criminal Investigation Bureau - Major Crimes (Robbery) Division, Early Shift, Squad 9264.

On Wednesday, 23 October 2024, at approximately 2315 hrs, I was told by SGT Ross MUELLER to respond to 3645 N 60th St regarding an armed robbery incident that had occurred there earlier.

While on scene I spoke with the Victim, Brittany C LEONARD (f/b 6-1-85). LEONARD is employed by the Milwaukee County Sheriff's office as a corrections officer. LEONARD was in her corrections officer uniform at the time of the incident, as seen on security camera footage inside the gas station. During our interview, LEONARD was wearing a black sweatshirt covering up any MCSO insignia. I initially interviewed LEONARD in the front seat of my squad car. Then I had LEONARD walk me through the incident, so as to give me the same vantage point and feelings that she was experiencing at the time.

I asked LEONARD if she was ok, and if she needed anything, LEONARD stated that she had a bit of a headache but was otherwise ok. LEONARD stated that she had a stroke about a year ago, so headaches are not that uncommon for her. I asked LEONARD about any MCSO connection to this incident, and did she think that she was targeted because of her employer. LEONARD stated that she did not believe that that was the case, and that she stated that she has been doing clerical work predominantly at the Sheriff's office which does not put her around any inmates.

I had LEONARD walk me through the events starting at approximately 10:30 PM tonight. LEONARD stated that she drove her White Chevy Equinox to the gas station to get some Excedrin. LEONARD stated that she was on her phone throughout the incident with one airpod in her ear. LEONARD walked into the gas station to see if they had any Excedrin. On her way out, walking back towards her car, LEONARD observed S1: M/B approximately 24-30 yo, 5'10"-6' slim build, with a black ski mask, and Dark top and pants, wearing slides. S1 was walking SB through the parking lot from W Keefe approaching her at a high rate of speed. LEONARD stated that she thought something was up with how fast he was walking but figured that he was trying to get to the gas station. S1 approached LEONARD and stated repeatedly "whole purse, whole purse". LEONARD stated that S1 produced a black semiautomatic handgun with a blue slide, in his right hand and pointed it at her. LEONARD stated that she was in shock and disbelief as this was occurring. LEONARD stated that she was wearing the purse across her body and was fumbling to get it off to give to S1. LEONARD stated that she was walking backwards as she was giving him the purse, and lost her footing, tripping backwards.

I asked LEONARD where exactly this occurred, and LEONARD walked me over to the spot which was approximately 10' away from the NE corner of the gas station, where she had parked her car. LEONARD stated that the fall did not cause her any pain or injury. LEONARD stated that after giving over the purse, S1 then fled WB on W Keefe on foot. LEONARD then went inside the gas station to have someone call 911.

LEONARD stated that her purse contained: her iPhone 13 in a leather case, her air pod case with one air pod inside, her chevy key fob, 2 silver capital one Credit cards, one Capital one Debit card, her Chime Debit card, her Flex Spending account card, her Navy Federal Credit Union card, and her Driver's license.

I had the responding officers provide LEONARD with a PV-17 form and a community contact card.

I asked LEONARD if there was anything else I had not asked her that I should know about, and she said "No".

LEONARD had called her boyfriend there to give her a ride home.

The business allowed officers to view video surveillance which depicts the incident as it was told from the victim.
