This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/04/23 at 4:43pm, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St, for a fight complaint. Officers spoke with employee who stated that a customer was at the drive through, asked to park, and informed a worker would give her, her drink. The customer came in the business yelling walked behind the register grabbed a cup, and then threw the drink tray behind the registers. The employee stated that no one was injured and was cooperative with the police during the investigation.
2. On 02/06/23 at 8:36pm, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St, for a subject with a gun complaint. Officers spoke with the manager who stated that a customer brandished a firearm and made a threatening remarks to an employee. The suspect was observed in a silver vehicle. The suspect stated to the employee that he would be back at 10, while displaying the hand gun. The manager provided video to the officers which showed the suspect vehicle description.
3. On 05/19/23, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St, for a subject with a gun complaint. Officers spoke with the employee who stated that a customer became upset over a mobile kiosk order. The subject appeared to be armed with a hand gun in his pocket. The subject then went behind the employee counter during the argument. The subject was removed from the business by a friend of the subject, and left in a suv. The business was

cooperative with officers but the employee did not have access to the surveillance system. The employee stated that the morning manger could access the video of the incident.

4. On 06/02/23 at 1:21am, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St, for a suspicious, other complaint. The caller stated that the business appeared to be closed but the drive through window was left opened. Officers checked observed that the business was locked and no employees were at the location. Officers checked inside the business and observed phone numbers and contacted the agent. Officers secured the business and the agent remotely armed the security system to the business.
5. On 08/27/23 at 8:42am, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St, for a trouble with subject complaint. Officer spoke to the employee and manger who stated that a drive through customer became angry while trying to a get a food order. The customer made threats to slap the manger regarding the incident. The employee feared for her safety regarding the altercation. The manger reviewed the video surveillance with the officers. The officers obtained the vehicle description from the video footage.
6. On 09/05/23 at 2:22am, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St, for a battery complaint. Officers spoke with caller, who stated that she was at the drive through window of the business, and was not being provided service. The caller explained that an unruly customer a head of her vehicle threw a drink at the drive through window prior to her receiving her food. The drink splashed inside of the window striking the employees. The employees then threw soda back but struck her and her vehicle. The unruly customer then drove away from the location, and the business refused service or communication with her. The caller told officers she either wants her food or a refund, and stated that she had nothing to do with the prior customer. Officers observed the caller's pants were wet and liquid was on her vehicle. Officers attempted to get into the business but employees refused to come to the door for the uniform officers. Officers tried knocking at different doors, as well as the drive through intercom. Officers observed two males inside visually shaking their heads no, as they move to the back of the business, out of sight. During officers time at the location there was no cooperation from within the business to resolve the incident.
7. On 09/09/23 at 1:52pm, Milwaukee Police were dispatched to 7130 N. 76<sup>th</sup> St for a battery complaint. Officers arrived at the location and observed a disturbance from 10 subjects outside the business. Most of the subjects left the without further incident. Officers spoke with the caller/employee who stated a customer became disruptive because of a delayed wait time. Officers reviewed the video of the incident and observed the customer shouting being belligerent in the lobby. The customer was cited for disorderly conduct.

On Saturday, February 4, 2023, at approximately 4:43 PM, Squad 4234 responded to a Fight complaint at the address of 7130 N 76th St, which is located in the City and County of Milwaukee. Upon arrival I spoke with Antonia M. GALMORE (b/f 12/25/02).

GALMORE stated after she took a female's order in the drive-thru of the business she asked the female driver to park, and she would have another employee deliver her drink to her. She stated the female pulled off but then shortly after entered the business stating, "I said I want my coke". She stated the female then grabbed a cup tray, walked behind the registers and threw the cup tray behind the registers. GALMORE stated the female then exited the business and she then called for police. She stated during the incident no one was injured, and no damage was done.

GALMORE and the business was cooperative with the squad's investigation, but she stated she did not have access to the video footage to provide officers.

GALMORE was issued a PV-17 and informed to advise officers of any additional information she discovered regarding this incident.

This report was submitted by PO Jason DAERING assigned to District 4, Early Shift, Squad 4281 with PO Andrew FUERTE.

On 2-6-23 at 8:36PM, PO FUERTE and I were dispatched to the location of 7130 N. 76th St., City of Milwaukee, with a report of a subject with gun. Upon arrival I did speak with a female later identified as ~~Antonia M. GALMORE (B/F 12-25-2002)~~. GALMORE stated that at approximately 8:25PM on 2-6-23, a black male subject threatened one of her employees while also brandishing a firearm. GALMORE, who was the Shift Manager for approximately 9 months at the location, stated that the suspect was a driver of a silver vehicle last observed traveling westbound on W. Good Hope Rd.

After speaking with GALMORE, I did speak with the employee who was threatened. This employee was identified as Yasmine D. BROOKS (B/F 12-19-97). BROOKS was a team member with McDonalds for approximately 2 months. BROOKS stated that while she was taking a drive-thru order, the customer she was dealing with started to get irritated at BROOKS over the way BROOKS was "disrespecting" them. The driver of the silver vehicle proceeded through the drive-thru and did speak to GALMORE, momentarily, while the suspect was receiving and paying for their food. After speaking with GALMORE over BROOKS being disrespectful, the suspect exited the drive-thru.

A short couple of minutes later, BROOKS observed the silver 4 door sedan pull back through the drive-thru. The suspect proceeded to, according to BROOKS, brandish a black firearm while making the statement of "I'll be back at 10!". BROOKS stated that this statement proceeded to cause her to fear for her safety as she was getting done at 10PM. BROOKS stated that the suspect never did point the firearm at her and only displayed it.

A review of the video surveillance did show that the suspect vehicle appeared to be an older model Kia Forte with heavy driver side damage. The vehicle did have a front registration plate; however, the video quality was not good enough to capture the individual lettering and numbering of the plate.

BROOKS was issued PV-17,

On Friday May 19th, 2023, I was dispatched to a "Subject with Gun" complaint located at 7130 N 76th ST, McDonald's, which is located in the City and County of Milwaukee.

Upon arrival I spoke with caller, later identified as Daria L. MORSE (B/F, 10-02-1961) who stated she walked in, and a customer was arguing with a young female, later identified as Antonia M. GALMORE (B/F, 12/25/2002), behind the counter and he had a firearm in his pocket. MORSE stated the male was complaining about GALMORE not knowing his order he placed on the kiosk. MORSE described the male actor as a 510, 170, with shaved sides and curly top hair, wearing a plain white tee shirt, ash jeans (whitewashed), and black shoes. MORSE also stated she believed the male actor was intoxicated. MORSE stated the male actor, during the argument went behind the counter and started threatening another employee. MORSE stated a second unknown male came into the store to remove the male, and when she said she is calling the police he left. MORSE stated she does not have access to the camera system, only the store manager, Desiree A. MCCLINTON (B/F, 03/03/1996) has access and will not be in until the morning. MORSE stated that the two unknown males got in a white 4 door SUV and left headed northbound on N 76th ST.

All parties on scene were cooperative and willing to talk with police.

Officers then entered through the open drive through window and checked all areas of the restaurant but did not locate any persons inside of the building. After searching for a phone number inside the office I was able to make contact with the owner and agent for the business, Erik S. SCHROEDER (w/m, 6-7-77). He had several numbers listed as follows: 414-915-2213, 414-210-4766 and 805-551-2327. I was able to get in touch with SCHROEDER at 414-210-4766. I informed SCHROEDER that the drive through window was open, and the restaurant was unoccupied. I also informed SCHROEDER that 1 oven was still on, but that we turned it off.

The drive through window was secured and officers exited out the rear door of the restaurant. SCHROEDER stated that he was going to arm the security system remotely after we exited.

MCCLINTON stated she told the driver "we don't have an order for you and you need to go back around. MCCLINTON stated the vehicle backed up to the pay window. MCCLINTON then stated the driver of the vehicle began arguing with her manager, Malaysia S. STEELE (B/F - 10/01/00). MCCLINTON stated the driver made threats to slap STEELE several times. MCCLINTON then stated vehicle drove around the building several times and then the driver got out. MCCLINTON stated the B/M driver began video recording as he checked each door. MCCLINTON then stated the B/M driver left and then came back to the building and parked behind the back door.

I spoke to STEELE regarding this incident. STEELE stated she was in the pay window when the B/M began yelling at her about taking his order. STEELE then stated the B/M made several threats to slap her which caused her to fear for her safety.

I reviewed video surveillance footage. The footage showed video of a possible Silver Nissan Altima, 4-dr in the McDonald's parking lot.

On Tuesday, September 5th, 2023, at 2:22am, Squad 4431 was dispatched to a "Battery" complaint at the McDonalds located near North 76th Street and West Good Hope Road. This call is related to Milwaukee Police Department CAD (Computer Aided Dispatch # 23-248-0135) and originated at 2:14am.

According to the CAD, the caller identified as Nyree, stated she was in the drive thru and a customer in front of her made the staff mad. The customer pulled away and a male worker from inside the business opened the drive thru window and threw a full soda on the caller. The caller stated that she had paid for her food and now the staff is denying her food and or money back. The caller stated she was not involved in the altercation or associated with the original unruly customer. The caller stated she would be waiting onscene in a blue in color 2004 Chevrolet Cavalier.

The only McDonalds located in this general area is located at 7130 North 76th Street. Squad 4431 responded to this location.

On arrival, officers observed a blue in color Chevrolet Cavalier with rear displayed Wisconsin registration ATT-2366 parked at the Drive-Thru window #2 along the north side of the McDonalds Restaurant. A female was standing outside of the vehicle on her cell phone and flagged officers down at which time it was confirmed that this was the original caller for this dispatched assignment. The caller, verbally identified as Nyree D Henderson b/f 02-21-1997, stated that she had called.

Regarding this incident, Henderson stated that she was in the drive thru and had ordered her food. Henderson verbally told officers the items she had ordered at this McDonalds and stated she had paid for the food using a card. Henderson was able to show me that she had purchased \$27.20 worth of food during this interaction. Henderson stated she was at the second drive through window (Window #2) awaiting her food when her order was messed up. She stated she informed the employees about the mistake and handed an employee her receipt. While in the drive thru line waiting, Henderson stated there was an issue with a male customer that had already went through the line. Henderson described this customer as "unruly" and stated it was a male in a red Cadillac and his order had been messed up she believed. Henderson stated she had no association with the "unruly male" customer. Henderson stated the male in the red Cadillac pulled off from the drive thru line but later drove back around at which time he exited his vehicle and threw a soda over her vehicle at the employee inside the McDonalds at the Drive Thru Window #2. Henderson stated the unruly male actually threw the soda over her vehicle and it entered the opened drive thru window. As Henderson sat in her vehicle at the window, she stated a male employee inside McDonalds exchanged words with the unruly customer and threw a soda back towards the male in the red Cadillac however the male employee struck her and her vehicle with the soda. I observed that Henderson's pants were wet and there appeared to be liquid on her vehicle's roof and hood.

Henderson stated since she struck with the soda by the employee, she had no communication from any of the employees inside the McDonalds nor had she received her food or money in return for the food. Henderson stated this issue could be resolved if she would have received either her money back or her ordered food and an apology; however, the employees stopped communicating with her, so she called the police.

After speaking with Henderson, officers observed that there were at least four other vehicles in the

drive thru line that were waiting on food and were also not having communication with the employees of the McDonalds.

After interviewing Henderson and learning that this matter could easily be resolved, both PO Pashkewitz and I attempted to make contact with any of the employees inside the McDonalds at this time to resolve this issue. PO Pashkewitz observed a male employee inside the business walking in her direction and she knocked on a window to gain his attention at which time the male turned around and walked into the back area of the business out of visual sight. I observed two males seated in the front of the McDonalds and knocked loudly on the glass door to gain their attention to open the door. The males shook their head no and both walked to the back of the business out of sight. Officers attempted to knock on the drive thru windows and speak with the employees via the drive thru intercom system however received no answer from the employees inside the business although officers had observed at least two male and two female employees inside the business.

It should be noted that there are listed signs posted stating that the business drive thru is open 24 hours. Squad 4431 was in full Milwaukee Police Department uniforms with badges and shoulder patches clearly visible on outermost uniform garments. Squad 4431 had arrived at the location in a fully marked City of Milwaukee police vehicle.

It should be noted that Squad 4431 was onscene from 2:35am until 3:06am. During the time onscene, there was NO cooperation with the police for a matter that could have easily been resolved. It appeared that there was a deliberate refusal to cooperate with the police during this incident. While onscene, all employees went to the back area of the restaurant out of visual sight. It also appeared that employee stopped providing service to other civilian customers.

A contact card was issued to Henderson.
