Your Class B Tavern, Public Entertainment Premises and Food Dealer Licenses Application Requesting Instrumental Musicians, Bands, Poetry Readings and Patron Contes LLC" for "Charles E. Fromage" at 5811 W VLIET St.

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines: Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

I am objecting to the new license application for the Bar called Charles E Fromage. It is located 5811 W Vliet St.

According to the paper that I have received, they are applying for a new application for a Class B Tavern, Public Entertainment Premises and Food Dealer.

I object to this application because of the noise that this establishment contributes. According to the noise ordinance/complaints, Intermittent noise (boom boxes, loud parties, live music, etc.) is measured by the Milwaukee Police Department (MPD). If they can hear noise 50 feet away from the property, they can issue a citation.

They will have concerts and other things on the top of their building, twice a week during the summer. I have been putting up with this for a couple of years now. I was living in my apartment before the bar opened. During the concerts, they have 2 large speakers that blare music. The space is not a large space at all. Speakers are not needed to hear the music whatsoever. Last year, I listened to about 2 1/2 hours of harmonica playing through those speakers. I went for a walk and could hear the harmonica 2 blocks away easily. This is a common occurrence twice a week. All different music acts, all equally as bad. It used to be that every Thursday and Sunday they would have concerts. This year Friday has been their night of choice. I have talked to other neighbors around me and in the same building as me and they can hear the music every time as well. The speakers and music is being played in the direction of the building I live in. I have no Air Conditioning in my building so during the summer months

Even if my windows are closed I can still hear the music and speakers through my walls and windows. I work extended seasonal hours during the summer and the last thing I want to do is come to a warm house where I can't have the windows open and 2 hours of their friends putting on a "concert" I have heard other neighbors scream out their windows to be quiet and shut up as well.

I have emailed them and still the concerts commence twice a week for the whole summer and also have called the police on them for a noise violation.

If they want to have music inside their facility and sell alcohol I am all for it. But I do not approve and completely object to Charles E. Fromage being any sort of "entertainment" Facility. I do not want the rooftop concerts to happen anymore. It has been a giant nuisance. If anything they do not need the speakers outside of their building for the concerts,

I could care less if they want to run a bar and have food inside their building. BUT I DO NOT WANT THESE CONCERTS ON TOP OF THEIR BUILDING. I do not approve of this being an ENTERTAINMENT venue.





The hearing before the Licenses Committee will take place on 7/22/2025 at 9:10 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


