
Now comes Rex Platke, by his attorney, David A. Bordow, who objects to the action taken by the City of Milwaukee Licenses Commission on November 20, 2006, in that the petitioner, Rex Platke, does not agree with the suspension of his Class D Bartender License for fifteen (15) days on the following basis:

1. That the prior applicant before the Licenses Commission for carrying a concealed and dangerous weapon was suspended for ten (10) days only;
2. That Rex Platke has had only one other infraction in 30 years as a Class D license holder and believes that a fifteen day suspension is arbitrary and harsh.

Wherefore, your petitioner seeks a hearing before the full City of Milwaukee Common Council, or, in the alternative, agrees to suspension of his Class "D" bartender license for a period of five (5) days commencing on January 1, 2007 at 12:01 a.m.

Mr. Platke was scheduled for twelve (12) office visits with WCS since the last court date of 10/04/2006 and kept twelve (12) of these appointments. The last date of contact was 11/13/2006.

**Intake/Orientation**

Mr. Platke was oriented to the OWI Project on 9/13/2006 and completed his intake on 9/18/2006. At that time he was referred to Impact, Inc. for an AODA assessment and a Driver Safety Plan and he was also informed of his office visit schedule.

**Drug Testing**

**Under the current protocol the defendant will no longer be drug tested.**

Breathalyzer tests were conducted at each office visit and the readings were .000.


**Treatment Status and Verification**

Mr. Platke completed the Impact assessment on 9/22/2006 and verification was obtained on 10/02/2006. He is currently in AODA treatment with Brighter Days Counseling Center. This information was verified on 11/13/2006 by Todd Zangl via phone. Mr. Zangl reported that he is attending weekly group and individual therapy sessions, is maintaining perfect attendance, and is engaged in the treatment process. Mr. Platke also attended the Victim Impact Panel on 10/25/2006.
