**CONTRACT AMENDMENT
TO THE
AGREEMENT BETWEEN
THE CITY OF MILWAUKEE AND
RUNNING REBELS COMMUNITY ORGANIZATION FOR
SUMMER JOBS PIPELINE TO PROMISE INITIATIVE**

The following amendment modifies the Running Rebels Contract with the City of Milwaukee pursuant to Common Council File Number 151082. This amendment extends length of service beyond the summer of 2016 to December 31, 2016 and increases number of individuals recruited, assessed, job trained and placed in sustainable paid employment or educational placement for the Summer Jobs Pipeline to Promise (P2P) initiative. This amendment adds Performance Objectives 8 and 9 for subsidized employment and skills based certifications. It eliminates Performance Objectives 6 and 7 which is the number of individuals served who have court-ordered restitutions and community service orders. Milestones for P2P Performance Objectives will be modified as indicated in the table below. All other terms and conditions of the contract remain the same.
