**Alley betw. W. Capitol Dr., W. Melvina St., N. 52nd St., N. 53rd St. (ST212230101)**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary.

**8th Aldermanic District**

**Alley betw. W. Burnham St., W. Rogers St., S. 19th St. S. 20th St. (ST212220111)**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary.

**9th Aldermanic District**

**N. Hastings St. – W. Acacia St. to W. Denver Av. (ST211210225)** Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8' width of tree border area), and grading.

**10th Aldermanic District**

**Alley betw. W. Galena St., W. Vliet St., N. 51st St., N. 52nd St. (ST212220117)**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary.


**14th Aldermanic District**

**Alley betw. S. Graham St., E. Homer St., S. Kinnickinnic Ave., E. Otjen St. (ST212180105)** Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary.
