I. DESCRIPTION OF PROJECT

A. Introduction

Section 66.1105(4)(d), Wisconsin Statutes, requires the “preparation and adoption... of a proposed project plan for each tax incremental district.” This Project Plan is submitted in fulfillment of this requirement and the related provisions of Section 66.1105, Wisconsin Statutes.

B. District Boundaries & Compliance with Statutory Eligibility Criteria

Tax Incremental District Number 136, City of Milwaukee, Amani Homeownership Initiative (“District” or “TID”) is comprised of 358 parcel(s) totaling approximately 1,561,398 square feet or 35.84 acres (collectively, the “Property”). The District is shown on **Map No. 1, “Boundary and Existing Land Use,”** and described more precisely in **Exhibit 1, “Boundary Description.”** The District contains only whole parcels and said parcels are contiguous as required by Sections 66.1105(2)(k)1 and 66.1105(4)(gm)1, Wisconsin Statutes.

As required by Section 66.1105(4)(gm)4.a. of the Wisconsin Statutes, not less than 50%, by area, of the real property located within the District was found to be an area “in need of rehabilitation or conservation work” as defined in Section 66.1337(2m)(a), Wisconsin Statutes. **Exhibit 2 “Property Characteristics”** illustrates how the property in the District meets this statutory criteria for tax incremental financing districts. The project proposed for the District will contain approximately 43,900 square feet of commercial space and per Section 66.1105 (5)(b), Wisconsin Statutes, it is estimated that less than 35% of the property within the District could be devoted to retail business at the end of the maximum expenditure period.

C. Project Plan Goals & Objectives

Property within the District is currently “in need of rehabilitation or conservation work” and is located in the Amani neighborhood in an area generally bounded by West Burleigh Street on the north, North 26th Street on the west, North 18th Street on the east and West Meinecke Avenue on the south. The following is a description of the planned project for the District.

The Project is being developed by a collaboration of the Emem Group, LLC (“Emem Group”), Milwaukee Habitat for Humanity Inc. (“Habitat for Humanity”), Milwaukee Community Crossroads, Inc. (“MCC”), Ezekiel Community Development Corporation (“Ezekiel”), and the Community Development Alliance, Inc. (the “Project Funder”), (collectively, “Development Collaboration”).

The Development Collaboration is proposing the new construction of 95 new affordable single-family homes. The Project consists of two components. Fifty-five (55) homes will be constructed and sold for affordable home ownership opportunities. Forty (40) single-family homes will be developed under the low-income housing tax credit program. At the end of the 15-year tax credit compliance period, the properties will be sold for home ownership (collectively, the “Project”). All of the properties are being developed on vacant City-owned lots.

The main purpose of the District is to improve affordable housing options in the Amani

neighborhood for low-income residents.

The more detailed objectives of this Project Plan are to:

1. Redevelop long vacant property and returning it to productive use.
2. Promote the coordinated development of underutilized property for appropriate residential use.
3. Support past and future investment in the neighborhood through the redevelopment of property that is currently vacant and underutilized.
4. Expand the supply of affordable housing with an emphasis on both current and future homeownership opportunities.

D. Existing Land Uses & Conditions in the District

The District is comprised of 358 parcels containing approximately 35.84 acres. The property in the District is currently assessed at \$10,804,600 and are zoned RT-4 (Two-Family Residential) and LB-2, (Local Business). The properties in in need of rehabilitation or conservation work are vacant and underutilized.

II. PLAN PROPOSALS & STATUTORY REQUIREMENTS

Section 66.1105(4)(f), Wisconsin Statutes, requires that a Project Plan for a Tax Incremental District shall include:

“... a statement listing the kind, number and location of all proposed public works or improvements within the district or, to the extent provided in subsection (2)(f)1.k. and 1.n., outside the district, an economic feasibility study, a detailed list of estimated project costs, and a description of the methods of financing all estimated project costs and the time when the related costs or monetary obligations are to be incurred. The plan shall also include a map showing existing uses and conditions of real property in the district; a map showing proposed improvements and uses in the district; proposed changes of zoning ordinances, master plan, if any, map, building codes and city ordinances; a list of estimated non-project costs; and a statement of the proposed method for the relocation of any persons to be displaced. The plan shall indicate how creation of the tax incremental district promotes the orderly development of the city.”

The plan shall also include an opinion of the City Attorney or of any attorney retained by the City advising whether such plan is complete and complies with Section 66.1105(4)(f), Wisconsin Statutes.

The following statements, maps and exhibits are provided in compliance with the statutory requirements.

A. “Statement of the Kind, Number, and Location of All Proposed Public Works or Improvements.”

Funds generated from the District will be used for the following uses and improvements as shown in **Map 2, “Proposed Uses and Improvements:”**

- Developer Grant. TID revenue will be used to provide annual grant payments to the Developer to offset actual costs incurred by the Developer for the Project. The City will make payments to the Developer equal to 100% of the incremental taxes certified and collected from property within the District, less an annual administration charge, until such time as \$3,570,000 is reimbursed to Developer by such payments plus an interest rate of up to 2.5% over a period not to exceed 25 years (the “Grant” or “Monetary Obligation”). See the Term Sheet, attached as **Exhibit 3, “Term Sheet.”**

B. “Detailed List of Estimated Project Costs.”

The costs included in this subsection and detailed in **Table A, “Estimated TID Project Costs”** which follows are, without limitation hereof because of enumeration, claimed as eligible Project Costs, as defined under Section 66.1105(2)(f), Wisconsin Statutes, and, if appropriate, in any Cooperation and Development Agreement(s) or grant agreement(s) presently or subsequently entered into by and between the City of Milwaukee, the Redevelopment Authority of the City of Milwaukee (“RACM”), and/or eligible designated developer(s) or property owner(s), provided further that such expenditures are necessitated by this Project Plan.

These cost estimates are more fully described as follows:

Capital Costs

The City shall fund an estimated \$3,570,000 in the form of TID Capital Project Costs of this Plan. These costs include the Monetary Obligation that funds the Grant to the Developer as enumerated in further detail below in **Table A, “Estimated TID Project Costs.”**

Administrative Costs

This category of Project Costs includes estimates for administrative, professional, organizational and legal costs.

Financing Costs

Financing costs include estimated gross interest expense on the Monetary Obligation to reimburse the Developer for the developer-financed Grant. Estimates of interest are based on interest rates set forth in the Economic Feasibility Analysis for the Project attached as **Exhibit 4, “Economic Feasibility Study.”** The City reserves the right to prepay the grant to the Developer, which could require issuance of general obligation or other forms of debt, as described in **Exhibit 3, “Term Sheet.”**

C. “Description of Timing and Methods of Financing.”

All expenditures are expected to be incurred during the period from 2026 through 2051.

The annual payments to the Developer will be paid pursuant to the Monetary Obligation, using incremental taxes generated annually in the District as further described in **Exhibit 3, “Term Sheet.”** The City may proceed to fund any or all Project Costs using general obligation bonds or notes, RACM revenue bonds or other forms of borrowing in amounts which can be supported using tax increment from the District.

D. “Economic Feasibility Study.”

The Economic Feasibility Study for this District prepared by the Ehlers Public Finance Advisors and titled Economic Development Analysis for proposed Tax Incremental District #136 and dated June 29, 2026 is attached to this Project Plan as **Exhibit 4, “Economic Feasibility Study.”** The study establishes the dollar value of Project Costs, which, based on certain general assumptions and a reasonable margin of safety, can be financed with the revenues projected to be generated by the proposed TID.

Based upon the anticipated tax incremental revenue to be generated by this TID, the District is financially feasible and is likely to be retired on or before the year 2051. Should incremental revenue generate in excess of those currently anticipated, they may be used to accelerate the reimbursement of the Developer-financed Grant for the Project.

E. “Map Showing Existing Uses and Conditions.”

See **Map No. 1, “Boundary and Existing Land Use;” Map No. 3, “Structure Condition,”** and **Exhibit 5, “Property Owners,”** attached to this Project Plan.

F. “Map Showing Proposed Improvements and Uses.”

See **Map No. 2, “Proposed Improvements & Uses,”** attached to this Project Plan.

G. “Proposed Change of Zoning Ordinances, Master Plan, Building Codes and City Ordinances.”

See **Map No. 4, “Existing Zoning,”** attached to this Project Plan. The proposed Project is

consistent with existing zoning, which is RT-4 (Two-Family Residential). The proposed Project is in accordance with the existing master plan, building codes, and other city ordinances. The Project should not require amendments to their provisions, but such amendments could be made if necessary without further amendment to this Project Plan.

H. “List of Estimated Non-Project Costs.”

There are no non-project costs.

I. “Proposed Method for Relocation.”

The Project Plan does not anticipate the acquisition of property by the City of Milwaukee or RACM, accordingly, no relocation activities or expenditures for relocation payments or services are provided herein. If, at a later date, it is determined that acquisition of property by condemnation and requiring relocation will be necessary, the cost and method of relocation will be included in a Redevelopment Plan and associated Relocation Plan prepared pursuant to Sections 66.1333 and 32.05, Wisconsin Statutes. The costs of such activities will be eligible for reimbursement through tax increment revenues should such revenues be generated during the statutory life of the District.

J. “Statement Indicating How District Promotes Orderly City Development.”

The Project is consistent with the *Fond du lac and North Area Plan*, one of fourteen Area Plans that make up the City of Milwaukee’s Comprehensive Plan, and with *The Housing Element* of the City of Milwaukee’s Comprehensive Plan (collectively, the “Plan”). The Plan identifies the need for affordable housing including increasing owner-occupancy rates, supporting the construction of new single-family homes, and supporting innovative home ownership models within the specific geographic area of the proposed Project with a priority on housing serving low- to moderate-income households.

The District will also result in the redevelopment of long vacant property and return it to productive use, promote the coordinated development of underutilized property for appropriate residential use, support past and future investment in the neighborhood through the redevelopment of property that is currently vacant and underutilized, and expand the supply of affordable housing with an emphasis on both current and future homeownership opportunities.

K. “Opinion of the City Attorney.”

This Term Sheet does not constitute an agreement between the Development Collaboration (as defined below), the Redevelopment Authority of the City of Milwaukee (“RACM”) and the City of Milwaukee (“City”). The terms set forth below and any other requirements necessary for a transaction of this sort shall be incorporated into a development agreement to be entered into between the Development Collaboration, RACM and the City (the “Development Agreement”). In recognition that there may be adjustments of the dates and descriptions herein as well as administrative approvals which will require the exercise of reasonable discretion on behalf of the City, the City’s Department of City Development Commissioner (the “Commissioner”) will be authorized under the Development Agreement to exercise such discretion and grant such approvals, including minor adjustments of the terms described in this Term Sheet.

Project:

The Amani Homeownership Initiative project (the “Project”) involves the new construction of 95 new affordable single-family homes in the Amani neighborhood. The Project consists of two components. Fifty-five (55) homes will be constructed and sold for affordable home ownership opportunities (the “Single-Family Component”). Forty (40) single-family homes will be developed under the low-income housing tax credit program. At the end of the 15-year tax credit compliance period, the properties will be sold for home ownership (the “LIHTC Single-Family Component”). The parcels upon which the 95 single-family homes will be constructed are collectively the “Project Sites.”

The homes will be developed on scattered site City-owned lots in an area generally bounded by West Burleigh Street on the north, North 26th Street on the west, North 18th Street on the east and West Meinecke Avenue on the south.

The Project is consistent with the *Fond du lac and North Area Plan*, one of fourteen Area Plans that make up the City of Milwaukee’s Comprehensive Plan, and with *The Housing Element* of the City of Milwaukee’s Comprehensive Plan (collectively, the “Plan”). The Plan identifies the need for affordable housing including increasing owner-occupancy rates, supporting the construction of new single-family homes, and supporting innovative home ownership models within the specific geographic area of the proposed Project with a priority on housing serving low- to moderate-income households.

Development Team:

The Project is being developed by a collaboration of the Emem Group, LLC (“Emem Group”), Milwaukee Habitat for Humanity Inc. (“Habitat for Humanity”), Milwaukee Community Crossroads, Inc. (“MCC”), Ezekiel Community Development Corporation (“Ezekiel”), and the Community Development Alliance, Inc. (the “Project Funder”), (collectively, “Development Collaboration”).

The Single-Family Component will be developed by Habitat for Humanity (50 homes), MCC (4 homes), and Ezekiel (1 home). The newly constructed homes will be sold for affordable home ownership. Habitat for Humanity has a 40-year history of working to create and preserve affordable home ownership opportunities for low-income families in Milwaukee. In addition to home building, Habitat for Humanity's work with prospective homeowners includes coaching and support and homeowners contribute 210-370 hours of sweat equity as part of their home ownership investment. MCC has multi-decade history of housing experience including YouthBuild, Neighborhood Improvement Project, and Housing Production. In addition to housing, MCC works with community on youth development, violence prevention, older adult wellness, basic needs, and overall community building. Ezekiel has over a decade of experience in construction, housing rehabilitation, homeownership, and workforce training opportunities. To date they have built/rehabbed more than 200 homes, sold more than 20 homes to first-time homebuyers, and trained more than 400 individuals in construction skilled trades.

The LIHTC Single-Family Component will be developed and owned by Amani Scattered Sites, LLC, an affiliate of Emem Group formed for the purposes of owning the project and creating the entity required for the syndication of low-income housing tax credits for the project. Emem Group was established in 2014 and is a Milwaukee-based real estate firm specializing in residential design/build and commercial real estate development services. It has managed the construction of over 100 new and remodeled homes and over 250 new multifamily apartment units, representing over \$150 million of new development.

Project Budget:

Total Project costs for the development are estimated at approximately \$30.7 million. Funding for the Single-Family Component of the Project will be sourced by Habitat for Humanity, MCC, and Ezekiel through home sales, donor contributions, local philanthropy, TIF, material donations, and volunteer construction services. Financing for the LIHTC Single Family Component of the Project will include equity investment from low-income housing tax credits, permanent loan, deferred developer fee, and TIF. Funding for both Project components is being further leveraged through the efforts of the Community Development Alliance, which has secured low interest financing from local philanthropy to support Tax Incremental District No. 136.

Development Schedule:

Development of the Single-Family Component will begin no later than December 1, 2026, with the staged completion of 55 single-family homes through December, 2030. The LIHTC Single Family Component will commence construction no later than July 31, 2027 and be completed no later than December 31, 2028.

Tax Incremental District:

The City intends to create Tax Incremental District No. 136 (“TID No. 136”) to assist in funding a portion of the costs of the Project as set forth in the Project Plan.

TID Funding & the Conditional Monetary Obligation:

RACM will provide the Project Funder with a grant plus interest as described below, funded by a limited and conditional monetary obligation of the City (the “Monetary Obligation”), in an amount not to exceed \$3,570,000 for the Project (the “Grant”) if such grant is earned by the Project Funder by substantially completing the Project as promised and within the timelines described in the Development Agreement. The Project Funder shall advance up to \$3,570,000 (subject to review of the final Project budget) of costs related to the Project and shall be reimbursed for these costs by the Grant. Because the Grant will be paid on a reimbursement basis, Project Funder will also receive interest at a rate of 2.5%¹ in addition to the grant.

After creation of TID No. 136 and determination of the base value of TID No. 136, the City will deposit 100% of future tax revenue based on the incremental value of the property within the TID actually received by City from TID No. 136, less Annual Expenses², into a special fund established for TID No. 136 (the “Incremental Revenue”). Upon Substantial Completion (as defined below) of the Project and the earning of the Grant, the Incremental Revenue will fund annual payments, plus interest, of the grant to Project Funder and will result in a reduction of the principal balance of the Monetary Obligation. Annual grant payments will be made to Project Funder on or before March 1st of each year, provided the Project Funder has paid, or has caused

¹ The interest rate on the Grant reflects the preliminary interest rate on the Project Funder’s underlying financing and is subject to change, based on the final closing date on the financing for the Project. In no event, shall the interest rate on the Grant exceed 2.6%. If the final interest rate exceeds 2.5% the amount of the Monetary Obligation will decrease accordingly.

² “Annual Expenses” is defined as an amount not to exceed \$7,500 per year used to pay the customary and reasonable costs incurred by City for audit and accounting functions and other ongoing administrative expenses for TID No. 136.

Habitat for Humanity, MCC, Ezekiel, and Amani Scattered Sites, LLC, as applicable, to pay its property tax bill in full prior to January 31st each year and there is sufficient Incremental Revenue to fund the Grant payment.

The Monetary Obligation is a limited and conditional obligation of the City in that it is subject to annual appropriation by the City's Common Council, is conditioned upon there being enough Incremental Revenue to fund the Grant, and is conditioned upon the Project Funder actually earning the Grant. If not appropriated, the City shall not expend Incremental Revenue for any other TID No. 136 project costs. Tax revenue shall not be pledged to the payment of the Grant and the Monetary Obligation shall not constitute a general obligation of the City or count against its statutory debt limits. Annual payments on the Grant will terminate and be considered paid in full: (i) at the time the Grant and interest is fully paid; or (ii) with the payment derived from the 2050 tax levy, payable in 2051, whichever occurs first.

The Project Funder shall have the right to assign all or a portion of the Grant and interest to sources of financing or refinancing on terms and conditions mutually agreeable between Project Funder and the proposed assignee(s). The City shall have a reasonable opportunity to review the applicable assignment documentation and approve any documentation to which it is a signatory.

Design/Consistency with Approved Plans:

Design of the Project and all final plans and specifications for the Project shall be subject to the review and approval of the Commissioner.

Substantial Completion of the Project:

Upon substantial completion of the Project, Project Funder shall submit a certification detailing Project costs theretofore incurred (together with copies of records, invoices, accountant's final cost certification and/or AIA documentation, in a form reasonably acceptable to the Commissioner) evidencing such expenditures. The Grant shall be deemed earned upon approval of such certification by the Commissioner and by Project Funder obtaining an occupancy permit for the Project (collectively, "Substantial Completion"). Substantial completion is further defined as follows:

- For the Single-Family Component substantial completion means the completion and receipt of Final Occupancy Permits for the following number of cumulative homes by the following dates:

<i>Phase #</i>	<i>Substantial Completion by:</i>	<i>Cumulative Total Number of Homes</i>
Phase 1	December 31, 2027	18 homes
Phase 2	December 31, 2028	27 homes
Phase 3	December 31, 2029	36 homes

- For the LIHTC Single-Family Component substantial completion means the completion and receipt of Final Occupancy Permits for the 40 single-family homes.

Cost Savings:

If, at Substantial Completion, total actual hard costs of the LIHTC Single Family Component of the Project are less than the Preliminary Project Budget, the amount of the Grant shall be reduced by 50% of such cost savings. As used herein “cost savings” shall be the net savings to the Project, such that if the cost savings are in a budget line item eligible for generating LIHTC equity, then the cost savings shall be the net amount after the reduction to LIHTC equity is calculated. For example, if there are \$10,000 of hard cost savings that result in a loss of \$4,000 of LIHTC equity, the cost savings would be \$6,000. Developer shall provide the Commissioner with a written statement of any such cost savings, which shall include a copy of IRS Form 8069 and that certain cost certification prepared by an independent certified accountant to be submitted to the Wisconsin Housing and Economic Development Authority in connection with the Project.

Material Disturbance:

If the Project is not substantially completed by June 30, 2031, unless caused in substantial part by an event of *Force Majeure*³ (a “Material Disturbance”), then City shall have the right (but not the obligation) to reduce the Monetary Obligation to an amount equal to the number of Project homes completed multiplied by \$45,000, using the following procedure:

- (1) City shall give Development Collaboration notice of its intention to terminate further payments on the Monetary Obligation, and Development Collaboration shall have 180 days to cure the Material Disturbance (unless such cure cannot reasonably be completed within such 180-day period, in which event such cure period shall be extended as reasonably necessary for Development Collaboration to pursue the cure to completion, so long as Development Collaboration diligently undertakes such cure and such cure period, as extended, does not exceed 365 days).
- (2) Thereafter, if Development Collaboration has not eliminated the Material Disturbance within the timeframes set forth in subsection (1) above, and if the City still intends to terminate payments on the Monetary Obligation, City’s Common Council may adopt a resolution determining that the Material Disturbance prevents the substantial realization of the public benefits contemplated as a result of the Project and constitutes just cause for the termination of the Monetary Obligation. In such event, City may thereafter file a certificate with Development Collaboration (attaching the resolution of the Common Council) stating that City has elected to terminate payments on the Monetary Obligation. Upon City’s filing of such certificate, the Monetary Obligation would terminate.

Development Collaboration Responsibilities:

The Development Collaboration (and/or applicable Development Partners) shall have the following responsibilities:

³ “Force Majeure” means delays caused by adverse weather, acts of God, labor disputes, strikes, material shortages, terrorism, civil unrest, war, fire, pandemic or epidemic, global health crisis, other casualty, riot, concealed and unknown site conditions and other causes outside of the control of the party obligated to perform, in which case, performance of such act shall be excused for the period of such delay, and the time for the performance of any such act shall be extended for a period equivalent to such delay.

- Design and develop the Project consistent with the approved plans and the Development Agreement.
- Submit to the Commissioner a final development budget for the Project, financing commitments, final bids, a construction contract, and proof that all funding sources have been committed (prior to closing on the funding).
- Obtain title to the property to be developed as part of the Project, if not already owned.
- Guarantee completion of construction of the Project.
- Enter into agreements with the City as described and required herein.
- Maintain the LIHTC Single-Family Construction Component as residential housing consistent with the requirements found in **Attachment 1 of this Term Sheet** for a period of 15 years from the date of initial occupancy or until termination of TID No. 136, whichever is longer, and comply with the monitoring requirements established as part of the Project financing provided by WHEDA.

Human Resources:

The Development Collaboration (and/or the applicable Development Partners) and City will enter into Human Resources Agreements based on the proportionate share of the Monetary Obligation allocated to each partner.

- Habitat for Humanity's non-profit status, the affordable homeownership focus of the development, and the volunteer model, the Habitat for Humanity Human Resource Agreement will provide for best efforts utilization of certified Small Business Enterprise ("SBE") for 25% of Project construction costs, 25% for purchase of goods and services, and 18% of amounts expended for the purchase of professional services deemed eligible pursuant to SBE Guidelines and provide for best efforts utilization of unemployed and underemployed residents for no less than 40% of the total worker hours expended on construction of the Project.
- MCC's Component Human Resource Agreement will provide for best efforts utilization of certified Small Business Enterprise for 25% of Project construction costs, 25% for purchase of goods and services, and 18% of amounts expended for the purchase of professional services deemed eligible pursuant to SBE Guidelines and provide for best efforts utilization of unemployed and underemployed residents for no less than 40% of the total worker hours expended on construction of the Project.
- Ezekiel's Component Human Resource Agreement will provide for best efforts utilization of certified Small Business Enterprise for 25% of Project construction costs, 25% for purchase of goods and services, and 18% of amounts expended for the purchase of professional services deemed eligible pursuant to SBE Guidelines and provide for best efforts utilization of unemployed and underemployed residents for no less than 40% of the total worker hours expended on construction of the Project.
- The LIHTC Single-Family Component being developed by Emem Group will provide for utilization of certified SBE for 25% of Project construction costs, 25% for purchase of goods and services, and 18% of amounts expended for the purchase of professional services deemed eligible pursuant to SBE Guidelines; utilization of unemployed and

underemployed residents for no less than 40% of the total “worker hours” expended on “construction” of the Project; compliance with applicable state and municipal labor standards; utilization of apprentices and/or on-the-job trainees; and participation in City’s First-Source Employment Program.

No Tax Exemption:

No portion of the Project shall at any time be exempt from real estate taxes and Habitat for Humanity, MCC, Ezekiel, and Amani Scattered Sites, LLC, as applicable, shall enter into a Payment in Lieu of Taxes Agreement with the City (“PILOT Agreement”).

Development Agreement:

The Development Collaboration (and/or the applicable Development Partners), RACM and City shall enter into the Development Agreement, which shall contain terms consistent with this Term Sheet (unless otherwise agreed to by the parties) and customary for such development agreements in the City.

Limits on Project Development Collaboration Action:

Until all obligations under the Development Agreement have been fully discharged, Project Funder, Habitat for Humanity, MCC, Ezekiel, and the Emem Group, without City consent, which shall not be unreasonably withheld, conditioned or delayed:

- Merge with another entity;
- Sell, lease or transfer the Project Sites other than residential sales or leases as contemplated by the Project and other easements or other real estate interests that may be necessary or appropriate to operate the Project;
- Enter into any transaction that would materially adversely affect the ability of the Development Collaboration to complete the Project or fulfill its obligations under the Development Agreement;
- Assume or guarantee the obligations of any other person or entity that would materially adversely affect the ability of Development Collaboration to complete the Project or fulfill its obligations under the Development Agreement; or
- Enter in a transaction that would cause a material and detrimental change to the Development Collaboration’s financial condition.

Economic Feasibility Study

Overview

The Amani Homeownership Initiative (the “Project”) is a targeted and coordinated effort to promote homeownership in the Amani neighborhood. The Project consists of two components involving the construction of single-family homes for both affordable rental and homeownership opportunities. Forty (40) single family homes will be developed under the low income housing tax credit program. The forty properties will be constructed as 3-bedroom homes with rents affordable to households with incomes less than 50% of Area Median Income. At the end of the 15-year tax credit compliance period, the forty homes will be sold for homeownership. In addition, fifty-five (55) single family homes will be constructed and sold for affordable homeownership opportunities. In total, 95 single family homes will be built.

The Project is being developed by a collaboration of the Emem Group, LLC (“Emem Group”), Milwaukee Habitat for Humanity Inc. (“Habitat for Humanity”), Milwaukee Community Crossroads, Inc. (“MCC”), Ezekiel Community Development Corporation (“Ezekiel”), and the Community Development Alliance, Inc. (the “Project Funder”), (collectively, “Development Collaboration”).

Financing Structure

In addition to the proposed TID contribution of \$3,570,000, each component of the project will have its own distinct funding sources.

Total estimated costs for the Project are approximately \$30.7 million. Funding for the Single-Family Component of the Project will be sourced by Habitat for Humanity, MCC, and Ezekiel through home sales, donor contributions, local philanthropy, TIF, material donations, and volunteer construction services. Financing for the LIHTC Single Family Component of the Project will include equity investment from low-income housing tax credits, permanent loan, deferred developer fee, and TIF.

Funding for both Project components is being further leveraged through the efforts of the Community Development Alliance, which has secured low interest financing from local philanthropy to support Tax Incremental District No. 136.

Current Property Value

The property in the district consists of 358 parcels with a total assessed value of \$10,804,600 which is the current base value of the District.

Projected Completed Value

The projected value of the Project upon completion is \$11,793,222.

The estimated assessed value of the 55 “Single-Family Component” homes element of the Project is \$6,990,000. Of the 55 homes, four (4) have an estimated per property assessment of

\$100,000, four (4) have an estimated per property assessment of \$120,000, and the remaining 47 have an estimated per property assessment of \$130,000, all of which are the target sales price for the 55 homes.

The estimated assessed value of the 40 “LIHTC Single-Family Component” homes element of the Project is \$4,803,222. For the first 15-years during the LIHTC compliance period, the 40 homes have an estimated per property assessment of \$55,581 based on 50% AMI rent caps. After the compliance period ends and the homes are sold for homeownership, the 40 homes will increase to an estimated per property assessment of \$120,081, which is the target sales price for the 40 homes.

Other Assumptions

- Tax Rate: 2.2385%
- Interest Rate on Payments to Developer: 2.5%.
- Maximum Term of Payments: 25 years
- Annual Appreciation: 1.01% for homes developed under the Project. In regard to the existing residential properties within the District boundaries, the appreciation rate is 0%.

District Cash Flow and Amortization of the Monetary Obligation

In a “pay-as-you-go” District, the Developer is accepting the risk that the District will generate sufficient incremental value to recapture the \$3,570,000 of costs, plus 2.5% interest, through future incremental revenue.

As shown in the projections in Table 1, forecasted tax incremental revenues are sufficient for the Developer to recover the proposed TID amount of \$3,570,000 plus interest in tax levy year 2050 (budget year 2051).

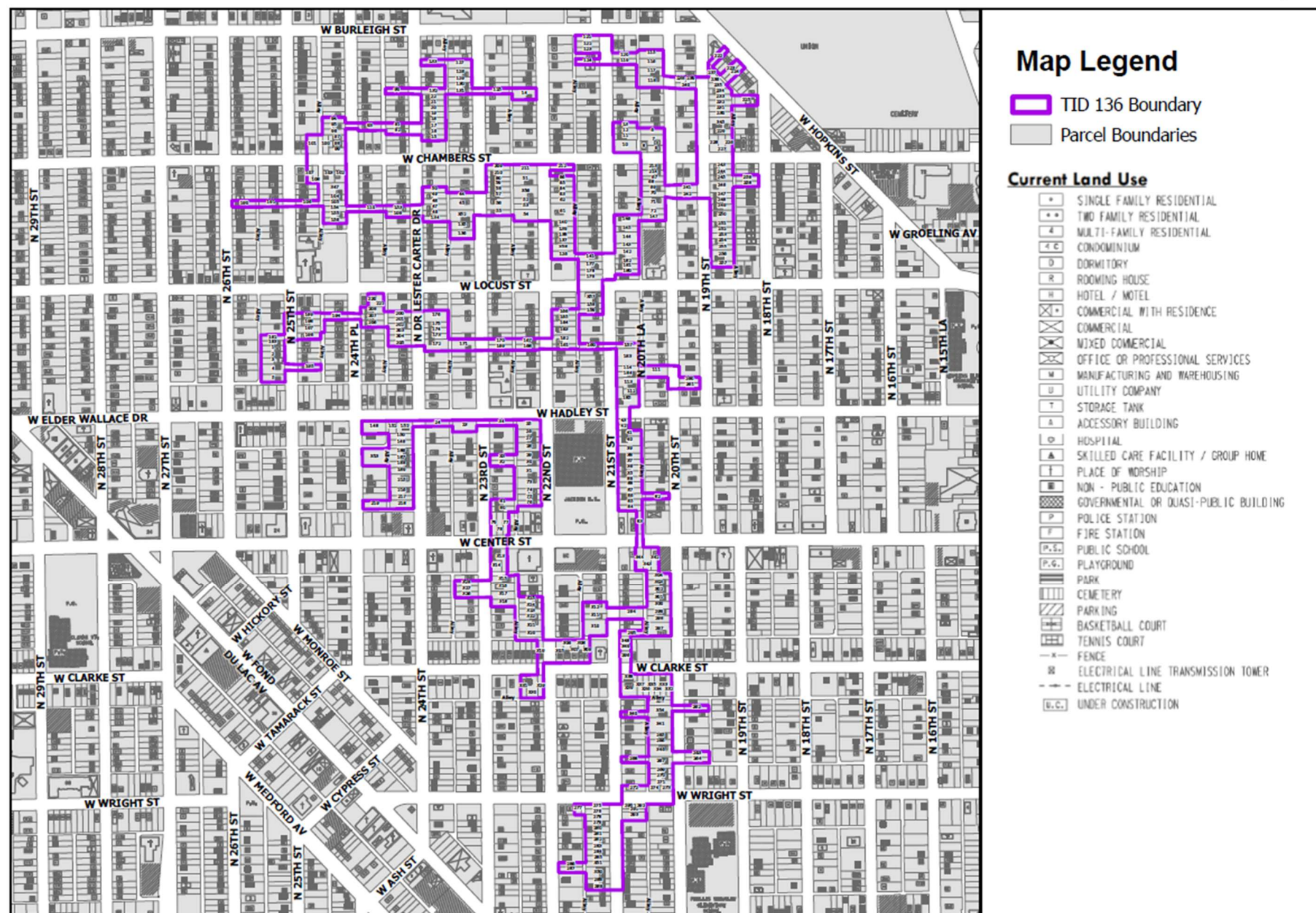

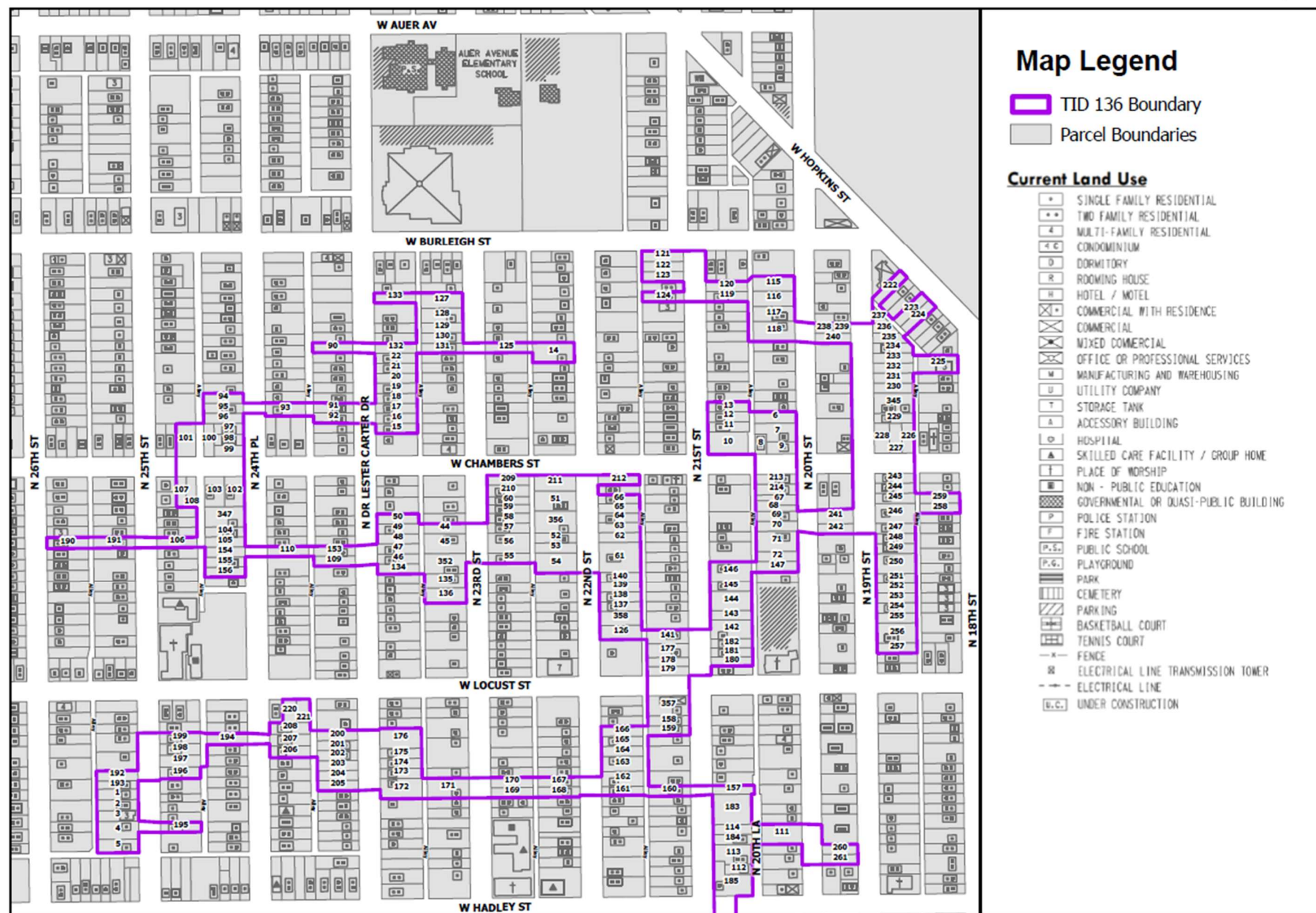


TID 136: Amani Homeownership Initiative, Map 1a

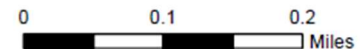

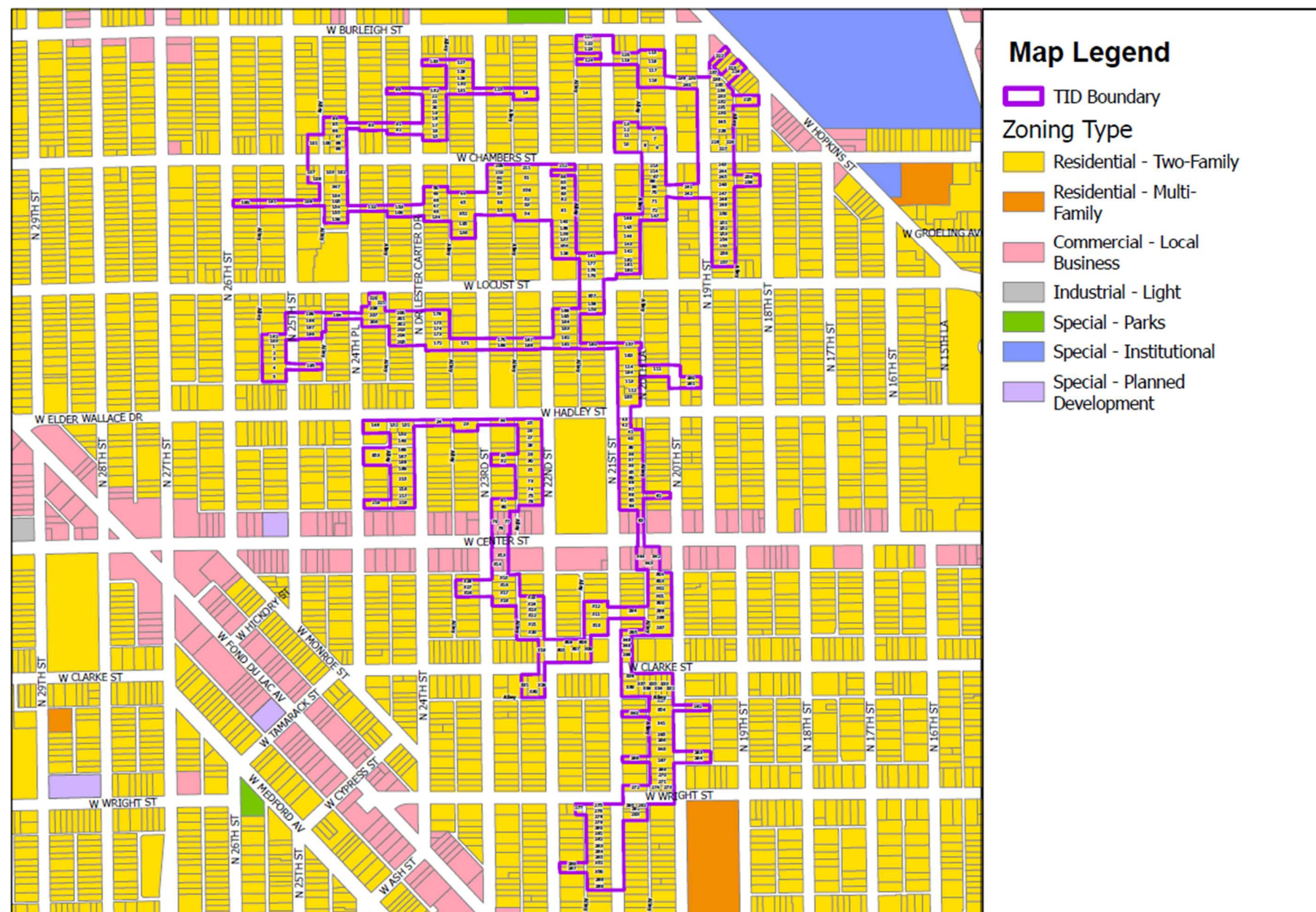


TID 136: Amani Homeownership Initiative, Map 4
