DEAR PERSON OF INTEREST:

The Common Council has referred File No. 230880 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Two-Family Residential, RT4, to a Detailed Planned Development to allow multi-family residential development at 2953-2979 North 8th Street, located on the south side of West Chambers Street, west of North 8th Street, in the 6th Aldermanic District.

This zoning change was requested by Cinnaire Solutions and Cupid Development, LLC and will allow multifamily residential development on the subject site, which is owned by St. Matthew C.M.E. Church and occasionally used as parking for church-related events. The proposal includes a 5-story, 40-unit residential building for seniors and 5, 2-story townhouse buildings that will have 2 units each for a total of 10 units. The townhouses are anticipated to be for families. Parking for the residents will be provided within the 5story building and in a surface lot on the site. **Please refer to the reverse side of this notice for map details.**
