Assumes \$60,000,000, 10 year level principal debt is issued at 4.50% before July 1. Actual amount issued may be more or less, depending upon the pace of projects. Actual debt may be amortized over a shorter or longer period depending upon useful life of the projects being financed.
Actual interest rates will depend upon market conditions at the time of issuance.
How ever, Notes issued pursuant to this resolution would be in lieu of bonds/notes that would be issued by other means.
