**Alley between N. Bartlett Ave., E. Hartford Ave., N. Newhall St., and  
E. Newport Ave. (ST212050144):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

---Hold one cycle, by Ald. Dudzik. Prevailed. (Ald. Wade excused)

**Alley between N. Booth St., E. Chambers St., E. Locust St., and N. Pierce St.  
(ST21210103):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

**N. 42nd St. – W. Burleigh St. to W. Townsend St. (ST211050117):**

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

**8th Aldermanic District**

**Alley between S. Layton Bl., W. Maple St., W. Mitchell St., and S. 26th St. (ST212050127):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

**Alley between W. Appleton Ave., W. Keefe Ave., W. Vienna Ave., and Dineen Park (Northerly Half) (ST212050135):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

**Alley between N. Hi Mount Bl., W. Lloyd St., W. Vine St., and N. 49th St. (ST212050145):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

### 11th Aldermanic District

**S. 71st St. – W. Wilbur Ct. to S. Sunset Dr. (ST211020151):**

Asphalt pavement resurfacing, replace sidewalk and driveway approaches where needed, and sodding.

---Hold one cycle, by Ald. Dudzik. Prevailed.

**S. 85th St. – 680 feet m/l north of W. Ohio Ave. to 730 feet m/l north of W. Ohio Ave. (ST210050102):**

Asphaltic concrete stage construction, install new curb and gutter, new walk and driveway approaches where needed and grading and sodding where necessary.

### 13th Aldermanic District

**W. Wanda Ave. – S. 14th St. to S. 15th Pl. (ST211050134):**

Asphalt pavement resurfacing, replace all curb and gutter and driveway approaches, replace sidewalk where needed and sodding.

### 14th Aldermanic District

**E. Bennett St. – S. Ellen St. to a point west of S. Ellen St. (ST211050114):**

Asphalt pavement resurfacing, narrow the roadway from 36 feet to 32 feet, replace all curb and gutter, sidewalk and driveway approaches, sodding, and tree removal where necessary.

---Hold one cycle by Ald. Wade. Prevailed.

**Alley between E. Euclid Ave., S. Griffin Ave., S. Howell Ave., E. Ohio Ave., and S. Whitnall Ave. (ST21200128):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

---Delete by Ald. Dudzik. Prevailed.

### 15th Aldermanic District

**Alley between W. Garfield Ave., N. Hi Mount Bl., W. Lloyd St., and N. 49th St. (ST212050146):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

---Hold one cycle, by Ald. Wade. Prevailed.

**Alley between W. Meinecke Ave., W. North Ave., N. 35th St., and N. 36th St. (East-West Leg and Portion of North-South Leg) (ST212050141):**

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where needed.

---Approve with late billing, by Ald. Witkowski. Prevailed.
