RE: Claim for \$49.67 in damage to car's headlight from car being chased by police at high speed downtown at midday.

Dear Mr. Owczarski:

This is to make a claim for reimbursement from the City of Milwaukee for \$49.67 in damage caused to the right headlight of my car, a 2002 Dodge Grand Voyager, when my car was struck by a vehicle being chased at high speed downtown by the police on November 30, 2023 about 1:30 P.M.

A copy of the police Accident Report # J9L1VJ8VNH is enclosed, as well as my E-Bay receipt for a new headlight. I wrote to the police captain Thiel in District 1 on January 9, but he referred me to you.

Fortunately, I was not injured and the only damage to my car was the headlight, which cost me \$49.67 to replace. I hereby ask the City of Milwaukee to reimburse me the \$49.67 because a high speed police chase downtown at midday is extremely negligent.

I have not made the claim before this because I had to order the headlight online, had to go to two garages to determine if there were other damages and what it would cost, and had to wait for my son to install the headlight when he was here for Christmas. I am not billing you for my time, inconvenience, or copying and postage costs,

Here is the way the accident happened. I was proceeding west on Mason Street. I had a green light and was in the middle of making a left turn onto Water Street to proceed south on Water. Suddenly, a car proceeding north on Water in the center lane (or perhaps even in the lane for traffic going in the other direction) came speeding toward me. I jammed on my brakes expecting that car to continue going through its red light and speeding north. Instead, the car turned right from the center lane (or opposing traffic lane) of Water Street to proceed east on Mason. At first, I thought it was going to collide with me head on, but then it swerved a little to its right and only clipped my headlight. It sounded like much greater damage. So maybe that car's fender got damaged. As soon as it had hit me, I heard

police sirens, and so I stayed stopped where I was. Two police cars with their sirens sounding came along going north on Water. I tried to signal them from my window that the car had turned onto Mason. The police turned right on Mason going east to follow the car they were chasing. After the police passed me, I completed my turn and pulled over to the west side of Water Street facing south, to inspect the damage on my car. A woman named Julie Leach came over to me and offered to be a witness. Her phone number is 414-614-7566. I gave this information to the police. The car that hit me was a small car in a strange green color. I would call it seafoam green. The witness told me she thought it had a white roof. I understand from Officer Orlando, who took my report, that the police did apprehend the driver a few blocks after the car hit me.

I did not call the police until I got home because I am not that familiar with how to use my mobile phone, since I rarely use it. Thus, I did not know how to look up the police number. When I got home, I called the police department and explained the situation. They sent Officer Orlando to my house that night to take the report and to look at my car and take pictures.

At first I thought the damage was more extensive. There were marks on the fender that looked like scratches. However, when I took it to a garage for an estimate, the man took a rag with paint remover, rubbed those, and they all came off. There is a small dent, but I am not going to have that fixed. Thus, the only thing that had to be replaced was the headlight. I found a matching headlight online, and my son was able to install it when he was here at the end of December. It would have cost about \$200 to have a garage install it, if he could not have done it. Thus, we are lucky the damages were so little. The cost of the headlight is not covered by my insurance because my collision deductible is too high and uninsured motorist insurance does not cover property damage on my car.

I feel the City of Milwaukee should reimburse me the \$49.67 for the headlight because it is inherently dangerous and negligent for the police to conduct high speed police chases downtown, especially at midday. Thus, I feel that the city is responsible for this damage to my car, even though the police are not the ones who hit my car. It is a blessing that no one was hurt and the damage was not more extensive.

Thank you for your attention to this matter.
