Dear Mr. Brazeau:

We are in receipt of your claim regarding damages sustained to your vehicle on February 15, 2023, when you struck a pothole at or near N. 51st Street and W. Hampton Avenue.

Based on 2011 Wisconsin Act 132, Wisconsin municipalities are immune from liability for any damage that occurs on or after April 5, 2012 due to a defect in a sidewalk or street.

Our investigation revealed that the Infrastructure Services Division conducted a search of call center records for the 5100 block of W. Hampton Avenue from December 15, 2022 through February 15, 2023, and received one call on February 15, 2023, and repairs were completed on February 21, 2023.

The Infrastructure Services Division did not have knowledge of a hazard in the roadway on this segment prior to February 15, 2023. Accordingly, we cannot accept liability for your damages, and we are denying your claim.



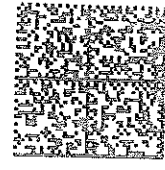
