There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/16/25 at 9:52a.m., Milwaukee Police were dispatched to a Trouble with Subject. The caller was no longer on scene; however, the clerk stated the caller was causing a disturbance and stated they were calling the police. The clerk told the caller, they were going to call the police, at which time the caller left after pounding on the windows.
2. On 07/13/25 at 7:08p.m., Milwaukee Police were dispatched to a Theft. The business called regarding a subject taking \$22 worth of items without paying. The subject was no longer on scene and the clerk did not have access to video.
3. On 09/21/25 at 3:00p.m., Milwaukee Police were dispatched to a Robbery. The business called stating a subject that had caused problems in the past, was told to leave, however, remained in front of the store. The clerk stated they exited the store to tell the subject to move along, at which time the subject punched the clerk in the ear and told their friends to grab merchandise. The clerk stated they did not have access to video. Follow was conducted later in an attempt to retrieve video, at which time the clerk stated they did not want to press charges.

On Monday , June 16,2025 at approximately 0952 hours, I was dispatched to 4225 W North Av in the city and county of Milwaukee, BC SUPERMARKET for a trouble with subject complaint .

Upon our arrival I observed nothing to be out of order. The caller was a "KEISHA" (414) 732-3114 who called stating "CALLER WANTS OFFICERS.. HAS A BAG WITH HER.. PUT HER HAIR IN HER BAGS.. SHE WANTS OFFICER EMPLOYEE ACCUSING HER OF TAKING GUMMYS// CALLER ARGUING WITH EMPLOYEE NOT ANSWERING QUESTIONS.. REFUSED PHONE SAID NOT SAYING IT WITH PEOPLE IN THE STORE AND HUNG UP// CALLER WANTS OFFICERS TO FILE HARASSMENT CHARGES..

P.O. WILSON spoke to the store clerk Gurmail SINGH (A/M 09-05-95) who was not the caller but stated an unknown patron came into the store and was causing a disturbance that threatened to call the police on him, at which point he stated that he would also call the police. SINGH stated the subject left and was banging on the window heading westbound on W North Av from the store.

SINGH did not request police as the situation resolved itself. Officers did not observe any license premise violations and did not need to see the security cameras which appeared to be working as officers observed the monitor.

It is unknown if the business is in billing status. Officers were unable to locate other license premise reports and cannot recall if they have ever been called to this location for a problem.

On Sunday, July 13, 2025, at approximately 7:08 PM, PO James BORNEMAN and I, Squad 3241, were dispatched to a Theft at 4225 W North Av (BC MARKET), which is located in the city and county of Milwaukee, Wisconsin.

Upon my arrival I observed BC Market which is a convenience/grocery store located in the center of the 4200 block of W North Av.

I spoke to the caller/victim, Gurmail SINGH (W/M, 09/05/1995), who stated a B/M came into the the BC MARKET located at 4225 W North Av, at approximately 6:20 PM on July 13, 2025, and stole two cans of "Salty Cat" cat food, and one bag of cat litter. SINGH estimated the total cost of the items to be approximately \$22. SINGH stated that he did not have access to the cameras. SINGH is employed at BC MARKET.

While on scene, I observed the licenses posted and they were up to date. During my investigation for Theft I did not observe any violations in the licensed premise.

I provided SINGH a PV-17 victim pamphlet and a Community Contact card, I advised SINGH to contact me if he was able to pull footage of the incident.

On September 21, 2025 Squad 3540, PO SHLAX and I, were dispatched to a robbery complaint at 4225 W North Ave (BC SUPERMARKET) which is located in the City and County of Milwaukee, State of Wisconsin.

Upon arrival we spoke to the victim, Gurmail SINGH (w/m, 09/05/1995) who stated that multiple subjects entered the supermarket. SINGH stated he recognized one of the subjects as Mikahel Morgan 02/13/09, because that subject punched him approximately 1 week prior, however, he did not want to press charges at that time.

SINGH stated that once he recognized the male he told the male to leave the store and that he could not be in there. The male exited the store and waited on the sidewalk however when SINGH exited the store to tell the male to move along from in front of the door the male subject punched SINGH in the right ear causing pain. While the subject committed the battery he yelled to his friends to grab merchandise from the store which those subjects did.

SINGH stated that the subjects grabbed approximately \$20.00 worth of assorted chips and slim jims.

SINGH did not have access to the video while we were there investigating and requested that we come back to retrieve on another day.

PO SCHLAX photographed SINGH's injury. I did observe SINGH's ear to be discolored red and irritated.

We reviewed body cam footage from the previous incident where PO TOLEDO and WARD spoke to the alleged battery suspect. The male identified himself as "Mikahel MORGAN (b/m, 02/13/2009)". It should be noted that "MORGAN" fumbled through his name and spelling so it is unaware if the subject used the correct name or not. An investigative alert was issued regarding.

PO SCHLAX conducted follow up on Tuesday September 23, 2025 in an attempt to retrieve video footage. When PO SCHLAX spoke to SINGH it was determined that he did not wish to press charges and refused to show video surveillance of the incident.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
