On Wednesday, June 7, 2023 the Granville Advisory Committee met to discuss your license application for Class B Tavern, Public Entertainment Premises and Food Dealer License Applications Requesting Instrumental Musicians, Disc Jockey, Jukebox, Bands, Karaoke, Poetry Readings, Comedy Acts and Patrons Dancing for "UPSCALE GALLERIA" at 6800 W Brown Deer Rd. Based on the information provided, the Granville Advisory Committee recommended to support your license applications based on your testimony and business operations plan of providing an upscale 5-star dining service with a full menu, culinary and bartending training, catering to a soft mature clientele, operating 7 days a week from 6 a.m. to 12 a.m. with the kitchen closed at 10 p.m., age restriction of 30 years and older after 6 p.m. on Fridays and Saturdays, and prohibiting hookah and smoking indoors except the outdoor patio.


