We have received your claim in the amount of \$1,025.78, relating to damage sustained to your vehicle on August 14, 2004 that you allege was caused by a City of Milwaukee Police officer at 2<sup>nd</sup> and Michigan.

Our investigation reveals that no report of damage was filed with the police department at the time. In addition, the police officers involved have no knowledge of this alleged incident. There is no evidence that the alleged damage was caused by the negligence of any City employee. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
