Friday July 19, 2019 I arrived in Milwaukee at 3:20 p.m. by train from Chicago. The train was an hour late.

I took a Yellow Taxi Cab number 585 from the Train Station to the Pfister Hotel. The cab driver did not use the meter.

Arriving at the Pfister Hotel the driver said the fare was Ten Dollars (\$10.00) I stated on Thursday that I took a cab from the Pfister Hotel to the Train Station and the fare was \$6.75 and that I gave the cab driver \$10.00 for the fare and tip.

I informed cab driver number 585 of this and asked why I was being charged ten dollars. The driver stated that he had been waiting almost two hours at the train station and their fare was a ten dollar charge.

I stated that the train being late was not my fault and why was he rate gauging me? The driver got very angry with me questioning his rate. The driver stated "Pay me what you want and get out of my cab."

I paid the driver with tip \$9.00.

In closing this black man driver is a nasty, insulting driver!

The "Yellow Cab Co." of Milwaukee (414-272-7544) said that they do not have a Yellow Cab Number 585 and that #585 must belong to the "Yellow Cab of Milwaukee" 4147-578-7500 since Milwaukee has two yellow cab companies.

In closing, I hope that the city cracks down on the rate gauging cab drivers before they ruin the tourist business and give the City of Milwaukee a bad reputation.

I cannot believe that there have not been any other complaints on cab driver #585.

Dear Sir/Madam,

I was told that this email address is for making a complaint about Taxi services I received in City of Milwaukee. I would like to make a complaint on the yellow-colored cab with number 585 on the side and back. I have seen this cab parking in front of the Milwaukee Intermodal Station many times. Last year on 10/31/2018, in the morning around 7:35 am, I got off the Amtrak train and took this cab to where I work at 875 E Wisconsin Ave. I normally pay \$7 including \$1-\$1.5 tip when I take the cab to this address from Intermodal Station. That day was the first time I got into this 585 cab and the driver immediately said he required \$10 minimum. I felt very confused and tried to point out to him that there should be no minimum cap on a cab ride like this, neither I had this type of encounter in my 3.5 yrs commute with any other cab drivers on this route. He insisted that I should pay \$10 and I said the maximum I would like to pay would be \$8. He agreed orally but since I paid by card instead of cash, once I got off the car I received this email receipt saying I was still charged \$10 regardless and on top of the \$8 I agreed to pay, he added \$2 as tip himself. The details of the receipt are shown below for your reference.

I was furious about this driver's behavior and I was very frustrated that then in the next few weeks/months, I continuously spotted him still waiting in line and sometimes the first of line in front of the Intermodal Station. Every time since then when I see his cab number I avoid getting on his car, even though normally you have to go to the first in line. I told several other cab drivers about my experience and they were all accusing him. They said this person had been rejected to a number of places in town and his reputation is bad among the drivers as well. They also agreed with me that such a bad customer service experience could definitely do harm to the image of Milwaukee cab drivers as a whole. Hence I was motivated to write this complaint to you and with the receipt information and the cab number, I believe it is not hard for you to locate him. He is a Caucasian guy in late 40's/early 50's with dark but very short hair. I would suggest such behavior of ripping off customers and giving bad customer service should not be tolerated.
