Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Hope all is well. I'm contacting you again regarding The Loaded Slate on 3rd St. Apparently they were granted a permit to set up a large tent in the lot next to their establishment and play outdoor music for an event. The issue is that they played extremely loud music last evening that could be heard inside of our condos on the other side of the river a block and a half away. As the evening progressed, the music and bass got louder so at 11:00pm, I called the MPD and reported a noise-nuisance complaint. I received a call back at 12:10am from an MPD officer who told me that The Loaded Slate had a permit that allowed them to play outdoor music until 11:30pm on Thurs, Fri, and Sat of this week.

I'm disappointed that The Loaded Slate was granted a permit after violating the terms of their last permit in the email chain below. I'm also disappointed that area residents were not notified of this

event and permit, and weren't engaged in the approval process. And a permit to play outdoor music shouldn't give them the right to play music as loud as they want so that it becomes a nuisance to area residents. And on a weekday night!! This is not something that I appreciate dealing with when I have to get up at 5:30am to go to work.

Please look into this and if permits are granted to businesses in the future to play outdoor music, please have the cut-off time end at a more reasonable hour so that it doesn't affect the quality of life of area residents.

Good Morning Alderman,

Hope you had a great summer and all is well. I'm reaching out to you this morning to notify you of a noise/nuisance situation that occurred yesterday. Around 7pm last night, I could hear music blaring around our condos. I took a walk to investigate and found it was coming from The Loaded Slate on 3rd St. They were having an outdoor Packer party, projecting the game on the side of their building, and blasting music from an outdoor sound system.

At a 9:05pm I called the MPD to report a noise/nuisance complaint regarding this. I received a call back a few minutes later from an officer that told me that The Loaded Slate had a permit for this event that allowed them to play outdoor music until 1:30am, but that he would work with the owner to move people indoors after the game was over and turn the music down. Well that didn't happen. The loud music continued and I called the MPD again at 11:38pm to log another complaint and eventually the volume was decreased after midnight.

I'm all for establishments having events and promoting their business, but I don't think that this special permit should give them a free pass to play music as loud as they want and as late as they want. As you know the River House Condos are located on Edison St, approximately 1½ blocks away from The Loaded Slate. I shouldn't have to hear music and bass inside my home with the doors and windows closed from a business that's located 1½ blocks away.

In the future, is there a way that stipulations can be written into the permits to restrict volume and hours? I don't feel that a permit should allow outdoor music to be played at high volumes until 1:30am. And on a Sunday night! I'd also like to know if there is a way for area residents to be informed of these permits in advance or even possibly take part in the approval process?

- 6. On 08/03/12 at 1:30 am, Milwaukee police conducted a License Premise Check at 1137 N Old World Third Street. Investigation revealed the bar had underage patrons, some which fled upon seeing police. Officers observed there was no one at the door checking ID's and spoke with Joe Kuntz. Kuntz stated it was unusually busy this particular night and had the doorman also acting as a barback, stocking coolers. Kuntz was advised he must always have someone at the door checking ID's. The underage patrons were cited.
- 7. On 03/02/13 at 12:00 am, Milwaukee police conducted a License Premise Check at 1137 N Old World Third Street. Investigation revealed underage patrons were inside the bar and were cited. Police spoke with Paul Schemelzer who was the doorman/security person, who stated they must have had fake ID's because he checked everyone's ID as they entered. Schemelzer was advised to ask for a school ID or some other form of ID when suspicious of a patron. The agent, Joseph Kuntz, was advised to have his security refer to identification reference book that was provided to them earlier in the year by police.

- 8. On 03/07/13 at 12:20 am, Milwaukee police conducted a License Premise Check at 1137 N Old World Third Street. Upon entering the tavern, police observed an employee of the bar standing on top of the counter with a bottle of liquor in her hand pouring it into the mouths of patrons. Police spoke with the agent Joseph Kuntz and explained that this is a health code violation and the employee would have to stop. Kuntz stated he was unaware that it was a violation and was issued a warning.
- 9. On 04/06/13 at 12:10 am, Milwaukee police conducted a License Premise Check at 1137 N Old World Third Street. Investigation revealed the bar had patrons under the age of 21 and those patrons were cited for presence of underage and obstructing. Officers spoke with Jerome Mellon who was advised of the underage patrons. Mellon stated that he would hold a meeting with his security about the on going problem with underage patrons.

- 10. On 07/28/2013 Milwaukee police were flagged down for a battery complaint in the 1100 block of North Old World Third Street. Investigation revealed the victim, Nicholas P. Zillman, had been hit in the head with a hammer. Both Zillman and the unidentified suspect were observed inside The Loaded Slate Tavern (1137 North Old World Third Street) shortly before the incident. Zillman appeared to be intoxicated and was uncooperative with police during the investigation. Milwaukee police incident report # 132090024 filed.
- 11. On 09/13/2013 at 12:04am a Milwaukee police officer conducted a licensed premise check at 1137 North Old World Third Street (Loaded Slate). The officer observed that the business appeared to be very near its posted capacity of 99, and asked the person at the door to let 5 patrons exit the business to every 2 allowed to enter in order to alleviate the crowd. The officer also observed a bartender pouring liquor directly into the mouth of a patron. The officer also observed some patrons leave their drinks at the bar and go to the back of the establishment which is consistent behavior for underage patrons. Because the officer was alone, he advised the Kuntz to have the bartender to cease his actions and the possibility of underage patrons in his establishment. No additional action was taken at that time. On 09/20/2013 at 12:08am Milwaukee police conducted a licensed premise check at 1137 North Old World Third Street (Loaded Slate). Officers at the exits checked patron identification as they exited the business and discovered 13 were under the legal drinking age of 21. One patron became combative and was placed in handcuffs. Capacity inside the business is 99 with the back bar open. The back bar was closed and officers estimate the crowd at 125-130. Additionally, the rear exit was padlocked from the inside. A total of 29 citations were written to patrons for violations of municipal ordinance including Presence of Minor/Underage, Possession/Consumption of Alcohol, Minor Misrepresent Age, Obstructing Issuance of Citation, Loitering Taverns, and Resist/Obstruct Officer. - 12. On 09/26/2013 at 3:00pm Milwaukee police Captain Aaron Raap, Sgt. Scott Charles, Sgt. Jeffrey Lintonen, PO Xavier Benitez, PO Adam Bradley and Michele Klingbeil met with Attorney Michael Whitcom, Joe Kuntz and Shawn Mellon at 1137 North Old World Third Street (Loaded Slate) at the request of Joe Kuntz. The business owners are looking for techniques to prevent underage patrons from entering the bar. Several suggestions were made to prevent underage patrons from entering the business and to help alleviate over capacity issues.
- 13. On 05/03/2014 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to gain entry into and then purchase a beer from the bartender at 1137 North Old World Third Street (Loaded Slate). The applicant received two citations.

- 14. On 06/28/2014 Milwaukee police responded to a sick/injured person at 1137 North Old World Third Street (Loaded Slate). This report is written by Police Officer Cullin Weiskopf, assigned to District One, Late Power Shift.

On the evening of Thursday March 30, 2017 through the morning of Friday, March 31, 2017 District One personnel performed an underage tavern enforcement initiative. There were three teams that were part of this initiative. Each team had an MPD Police Aide, a Police Officer, both of which were acting in a plainclothes capacity with a uniformed Police Officer or Sergeant monitoring from a short distance. The Police Aide for each team was under the age of 21. This was verified by their respective Wisconsin driver's license. Police Aide Ana Romero-Perez (PS 024687, 03/18/1997) and Police Officer Paige Carloni (PS 024035) were in plainclothes while Police Officer Mariolys Flores (PS 024325) was in full uniform.

Prior to attempting any checks of licensed establishments the Police Aides and Police Officers were given instructions. All plainclothes members of this initiative were advised they are not allowed to consume any intoxicating beverages. If asked about their age, the members were told to tell the truth. The Police Officers were directed to produce ID's, but the underage Police Aides were directed to not produce any form of identification. It was explained that the Police Aide was to order an alcoholic beverage. It was explained that at all times the plainclothes Police Officer should be in visual sight and observe the financial transaction for alcoholic beverages.

On March 30th 2017, at 9:27 PM, PO Carloni and PA Romero-Perez attempted to gain entry to the class "B" licensed tavern, Loaded Slate, located at 1103 N. Old World Third St. PA Romero-Perez was not allowed in the tavern by security at the enterance to the tavern.

On April 5, 2017, at 9:36 PM, PO Matthew Anderson informed Benjamin Alzalde that the establishment successfully passed the initiative.

- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

This report is written by PO Thomas FRANK, assigned to District 1, Power shift. On Saturday, October 1st, 2016, at 11:28PM, I was flagged down for a fight at the location of 1023 N. Old World 3rd St. (The Brass Alley). Upon my arrival, I observed a W/M standing outside of the tavern bleeding from the top of his head, and behind his left ear. This subject stated he was involved in a physical fight inside of the tavern, at which time he was struck over the head with a glass beer bottle. This subject was extremely upset, and stated there were no employees around, and at no time did any of them intervene. This subject stated two B/M's threw him to the ground, and then one of them struck him over the head with a bottle. The altercation apparently started over this subject's friend, bumping into one of the B/M's inside of the tavern. The injured W/M mentioned several times that he could not believe that no staff member was able to intervene, and that the two B/M's ran out of the tavern and got away before anyone even realized he was injured. This subject refused medical attention, and refused to give me his information. He was highly upset, and stated he did not want to give me any of his information because, "you will never find these guys, so who cares". This subject and his friends then left the area without giving me any additional information regarding this incident.

I spoke to the on duty manager, Brian WESTON, W/M, 11/10/85, who stated he was unaware of what happened, until one of his employees told him, because he was in the back of the tavern, and the fight happened in the front of the tavern. I informed WESTON that the injured party was extremely upset that the staff did not intervene, at which time WESTON stated, two employees were "no shows", and he was helping out as much as he could, but did acknowledge that they were short staffed. From my observations, it appeared that there was not enough staff working to properly deal with the amount of patrons that were inside. I notified WESTON that I would be filing this report, and advised him about future staffing levels on a busy weekend, and the issues that could have possibly been resolved if they were properly staffed.

This report is written by Police Officer Cullin Weiskopf, assigned to District One, Late Power Shift.

On the evening of Thursday March 30th, 2017 through the morning of Friday, March 31st, 2017 District One personnel performed an underage tavern enforcement initiative. There were three teams that were part of this initiative. Each team had an MPD Police Aide, a Police Officer, both of which were acting in a plainclothes capacity with a uniformed Police Officer or Sergeant monitoring from a short distance. The Police Aide for each team was under the age of 21. This was verified by their respective Wisconsin driver's license. Police Aide Ana Romero-Perez (PS 024687, 03/18/1997) and Police Officer Paige Carloni (PS 024035) were in plainclothes while Police Officer Mariolys Flores (PS 024325) was in full uniform.

Prior to attempting any checks of licensed establishments the Police Aides and Police Officers were given instructions. All plainclothes members of this initiative were advised they are not allowed to consume any intoxicating beverages. If asked about their age, the members were told to tell the truth. The Police Officers were directed to produce ID's, but the underage Police Aides were directed to not produce any form of identification. It was explained that the Police Aide was to order an alcoholic beverage. It was explained that at all times the plainclothes Police Officer should be in visual sight and observe the financial transaction for alcoholic beverages.

On March 30th 2017, at 8:57 PM, PO Carloni and PA Romero-Perez attempted to gain entry to the class "B" licensed tavern, The Brass Alley, located at 1023 N. Old World Third St. PA Romero-Perez was not allowed in the tavern by security at the enterance to the tavern.

On April 5th, 2017, at 9:20 PM, PO Mathew Anderson informed Anthony Trester, the bar manager, that the establishment successfully passed the initiative.





When the officer entered the business, staff began yelling "everyone out". All but 13 people left the business prior to 2:00am. The staff was advised that any further violations would result in citations.

- 14. On 07/16/2016 at 6:21pm officers responded to a fight at The Brat House, 1013 N. Old World Third St. The investigation revealed the bar had removed a patron for being intoxicated. The subject attempted to push past the bouncer to get back in the tavern. The bouncer grabbed him and slightly pushed him to create distance. The subject fell to the ground striking his head. The victim was treated at the hospital for a laceration to his head.
- 15. On 08/16/2016 an officer conducted follow up at Brat House, 1013 N. Old World Third St. regarding bars selling alcohol on shuttle buses to Brewer games. The manager was advised this practice was illegal, the manager, Eric IMHOFF, stated they run a shuttle but do not sell alcohol on the bus.
- 16. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Milwaukee Brat House, 1013 N. Old World Third St. The Police Aid was challenged at the door by security, she stated she did not have an ID and the bouncer stated he believed she was of age and allowed her inside. She was able to purchase a beer at the bar for \$5.00.
- 17. On 07/03/2017 an officer meet with the manager of The Brat House, 1013 N. Old World Third St regarding an aldermanic complaint. The complaint was that patrons of The Brat House were leaving the sidewalk area and sitting in the sidewalk areas of other taverns and leaving the sidewalk area with open containers of alcohol. The complaint was also that the bar was selling alcohol out the open front window. The manager, Andy FRONEK, stated when it is busy it is hard to keep patrons in their area. When they are running a shuttle to Brewers games or Summerfest he does sell beer through the front window. He stated they were willing

to work with the other bars to keep patrons at their specific patio areas and when providing shuttle service he would have security in the patio area to keep patrons in their area and off the city streets.

On Saturday, 07-16-16, at approximately 6:21pm, squad 1220, Police Officer Rick BUNGERT and I were dispatched to a fight at 1013 N Old World Third St. Upon our arrival, I was met by the manager of the Brat House which is located at the above listed address. The manager, Ryan M COOKE, w/m, 10-04-88, phone of 414-339-3830 stated that the patron that was lying on the sidewalk in front of Buck Bradleys was later identified as Joshua Carl BARTELS, w/m, 08-26-76 from California. COOKE went on to say that BARTELS had entered the Brat House around 1:00pm where he ate lunch and consumed about three beers that he knew of. Some time later, COOKE added that BARTELS began to wander in and out of the bar, possibly due to intoxication, or having been under the influence of something other than alcohol. After informing BARTELS that he needed to leave, COOKE stated that BARTELS paid his bar tab and left only to return a few minutes later. While he did not witness the encounter of BARTELS being involved in a scuffle with the bar's bouncer, COOKE made note of several tables of patrons who were sitting outside when BARTELS fell and struck his head.

I then spoke to the bouncer who had the initial interaction with BARTELS prior to BARTELS' falling. The bouncer, Eric M THUROW, w/m, 11-12-86, phone of 262-689-7935 stated that he did not know what time BARTELS had initially come into the bar but stated that he did observe THUROW entering and leaving the bar several times after having been asked to leave by other bar staff. While standing at the front door of the bar, THUROW stated that BARTELS again attempted to gair entry into the bar alleging that he had left his backpack on the stool next to where he was sitting. When informed that he had not left any such item and needed to again leave, THUROW stated BARTELS attempted to push past him to enter the bar at which time THUROW stated he grabbed BARTELS to escort him back outside. Just outside of the front door, THUROW stated BARTELS grabbed his arm and attempted to push him. To avoid a physical altercation with BARTELS, THUROW stated he then grabbed BARTELS and slightly pushed him in an attempt to create some distance between them. As he did so, THUROW stated BARTELS began to stumble backwards, grabbing and scratching his left arm before falling to the ground, striking the back of his head on the concrete sidewalk. THUROW stated his intent was not to harm BARTELS but to get him to leave the premise before he caused a scene.

MFD personnel arrived on scene and preliminarily treated BARTELS for a laceration to the back of his head. Bell Ambulance 405 then responded to the scene and transported BARTELS to St. Mary's Hospital for medical treatment. BARTELS was admitted to the emergency room at 7:20pm and was treated by Dr. Stephanie POST for a 3-4 inch laceration to the back of the head that required six staples to close. At 9:30pm, a preliminary breath test (PBT) was administered to BARTELS by Officer Scott LAMMERS at which time BARTELS BAC was recorded as .256.

Upon our arrival at St. Mary's, Officer BUNGERT and I were advised by both ambulance and medical staff that BARTELS informed them that there were two handguns in the backpack that he had attempted to go back into the Brat House to retrieve. Because of his altered state due to his level of intoxication, BARTELS gave several differing accounts of how this incident transpired. When asked how many drinks he had that day, BARTELS responded that he didn't know for sure, just that it was a few. BARTELS admission of him being intoxicated at the time of this incident was recorded via my Axon Flex body worn camera # 2837.

While in the back of the ambulance, BARTELS stated that he was from California and gave the address of 455 Evelynv Ave 1203, Mountain View, CA as listed on his CA driver's license. When asked to give his account of what happened, BARTELS admitted several times that he was intoxicated. Upon verifying that the address given as a valid address for him, BARTELS then stated that as of Friday, 07-15-16, he considered himself to be a new resident of Wisconsin, residing at 3830 S 61st St., then 3830 W Greenfield Ave in West Allis. When asked how he came to be a resident of

the addresses given, BARTELS stated his father Carson BARTELS drove him from his residence in Cedar Falls, IA to the train station there at which time he took the train from Iowa to Chicago and then to Milwaukee. BARTELS stated he was here to check himself into the sober living facility, Sals at 3830 W Greenfield Ave.

After having checked in, BARTELS stated he was asked to leave, initially what he told was the same day, but changed to Friday as he had been in town since Thursday for being in violation of the rules of having consumed alcohol. BARTELS went on to say that prior to this incident, he took a Lyft from the Radisson or some other hotel near the airport to Old World Third St. It was later learned through BARTELS' find my iPhone app that's on his phone that BARTELS resided at the Radisson on North Avenue in Wauwatosa prior to losing his backpack.

When asked why he failed to mention that there were two firearms in his backpack while Officer BUNGERT and I were still with him at the Brat House, BARTELS stated that he just forgot but as soon as he remembered, he relayed the information to people that would be able to inform us of the additional information. His confidence level that firearms were in his backpack when he lost them went from sure, to it's possible, to maybe not firearms but 100% sure that the backpack contained ammunition for a 30mm rifle. BARTELS stated he if did have a firearm, it would've been secured in a biometric case that only he would be able to access via his fingerprint. BARTELS then stated that all the firearms he owns are in San Francisco on his friend Mike's boat.

Due to the possibility that BARTELS' black Osprey backpack might contain a firearm, Officer BUNGERT and I transported BARTELS back to the Brat House to view video surveillance as to whether or not BARTELS was ever in possession of the backpack that he described. Upon our arrival, Officer BUNGERT was met by both co-owners of the bar, Andy was able to access the bar's video surveillance from his cell phone at which time Officer BUNGERT viewed the video and confirmed that BARTELS was in possession of his backpack when he left the bar around 5:30pm. At this point, BARTELS does not know where he could have left the backpack, stating that he did go into at least one other restaurant, Maders, before patroning the Brat House. Unable to return to the sober living home, BARTELS was conveyed by Officer BUNGERT and me to the Courtyard by Marriott at 300 W Michigan St.

This report is written by Police Officer Mariolys Flores, assigned to District One, Late Power Shift.

On the evening of Thursday March 30, 2017 through the morning of Friday, March 31, 2017 District One personnel performed an underage tavern enforcement initiative. There were three teams that were part of this initiative. Each team had an MPD Police Aide, a Police Officer, both of which were acting in a plainclothes capacity with a uniformed Police Officer or Sergeant monitoring from a short distance. The Police Aide for each team was under the age of 21. This was verified by their respective Wisconsin driver's license. Police Aide Ana Romero-Perez (PS 024687, 03/18/1997), Police Monica Zarinana-Mayorga (PS 026070, 11/28/1996), PA Jada GREER (PS 026047, 08/30/1997), PO Paige Carloni (PS 024035), PO Sarah Beland (PS 019704) and PO Kourtney Hartk (PS 022557) were in plainclothes while PO Mariolys Flores (PS 024325), PO Seth Edwards (PS 024600) and PO Cullin Weiskopf (PS 017808) were in full uniform.

Prior to attempting any checks of licensed establishments the Police Aides and Police Officers were given instructions. All plainclothes members of this initiative were advised they are not allowed to consume any intoxicating beverages. If asked about their age, the members were told to tell the truth. The Police Officers were directed to produce ID's, but the underage Police Aides were directed to not produce any form of identification. It was explained that the Police Aide was to order an alcoholic beverage. It was explained that at all times the plainclothes Police Officer should be in visual sight and observe the financial transaction for alcoholic beverages.

After the briefing, the teams conducted underage checks at multiple taverns and convenient stores located throughout the District One boundaries.

Police Officer Paige Carloni and Police Aide Ana Romero-Perez attempted to gain entry to the class "B" licensed tavern, Milwaukee Brat House located at 1013 N Old World Third St. Police Officer Carloni was challenged at the point of entry and she showed her Wisconsin state identification card providing she was of age. PA Romero-Perez was also challenged at the door. When the bouncer asked for identification, PA Romero-Perez told the bouncer that she did not have her ID with her. Bouncer then stated that he believed that she, Romero-Perez was of age and let her enter the premises. The Bouncer at the door was a W/M, with a beard, wearing a gray sweater. Once inside, Romero-Perez purchased a beer at the bar for \$5.00. The bartender who served Romero-Perez was a W/M, with a beard, 5'07, and 150lbs. wearing a black beanie, black shirt and glasses.

On Friday March 31, 2017 at 9:50 p.m. Police Officer Mariolys Flores informed Ryan M. Cooke (M/W, 10/4/88), manager, that they failed.

PA-33E Narrative

This report is written by PO Cullin WEISKOPF, assigned to District One, late power shift. On Monday, July 3rd 2017 at 2:08 AM, Squad 1430, PO Eric NORTHWOOD and I, conducted a meeting with the manager of the Milwaukee Brat House tavern, Andy FRONEK, regarding an aldermanic complaint of Brat House patrons leaving the sidewalk area and sitting in the sidewalk area of the taverns to the north and south of the Brat House and leaving the Brat House sidewalk area with open containers of alcohol. The complaint also indicated that the tavern was selling alcohol out of the open front window to patrons on the street.

Prior to the meeting with FRONEK, at approx. 12:30 AM, I observed Milwaukee Brat House patrons sitting on the tables outside of the Old German Beer Hall, 1009 N. Old World Third St, located just to the south of the Milwaukee Brat House.

FRONEK stated that he was aware of his patrons sitting on the tables of the other bars to the north and south of the Brat House and that it was a constant battle to keep their patrons in their area, especially when it was busy. FRONEK stated that, specifically when they have a shuttle for special events (i.e. Brewer games, Summerfest) there are large amounts of patrons on their front patio areas. FRONEK stated that when patrons are waiting for their shuttle, the bar does sell beer through the front window area.

I explained the concerns of the aldermanic complaint to FRONEK who stated that they were more than willing to work with the other bars on the street to keep taverns specific patrons at their specific front patio areas. FRONEK also stated that from now on, when they are providing shuttle services, they will have security in the patio area to keep their patrons in their patio areas and not on the City street or in the other bars patio areas.

Good Morning Alderman,

Hope all is well. I'm contacting you to see if RC Schmidt approached the city about converting the west end of the Harp parking lot into a patio? In the attached photos, you can see that the dumpsters that use to reside in the SW corner of the parking lot have been moved to the east to open up an area along the river between the Harp structure and our condominium fence line. The old privacy fence that use to stand on the west edge of the parking lot has been totally removed and a new fence with a bar/table top has been erected. Several residents of the River House Condominiums have approached me with concerns about noise, increased occupancy, security, etc if this area is going to be converted into a patio. This area, which I'm estimating to be 30' x 20', would extend their premises right up to the fence line and exit door of our condominium privacy/security fence.

Another concern, is that two Paddle Tavern pontoon boats have been running their business from the Harp's docks. Not sure if you were aware of this or if the proper permits were obtained to conduct this business, but the River House Condominiums residents were never informed that this business was going to operate just few feet from our property. Again, the concern is noise, especially considering that alcohol is allowed and encouraged onboard.

Please let me know what you find out. If the plan is to convert the parking lot area into a patio, the River House Condominium residents would not be in favor of this and would like to know what needs to be done to stop this from moving forward.


Good Morning Alderman,

Hope all is well. I'm contacting you to see if RC Schmidt approached the city about converting the west end of the Harp parking lot into a patio? In the attached photos, you can see that the dumpsters that use to reside in the SW corner of the parking lot have been moved to the east to open up an area along the river between the Harp structure and condominium fence line. The old privacy fence that use to stand on the west edge of the parking lot has been totally removed and a new fence with a bar/table top has been erected. Several residents have approached me with concerns about noise, increased occupancy, security, etc if this area is going to be converted into a patio. This area, which I'm estimating to be 30' x 20', would extend their premises right up to the fence line and exit door of our condominium privacy/security fence.

Another concern, is that two Paddle Tavern pontoon boats have been running their business from the Harp's docks. Not sure if you were aware of this or if the proper permits were obtained to conduct this business, but the esidents were never informed that this business was going to operate just few feet from our property. Again, the concern is noise, especially considering that alcohol is allowed and encouraged onboard.

Please let me know what you find out. If the plan is to convert the parking lot area into a patio, the esidents would not be in favor of this and would like to know what needs to be done to stop this from moving forward.

- 5. On 07/26/2014 Milwaukee police observed a fight in front of The Harp tavern (113 East Juneau). Investigation revealed four subjects were harassing females waiting in line to enter The Harp. When security intervened, these same four subjects assaulted them. The four subjects received citations.

This report is written by P.O. Andrew GOLLUP, assigned to District Two, Early Shift.

On Sunday, 1-29-17 at 1:30am, Squad 1441 (P.O. Neil VERDBURGT and I) was flagged down at The Harp, 113 E Juneau Ave, for a Subject Down call for service. Upon arrival, I observed a white male, later identified by Wisconsin DL as Brian G HAGGERTY (w/m 9-20-88), laying face down, unconscious on the ground. While P.O. VERDBURGT requested medical and an anonymous citizen who identified herself only as "a nurse" checked HAGGERTY for a pulse, I spoke with the victim, Jesse M BAKER (w/m 10-19-84).

BAKER stated that he was working as a bouncer for The Harp tonight. He stated that HAGGERTY had been previously kicked out of Triniti (125 E Juneau Ave) due to being overly intoxicated. BAKER knew this because The Harp and Triniti have the same owners. BAKER stated that HAGGERTY came to The Harp and requested to be let in, but BAKER denied him entry. HAGGERTY began to bribe BAKER, but was still not let in. HAGGERTY then began to threaten BAKER, and stated something to the effect that BAKER's face would meet HAGGERTY's elbow.

HAGGERTY then moved towards BAKER. BAKER thought that HAGGERTY was about to attack him and feared for his personal safety, so he pushed HAGGERTY backwards. Due to HAGGERY's extreme level of intoxication, he began to fall, "twisted", and his face landed directly on the concrete ground. HAGGERTY remained unconscious on the ground, and HAGGERTY and bar patrons flagged us down.

BAKER stated he did not push HAGGERTY very hard, and he did not mean for BAKER to fall. BAKER stated he was only trying to prevent being attacked.

I was then approached by Kurt D HENTHORN (w/m 8-20-88), who identified himself as HAGGERTY's friend. HENTHORN stated that they had arrived in Milwaukee by train around 5:00pm, and they had been drinking since arriving. HENTHORN thought that HAGGERTY had consumed six to eight beers since arriving.

I then interviewed Kyle T CWIKLIS (w/m 11-5-89), who was working as a bouncer at Triniti. CWIKLIS stated that he had earlier kicked HAGGERTY out of Triniti due to his extreme level of intoxication. HAGGERTY threatened to attack CWIKLIS and to get his friends to do the same. HAGGERTY eventually left, and CWIKLIS observed him walking to The Harp. CWIKLIS stated he did not see how HAGGERTY fell to the ground, but saw him lying on the ground unconscious.

During my on-scene portion of the investigation, I observed HAGGERTY was unconscious for approximately ten minutes. I observed a tennis ball sized welt to his forehead. HAGGERTY was transported to Froedtert Hospital by MFD Med 7 (Red Shift, Acting Lt Michael PAYNE). He was treated by Dr Heidi LUDTKE at 2:20am. While at Froedtert, HAGGERTY told P.O. VERDBURGT that he did not remember the incident or why he was at the hospital.

HAGGERTY was issued citation J9816RP3F0 for Disorderly Conduct.

It should be noted that all employees of Triniti and The Harp were cooperative with the investigation and assisted police in providing aid to HAGGERTY.

On the evening of Thursday March 30th, 2017 through the morning of Friday, March 31st, 2017 District One personnel performed an underage tavern enforcement initiative. There were three teams that were part of this initiative. Each team had an MPD Police Aide, a Police Officer, both of which were acting in a plainclothes capacity with a uniformed Police Officer or Sergeant monitoring from a short distance. The Police Aide for each team was under the age of 21. This was verified by their respective Wisconsin driver's license. Police Aide Monica Zarinana-Mayorga (PS 026070, 11/28/1996) and PO Sarah Beland (PS 019704) were in plainclothes while PO Seth Edwards (PS 024600) were in full uniform.

Prior to attempting any checks of licensed establishments the Police Aides and Police Officers were given instructions. It was explained that at all times the plainclothes Police Officer should be in visual sight and observe the financial transaction for alcoholic beverages.

On March 30th, 2017 at 8:58 PM, PO Beland and PA Zarinana-Mayorga attempted to gain entry to the class "B" licensed tavern, The Harp, located at 113 E Juneau Ave. PA Zarinana-Mayorg was refused entry by security for the tavern.

On May 9th, 2017 at 11:50 PM, PO Cullin Weiskopf informed Kris Rickaby that the tavern had successfully passed the initiative.

This report was written by Sergeant Thomas Ackley, assigned to District One, late power shift.

On August 6, 2016, at about 1:00 am, I was assigned to Squad 1411. I was supervising the Code Red deployment. I received a phone call from PO Matthew Anderson who advised me the owner of Dino's Taverna, 777 N Jefferson St, had requested to speak with a supervisor.

Upon arrival, I spoke with the owner, Dean Zarkos, who wanted to complain about the music level of the other taverns on the block. Zarkos continued and stated the problems on the block were not from his tavern, but from the other taverns on the block. It should be noted that Zarkos had just had a hearing with the License Committee, where many other business owners on the block had appeared and testified about Zarkos' alleged problematic business practices. Zarkos asked what else he could do to do better. I told Zarkos that I was concerned with the fights that stemmed from his tavern. I began to go into detail, explaining my assessment of past problems. While discussing past incidents, I observed several concerns. The concerns are as follows.

-It was a Friday night in August and Zarkos was managing the tavern and acting as the only security / door attendant for the tavern. Especially with the history of fights and other disturbances at the tavern, my assessment was that there should have been at least two security staff / door attendants on duty.

-Zarkos appeared to be intoxicated. I could smell the odor of intoxicating liquor on his breath as he was talking to me. If my assessment was accurate, his level of intoxication would have significantly decreased his ability to manage the tavern, monitor the crowd, while also acting as a bouncer. Zarkos denied, however, having anything to drink that day.

-While speaking with Zarkos, over a dozen patrons walked in without being ID'd or even greeted. When I brought it to Zarkos' attention, Zarkos began to card people. One of the patrons handed Zarkos a piece of paper with his picture on it in black and white. I recognized the format of the photo as a photo from MPD's booking system. The photo was a booking photo. The patron also somehow found a sticker with his personal information on it. The sticker was consistent with the stickers hospitals print out for patients as they are admitted. The patron stated he had been in the bar 3 times already that night. I explained that the piece of paper was by no means a form of identification, as the personal information was only on a sticker and the sticker was placed on a piece of paper from a copy machine.

I explained each of the concerns with Zarkos.

This report is written by Police Officer Deron COLEMAN assigned to District 1 Late Shift.

On Tuesday, August 30, 2016 at approximately 12:06AM, Squad 1330 (P.O. James PITTMAN and myself) was dispatched to 777 N Jefferson St for a Property Damage call for service.

Upon arrival, P.O. PITTMAN and I spoke to staff at Plum Lounge which is located at 780 N Jefferson St (directly across the street from Dino's Tavern). They explained to us that on Monday, August 29, 2016 at approximately 11:36PM, an unidentified patron exited Dino's Tavern and threw a glass bottle from the sidewalk in front of Dino's across N Jefferson St towards Plum. This bottle nearly struck an employee's vehicle before shattering on the sidewalk in front of Plum Lounge. It should be noted that this act was recorded by surveillance cameras outside of Plum Lounge and co-owner Andre B LEWIS II (B/M 09/26/1981) was able to provide officers with a thumb drive containing a copy of this video.

After determining that no property damage had occurred, P.O. PITTMAN and I walked to Dino's Tavern in order to discuss this incident with the staff members on scene and hopefully come to a peaceful agreement between the staff members of two establishments involved. As we approached Dino's, P.O. PITTMAN, who is a certified Drug Recognition Expert, detected the faint smell of burnt marijuana. There were approximately 8-10 patrons seated outside of the front entrance, including two unidentified women dancing on the steps and railings that lead to the upper entrance of the building. We were met by Dean ZARKOS (W/M 05/25/1954) who identified himself as the owner of the establishment. Officers were able to determine that ZARKOS was intoxicated by alcohol due to the strong odor of an alcoholic beverage on his breath, red & glassy eyes, loud & slurred speech, and he also appeared to be swaying while standing and slightly off balance while walking.

As I explained to ZARKOS that one of his patrons threw a glass bottle across the street while leaving Dino's he became uncooperative and argumentative. He refused to listen to me, as he continued to cut me off while speaking in order to deflect to other topics. While speaking to him, I observed a lack of order in and around his business. The patrons were loud, disorderly, and also attempted to insert themselves into our conversation. ZARKOS continued to be argumentative as he accused my partner and I of lying about seeing video of this incident. ZARKOS informed us he was the only employee on duty running his licensed tavern, stating that he had sent his wife home at approximately 7:00PM. ZARKOS did not appear to have any other employees or security personnel on duty. ZARKOS did not deny being intoxicated and did not comment when asked if he thought it was dangerous to be in control of a licensed premise while intoxicated by alcohol.
