This report is written by Police Officer Gilbert Gwinn, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/03/2013 the applicant met with Captain Victor Beecher, Lieutenant Joseph Seitz and Lieutenant Shannon M. Seymer-Tabaska of the Milwaukee police department at the applicant's request. Also in attendance were Obiora Obi, described during the meeting as 75% owner and General Manager, and Sheena Tally, described during the meeting as manager. The applicant was described during the meeting as a 0% owner. During this meeting, some of the potential problems related to a business holding a Class B Tavern license in general and the applicant's ability to handle those potential problems was discussed. The applicant told police he wanted to work collaboratively and cooperatively with police and believed many of the problems that may occur at the business could be handled by security. The applicant informed police that he would be responsible for executive decisions and administration of the business.

2. On 08/04/2014 the applicant, along with Obiora Obi and a representative from Lucas security, met with Captain Beecher and Sergeant Donovan-Agnew of the Milwaukee police department at Milwaukee police district #4 regarding the re-opening of Onyx. Several changes were outlined by the applicant and Obi that they hoped would help them better operate the establishment. The applicant and Obi stated they are looking forward to working with the department and operating a successful business.

3. On 08/15/2014 Milwaukee police conducted a licensed premise check at Onyx Night Club. Obiora Obi identified himself as the Manager/Owner of the property and told officers he has hired a new security contractor, that the business will not allow anyone under the age of 25 into the club and that the business will close at 1:30am or 1:45am depending on the size of the crowd. Obi requested Milwaukee police squads be in the area at closing time.

4. On 04/25/2015 Milwaukee police were dispatched to a theft complaint that occurred at 3120 West Villard Avenue (Onyx Night Club). Investigation revealed two patrons of the business placed their wallets on a table while they had their pictures taken in a booth. When they went to retrieve their wallets, they discovered both were gone. Obiora Obi and bar security were very cooperative with police during this investigation which led to the suspect being identified and cited.
 5. On 05/29/2015 Milwaukee police conducted follow up at Onyx Night Club (3120 West Villard Avenue) regarding an arson investigation. Obiora Obi told officers he received a phone call from a Milwaukee police officer around 5:00am 05/28/2015 advising him of an attempt arson at his business. Obi viewed video footage of the incident and discovered an unknown person pouring gasoline around the exterior of the building, then lighting it with a match or lighter. Milwaukee police incident report #151480019 filed.
 6. On 06/02/2015 the applicant, as well as Obiora Obi, met with Milwaukee police at Milwaukee police district #4 regarding an event planned for Onyx Night Club on 06/22/2015. The business will be hosting an event on that date featuring "Lil Wayne". A discussion was held regarding a plan for the staging of this event. Mr. Obi stated he would provide the police with a written copy of the plan.
 7. On 06/27/2015 Milwaukee police, along with agents from the Wisconsin Department of Revenue, conducted a licensed premise check at 3120 West Villard Avenue (Onyx Night Club). During this inspection, officers observed no violations of municipal ordinance. However, agents discovered 37 contaminated bottles that were disposed of at the location.

8. On 09/01/2015 Obi Obiora and Richard Lucas attended a scheduled meeting at Milwaukee police district #4 regarding upcoming events at Onyx. During this meeting, Mr. Obiora stated he had 3 upcoming events and requested additional police presence on 09/19/2015 for an event where he anticipated approximately 500 attendees.
 9. On 12/27/2015 Milwaukee police responded to a fight complaint at Onyx Night Club. Security told officers there had been a fight inside the club, but there were no injuries. All involved parties were gone when officers arrived.
 10. On 01/01/2016 at 4:28am, Milwaukee police were dispatched to a shooting at Onyx Night Club, while other officers were dispatched to St. Joes Hospital to meet with the victim. Officers spoke to Obi Obiora who was identified as the manager and told officers he was not aware of a shooting at his location. Mr. Obiora allowed officers to view video captured by his security camera system. This video depicted at 3:29am, two individuals engaged in a verbal altercation outside of the main entrance with several other individuals attempting to intervene. At no time did the officers observe a gun or any one being physically assaulted. A security guard was interviewed and stated he heard shots fired but believed they were from distance. The victim of

this offense told officers he heard gunshots as he was crossing West Villard Avenue southbound from the Onyx Night Club, when he heard gunshots and realized he had been shot in the leg. Milwaukee police incident report #160010048 filed.

11. On 01/31/2016 Milwaukee police were dispatched to a fight/battery at 3120 West Villard Avenue (Onyx Night Club). The victim stated he was physically assaulted in a bathroom stall at the business and robbed of \$2,000. Milwaukee police incident report #160310019 filed. During this investigation, officers heard two gunshots and observed patrons fleeing the business. Officers entered the business and located a victim who sustained a gunshot wound to his leg. A security guard stated prior to the shooting an individual involved in an argument was escorted out of the building. Approximately 10- 15 minutes later the bar lights were turned on and he observed the same subject inside the bar fighting with others. He did not see a firearm, but heard two gunshots. Milwaukee police incident report #160310017 filed.
12. On 02/06/2016 a meeting was held at Milwaukee police district #4 regarding a shooting that had occurred on 01/31/2016. It was pointed out that no major incidents had occurred at Onyx since it reopened until the shooting. Obiora Obi stated the victim of the robbery (see item #11) had been flashing money all night prior to being robbed in the men's room. He further stated the promoter of this event promoted to known gang members, which was unknown to him or his security staff until the group showed up. He admitted they had become lax in searching people and he was considering changing the business's age limit. Obi stated he would send a new security plan and continue to work with district #4.
13. On 02/13/2016 Milwaukee police were dispatched to a subject with a gun complaint at 3120 West Villard Avenue (Onyx Night Club). While en-route, officers were advised that the firearm was in a black Honda bearing Wisconsin registration. Officers observed the described vehicle and discovered a handgun in plain view partially under the passenger side front seat. Investigation revealed the owner of the auto, Devin Cooper, had become belligerent while inside the business and was removed by security. Once outside the business, Cooper retrieved a handgun, which he placed in the waistband of his pants, from the auto. Security for the club began dialogue with Cooper and eventually he threw the firearm back into the car. Cooper was detained by security until police arrived. Cooper was arrested. Milwaukee police incident report #160440016 filed.
14. On 02/27/2016 Milwaukee police were dispatched to a shots fired complaint at 3120 West Villard Avenue (Onyx Night Club). Security stated there had been a fight inside the business. Security separated the individuals involved and forced them to leave the club. One of the involved parties fired three shots outside of the establishment shortly after being forced to leave. This subject was apprehended by security after a chase and detained for police. Security also discovered a handgun on the ground after checking the area. Video shows security breaking up a fight inside the club and removing the subjects. It then shows the suspect attempting to re-enter the club and being refused entry. The video then shows one of the subjects initially involved in the fight leaving the club. The suspect is then observed chasing this individual and firing three shots at the individual. Milwaukee police incident report #160580014 filed.
15. On 03/06/2016 Milwaukee police were dispatched to a fight at 3120 West Villard Avenue (Onyx Night Club). Security personnel told officers there had been a fight inside the club. The involved parties were escorted out and one of the subjects yelled for someone to get the gun from inside the vehicle. Fearing the situations would escalate, security called 911. The parties involved were gone when officers arrived.

16. On 04/24/2016 Milwaukee police were in the area of North 32nd Street and West Villard Avenue when they hear a gunshot. The sound appeared to come from the parking lot southwest of Onyx. Upon arrival officers observed 30-40 individuals in the parking lot with security from Onyx trying to disburse the crowd. Officers observed a subject, Tashauna Brewster, with blood on her mouth and her dress standing in front of a car in the parking lot. Brewster told officers she had left the club and had beeped her horn at a group of females standing in front of her car preventing her from leaving the parking lot. The females began punching her through the window. Brewster was dragged from her car by the females who continued to punch her. An unknown female fired one shot in the air and then entered a vehicle and fled the scene. Brewster was transported to St. Mary's hospital where she received stitches to her lower lip. Milwaukee police incident report #161150024 filed.
17. On 05/08/2016 Milwaukee police were dispatched to a shooting at 3120 West Villard Avenue (Onyx Night Club). Investigation revealed no one had been shot, but several shots had been fired in the parking lot utilized by customers of the business. There had been a fight inside the business that continued outside. During this fight the victim was knocked unconscious and received several stiches. While the fight was happening, two individuals fired 14 shots in the parking lot. Three firearms, including a stolen handgun and an AK47 style assault rifle, along with 17 grams of cocaine based powder and 3 grams of marijuana were recovered. Five arrests were made. Milwaukee police incident reports #161290025, #162390027, #161290028 and #161290064 were filed.
18. On 05/13/2016 Milwaukee police, along with representatives from the City Attorney's office and the District Attorney's office met with representatives from Onyx Social Club. Assistant City Attorney Nick Desiato recommended the age limit be raised to 23 and changes needed to be made to the interior security personnel. The applicant was given a Nuisance letter and asked what they were willing to do to change. The applicant stated they will come up with a plan continue to work with police.
19. On 05/15/2016 Milwaukee police were dispatched to a trouble with a subject complaint at 3120 West Villard Avenue (Onyx Night Club). Security for the club told officers that there had been a fight inside the business. When the involved parties were being escorted out, one of them stated he was going to get a gun and come back. No weapons were observed and the involved parties were gone when police arrived.
20. On 05/21/2016 Milwaukee police were instructed to monitor 3120 West Villard Avenue (Onyx Night Club). At approximately 1:50am, security from the business forced multiple subjects out of the tavern that had been involved in a fight. While clearing the fight, officers heard two shots. It was later determined that an officer had fired at an auto that had struck an officer. The establishment provided security video footage on the incident. Milwaukee police incident report #161420017 filed.

21. On 06/27/2016 a meeting was held at district 4 regarding an upcoming event at 3120 W. Villard Av. The applicant wanted to advise of an event that was scheduled for the "First Friday" that was for the victim involving the Wauwatosa Police. He stated he would have armed and unarmed security, he would wand the patrons and conduct pat down and purse checks. He also requested squads to monitor at closing time. He stated he would monitor the crowd and change the music if necessary.

22. On 10/16/2016 at 2:25am officers responded to a shooting at 5173 N. 31st St. The officers were advised the victim and suspect had come from Onyx Night Club at 3120 W. Villard Av. The investigation revealed the victim was in Onyx with a friend. There was an altercation after the victim or her friend bumped into the suspect. The victim left and was sitting in her car when the suspect approached and fired into the vehicle, striking the victim in the head. the officers were able to view the security cameras and located the suspect and victim in the ID scanner. The suspect and victim were under 25 which was in violation of the 25 and over age restriction.

23. On 10/20/2016 a meeting was held regarding the shooting from 10/16/2016. OBI stated there were no events schedule for this weekend and Jerrell JONES stated he was turning in the Liquor license on Monday 10/24/2016.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/23/02 the applicant was cited by the Milwaukee Police Department for Resisting/Obstructing an Officer.

2. On 03/05/06 at 2:40am, officers observed numerous vehicles and people outside the Onyx at 3120 W. Villard. Officers entered and found 20-25 persons still inside. Head of security George M. Willis was advised all patrons must be out by 2:30am and the patrons left quickly. A verbal warning was issued.
3. On 10/07/06, officers conducted a licensed premise check at Onyx, 3120 W. Villard Ave. A count of persons inside revealed the premise was over the posted capacity of 300 by 134 persons. A citation was issued to Marc Brown, who was listed as a corporate officer during this time.

4. On 03/31/07 at 12:33 am, Milwaukee police were dispatched to the Onyx for a Battery complaint. Investigation revealed a fight took place inside the tavern between two patrons who were ex boyfriend/ ex girlfriend. Security broke up the fight with the female leaving the tavern. Officers spoke to the licensee, Obiora Obi, who stated he did observe the fight and had security remove both parties from the club. A report was filed.

5. On 07/15/07 at 2:45 am, Milwaukee police conducted a tavern check at 3120 W Villard Avenue after seeing patrons leaving the tavern after hours. Officers found there was no liquor license displayed. The licensee, Obiora Obi, was issued a citation for Display of Liquor license.

6. On 08/11/07, Milwaukee police were dispatched to 3120 W Villard Avenue for a Fight complaint. Investigation revealed that a fight broke out between two patrons with security escorting all parties out of the tavern. No further information was provided.

7. On 03/09/08 officers investigated a Recklessly Endangering Safety complaint that occurred in the 3100 block of W. Villard Ave. Investigation revealed that an 18 year old and 20 year old female were inside Onyx at 3120 W. Villard Ave. where they were consuming alcoholic beverages. The two females were involved in a physical fight with other female patrons while on the dance floor inside Onyx. The females were removed by employees, but the fight escalated outside culminating with the 18 year old striking two of the other women involved in the fight, with a vehicle. The driver of the vehicle was arrested.

8. On 12/07/08 at 1:15 am, conducted a License Premise check at 3120 W Villard Avenue. While conducting the license premise check, several patrons of the tavern became loud, profane, and uncooperative. These patrons were cited for Disorderly Conduct. No tavern violations were observed.

9. On 05/02/09 at 12:21 am, Milwaukee police conducted a License Premise check at 3120 W Villard Avenue. Officers spoke to the manager Chuka Obi and observed no violations. Officers did advise Obi of concerns regarding patrons and their safety as they crossed the street to gain entry into the tavern due to illegally parked autos from patrons already inside the tavern. 25 parking citations were issued with four of those autos being towed.

10. On 09/03/09 at 1:15 am, Milwaukee police were monitoring an after party at the Onyx nightclub due to an anticipated large crowd. The help was requested by Onyx owners to assist their employees with traffic control and to ensure patrons left the area once closing was announced.

11. On 09/04/09, Milwaukee police were to monitor Onyx Night Club from 9 pm to 2 am for crowd and traffic control due to a large amount of patrons at the club. At 2:00 am, officers requested more squads due to heavy pedestrian traffic and congesting with auto traffic from patrons leaving the club. Three squads and a supervisor were needed until the area was cleared.

12. On 05/08/10 at 2:00 am, Milwaukee police were monitoring bar closing at Onyx when a fight broke out between members on a party bus that was parked outside the club. As officers attempted to make an arrest, an officer was hit in the back of the head with a bottle causing a laceration. Arrests were made.

13. On 05/16/10 at 4:20 pm, Milwaukee police were dispatched to Sinai Hospital for a Battery complaint. Police spoke with the victim who stated on May 15th, she was at Onyx Night Club and had a verbal altercation inside the VIP area inside the club. The victim stated she left the club and was inside her auto when a group of females she had the altercation with approached her and started striking her with closed fists. The females then fled the area. The victim was treated for a laceration, which required 5 stitches to close. Attempts to speak with someone from the club were unsuccessful due to the fact the club was closed. A report was filed.

14. On 10/31/10 at 11:48 pm, Milwaukee police were on scene at 3120 W Villard, Onyx Night Club, for a large crowd. Additional units had to be called in due to the volume of people and cruisers that refused to leave the area. Numerous arguments and altercations occurred due to the large crowd.

15. On 12/17/10, Milwaukee police were monitoring an event being held at Onyx located at 3120 W Villard. While on scene, no violations were observed and no citations were issued.

16. On 11/05/11 at 12:25 am, Milwaukee police responded to 3120 W Villard to monitor the crowd and traffic control related to the business operation of Onyx. Five squads were present and one subject was arrested on warrants and was issued a citation for loitering.
17. On 11/13/11 at 1:44 am, Milwaukee police responded to 3120 W Villard Avenue for a Trouble with Subject complaint. Three squads responded and no citations or arrests were made.
18. On 11/22/11 at 7:18 pm, Milwaukee police conducted a License Premise check at 3120 W Villard Avenue. Police were aware that Onyx Nightclub has a weekly event know as, "Taco Tuesday" and that surrounding streets and parking lots are overflowing with vehicles. The district wanted to take a proactive approach to prevent any incidents from occurring. No violations were found.
19. On 11/24/11 at 1:20 am, Milwaukee police were at 3120 W Villard Avenue to monitor crowd and traffic control issues that may result from Onyx. There were a total of 10 squads that monitored closing. Due to the size of the crowd, it was necessary to have that many officers in order to disperse the crowd as quickly and safely as possible. Two subjects were arrested on outstanding warrants; one citation was issued for disorderly conduct. At 2:03 am, an officer was flagged down for a patron who was struck by an auto, injuries were not life threatening.
20. On 11/29/11 at 9:35 pm, Milwaukee police performed a License Premise Check at 3120 W Villard Avenue. Police were monitoring the club because of its "Taco Tuesday" special. A total of three squads were on scene for 4 hours. No incidents reported.
21. On 12/02/11 at 11:31 pm, Milwaukee police were dispatched to 3120 W Villard Avenue to monitor traffic and crowd controls at Club Onyx. At 1:38 am, officers were flagged down regarding a disorderly conduct investigation related to patrons of Onyx. No arrests or citations were issued for that incident.
22. On 12/04/11 at 1:51 am, Milwaukee police responded to a Battery complaint at 3120 W Villard Avenue, Club Onyx. Four squads were on scene and the caller stated that 10-15 people who were "put out" of the club were in the street being disorderly. No citations or arrests were made from this incident.
23. On 12/06/11 at 10:32 pm, Milwaukee police were on scene at 3120 W Villard Avenue monitoring the club because of its "Taco Tuesday" special. A total of four squads were on scene with some squads on scene for as long as 4 hours. No incidents reported.
24. On 12/13/11 at 9:09 pm, Milwaukee police were on scene at 3120 W Villard Avenue monitoring the club because of its "Taco Tuesday" special. A total of four squads were on scene with some squads on scene for as long as 2.5 hours. No incidents reported.

25. On 12/20/11 at 8:58 pm, Milwaukee police were on scene at 3120 W Villard Avenue monitoring the club because of its "Taco Tuesday" special. A total of seven squads were on scene with most squads remaining on scene for 35 minutes. No incidents reported.
26. On 12/20/11 at 8:58 pm, Milwaukee police were on scene at 3120 W Villard Avenue monitoring the club because of its "Taco Tuesday" special. At 1:58 am, gunshots were heard and a motor vehicle pursuit was initiated by one of the squads. At 2:02 am, it was confirmed that a 21-year-old female had been shot. Spent casings were located at 5151 N 31st Street. Police spoke with the victim who stated there was a physical fight between her and another female patron inside the club. The victim stated they were both thrown out of the club when the female and some of her friends attacked her outside the club. The victim then entered her car when the suspect and her friends used their cars to block the victim in. The victim stated she tried to escape when someone shot her in the leg. Both subjects were found to be 21 years of age and the club has an age restriction of 25 and older. A total of sixteen cars were needed for this investigation.
27. On 12/29/11, Captain Jerome O'Leary wrote a Licensed Premise Report in regards to numerous disturbances in and around the neighborhood it occupies. The following reads: The nightclub has been experiencing an increase in traffic and disturbances outside. These problems are being experienced not only by District Four, but also by District Seven, which shares Villard Avenue as a border with District Four. With the increase in problems around the nightclub, both Districts Four and Seven have had to increase the police personnel in the area of the nightclub. On the average Tuesday night, for Onyx's "Taco Tuesday", District Four deploys four officers and a supervisor to assist with controlling disturbances around the nightclub. On Friday nights, District Four deploys the same number of personnel to do the same. District Seven also deploys squads to the area on these nights to assist with the efforts of District Four. Due to this and the fact that there was a shooting related to the nightclub that involved a response of officers from Districts Four and Seven, Captain O'Leary and Captain Regina Howard called the nightclub owner into District Seven for a meeting to address these issues. Also present was Assistant City Attorney Robin Pederson. On Tuesday nights, the nightclub holds a special event, which draws a regular capacity filled crowd, which the owner informed Captain O'Leary that 80 to 90% of the crowd is under the age of 25. Mr. Obiora informed Captain O'Leary that he had to add extra security due to the increase in problems inside the club as well as outside. During the conversation, Assistant City Attorney Pederson informed Mr. Obi that his nightclub was not licensed to have patrons under the age of 25 during hours of operation unless by special permit. Mr. Obi stated that he knew this. When asked why was the nightclub disregarding the conditions of the license, there was no response from Mr. Obi. Mr. Obi was informed that police would ensure that the club complies with the conditions of the their license. The 25 and up age limit was granted and started in September of 2011, but the nightclub disregarded this provision from that date until this was brought to police departments attention on January 12, 2012. The nightclub advertised 21 and up for all of their events and allowed patrons under the age of 25 regularly, knowing they were not licensed to do so.

28. On 01/03/12 at 7:41 pm, Milwaukee police were on scene at 3120 W Villard Avenue monitoring the club because of its "Taco Tuesday" special. A total of five squads were on scene with the last squad clearing the area at 2:00 am. No incidents reported.
29. On 01/07/12 at 12:18 am, officers were ordered by Captain O'Leary to conduct a License Premise Check at 3120 W Villard. Two squads responded and upon entry, officers observed two bouncers at the front door of the club. Officers identified one security guard as Aaron Pass who was asked by officers if he was checking ID's prior to entry. Pass responded, "Yes we always do here". Pass was asked if all patrons were 25 and up because the bar is licensed as such, Pass stated, "No just 21 and older here". The officer asked how long Pass has been an employee for the club to which he replied, "For a little bit now". It was later found during the permit check that the tavern had a special party permit for this date, allowing patrons 21 and older allowed in the tavern. Police also observed a booth with a cash register where they were actively charging a ten-dollar cover to patrons. No sign was posted and Mr. Pass was advised that this was a violation and needed to be addressed and corrected as soon as possible. Officers also spoke with a woman, identified as Shely Hill, who stated she was the manager and that all bartenders' were working under her and her license. When officers asked her to provide her bartenders license, officers assumed that Hill went to retrieve it, but she never returned. Approximately 5 minutes later, the tavern owner Obiora Obi came to the bar with his jacket on and asked officers if there was anything they needed. When officers attempted to locate Hill, police asked Obi, where the bartender in charge was to which Obi responded he was the bartender in charge. When asked who was responsible for serving drinks when Obi was not on the premise, Obi responded he was always on the premise. When further asked why Hill stated she was the manager in charge, Obi stated she was mistaken and did not mean that because her bartender's license was expired. When asked where Hill was, Obi stated he didn't know. Officers found the tavern employees' to be uncooperative when speaking with police.
30. On 01/10/12 at 12:18 am, officers were ordered by Captain Jerome O'Leary to conduct a License Premise Check at 3120 W. Villard Avenue. As police entered, they observed the business charging a cover charge at the front door however the amount per individual was not posted in the entryway per city municipal code. This was the second incident when police observed the cover charge not being clearly posted. Officers found the club did have a special party permit for the night that allowed patrons 21 and older to be present. Officers spoke with Obiora Obi and advised him of the signage for the cover charge that has to be posted; any further violations would result in a citation.
31. On 02/04/12 at 11:48 pm, Milwaukee police conducted a License Premise Check at 3120 W. Villard Avenue. No violations were observed.

1. On 03/10/12 at 11:02 pm, Milwaukee police conducted a License Premise Check at 3120 W Villard Avenue. No violations were observed.
2. On 04/22/12 at 1:45 am, Milwaukee police conducted a License Premise Check at 3120 W Villard Avenue and observed no violations.
3. On 04/26/12 at 10:00 am, a meeting was held with police personnel from District Four, Alderman Hamilton and Obiora Obi to discuss concerns with the bar, Onyx. Obi asked for permission to use barricades to block off 31st and 32nd streets northbound about fifteen minutes before closing time. Captain O'Leary agreed to the use of barricades to help with traffic at closing. Captain Howard suggested attending block watch meetings in the area so Obi can address any concerns that the neighbors may have regarding his business. All parties were in agreement.
4. On 05/02/12 at 1:06 am, Milwaukee police conducted a License Premise Check at 3120 W Villard Avenue and no violations were observed.

5. On 06/23/12 at 1:27 am, Milwaukee police conducted a License Premise Check at 3120 W Villard Avenue and no violations were observed.

37. On 02/25/13 at 12:49 am, Milwaukee police were flagged down by security at the Onyx Social Club for 20 females fighting inside the club. More squads had to be called to help assist in breaking up the fight. A total of five females were cited for the following: four females were cited for disorderly conduct. Another female was cited for fail/obey traffic officer signal/order.

38. On 02/28/13 at 9:10 am, at the request of Obi Obiora, Obiora met with police personnel from District 4 to discuss how the fight incident was handled on 02/25/13. Discussed were future plans to work with MPD regarding any further incidents.

39. On 03/02/13 at 2:05 am, Milwaukee police were dispatched to 3120 W Villard Avenue for a Theft complaint. Police spoke to the victim who stated a known subject removed money from his pants pocket while inside the club and was refusing to return it. The theft complaint was ordered into the district attorneys office and was not processed by an ADA. Officer's also cited the victim for Assault & Battery and the suspect for Possession of Alcohol by Underage Person.

40. On 03/31/13 at 10:26 pm, Milwaukee police responded to an anonymous report of a fight at Onyx located at 3120 W Villard. Officers spoke with Obiora Obi who stated at 10:10 pm, there was a verbal argument between two females on the dance floor. The fight became physical and their friends separated the two females with security escorting all parties out of the club. Upon being escorted out, the females continued to verbally argue before getting into their vehicles and leaving the area.

41. On 04/05/13, Milwaukee police investigated a Shooting complaint that occurred outside of the Onyx Night Club. Investigation found two patrons who were leaving Onyx, were approached by two unknown males who began to fight them. Shots were fired shortly after striking victim # 1 in the right hand. Victim # 2 fled the location on foot and when he returned he advised victim #1 he was robbed of his necklace. The victim sought medical attention at a hospital in Racine for the wound to his hand.

42. On 04/15/13 at 12:30 am, Milwaukee police were dispatched to 3120 W Villard for a Fight complaint. Investigation revealed two patrons had an argument, which escalated and became physical. During the fight, one of the subjects was injured with an unknown weapon and sustained two puncture wounds to the chest area. Police viewed video surveillance, which showed the fight and security escorting both parties out of the club. Further viewing showed one of the subjects throwing an object into a garbage can located outside the club, a few feet from the main entrance door. Police checked the garbage can and recovered a small pocketknife with blood on it.
43. On 04/15/13 at 2:08 am, Milwaukee police, while investigating an active battery cutting complaint, recovered a small clear corner cut bag containing a white substance from the dance floor of the Club Onyx. The substance tested positive for heroin and was placed on police inventory as a no case.
44. On 04/26/13 at 1:45 pm, members from the Milwaukee Police Department, ACA Nicholas Desiato and Attorney Michael Guerin met with Obi Obiora to discuss the substantial battery that took place on 04/15/13 and the nuisance status of his establishment. Discussed were future plans to work with the police department regarding any further incidents. Measures that were put in place already for Onyx was an identification scanner for each person who enters the facility. Each male who enters the club has a pat down, with females being scanned with a wand. Obiora stated he has posted signs on the building regarding no weapons allowed inside the business. Also discussed were additional security guards for inside the club. Obiora also stated he rents the parking lot across the street for patrons to park. MPD made the following recommendations: Increase the use of the security wand. Change the age requirement to 25 years of age. Have more employees who are able to operate his security camera system. He was also advised to check on a month basis, calls for service as well as getting all incident reports from the Open Records Section. Obiora was also advised to notify both Districts Four and Seven of all special events prior to the event occurring.
45. On 04/29/13 at 1:36 am, Milwaukee police were monitoring the closing of Onyx Night Club when officers heard five gunshots east of the tavern. The crowd was uncooperative during the closing of club as patrons were exiting. Officers had to provide traffic control to disperse cars that were constantly driving around marked police squads. While officers were attempting to clear the area of traffic, a large fight of 15-20 patrons took place as the patrons left Onyx.
46. On 05/20/2013 at 1:50am, while conducting traffic control at 3120 W Villard Av (Onyx) an officer was flagged down by security. Security stated at approximately 12:45am, several security staff members approached a subject in the bar to ask him to leave due to violating the dress code. The subject started to argue with security and struck one of the security staff with an empty gray goose bottle causing it to break, which resulted in a 2-inch laceration over victims left eye that required stitches to close. The subject had the neck of the bottle still and began swinging the bottle at other security staff and struck another causing a 3-inch cut to left cheek. The subject made threats to come back and shoot up the place. While conducting traffic control security identified the subject involved who was subsequently arrested and taken to District #4 for Substantial Battery-Int Bodily Harm.

47. On 05/27/2013 at 12:22am, Milwaukee Police were dispatched to a tavern violation at 3120 W Villard Av (Onyx), which was called in by a citizen who was concerned over the large number of vehicles and people. Once on scene, security notified officers that they had to remove a patron for being disorderly and while the subject was asked to remove his ID card a small baggie of suspected marijuana was observed falling out of his pocket by security. The subject was arrested for Possession of Controlled Substance- Marijuana and the case is still open (set for jury trial on 11/12/2013). Squads were positioned to block traffic from traveling in front of the club as patrons leave and were also monitoring the Villard Food Town at 3127 W Villard Av, where a large number patrons began to gather after leaving Onyx. An anonymous citizen called the shift commander to let them know there may be a shooting in front of Onyx involving 4 occupants of a white, Ford Expedition. The shooting never happened.
48. On 06/17/2013, at approximately 12:00am, squads from Districts 4,7, and the NTF responded to area of 3120 W Villard Av, Onyx to assist with traffic control and to deter violent crime from occurring. While squads were on scene security informed officers that they had a suspect of a Substantial Battery detained that had occurred on 05/20/2013. Officers reviewed the video footage from 05/20/13 and identified the suspect being held as the individual that committed the substantial battery. The subject was arrested.
49. On 07/01/2013, Milwaukee Police were conducting a Tavern check at 3120 W Villard Av (Onyx) as well as monitoring the patrons leaving and traffic control. While conducting traffic control a possibly armed subject was observed in the 5100 block of N 32nd St breaking into vehicles, which were parked, in close proximity to Onyx. While squads were investigating three entries to auto complaints and saturating the area for the possibly armed subject there was a foot pursuit and subsequent arrest of the subject. Due to the investigations, there was not a sufficient amount of squads at Onyx to control the patrons who became disorderly and started fighting. Onyx security had broken up the fights and dispersed the patrons before anyone could be cited or arrested.
50. On Saturday, July 6, 2013 at approximately 2:15am, there was a squad assigned to monitor Onyx at 3120 W Villard Av, which was parked at 3133 W Villard Av. The officers heard a gunshot that was believed to have come from the front of Onyx. Security from Onyx advised officers, shots were fired and provided a description of the suspect. Officers were advised by armed security from Onyx that they had the suspect from the shooting detained at 3026 W Eggert Place. Officers responded to the location and placed the subject in custody and a .25 caliber semi-auto handgun was recovered. At 2:54am Officers were advised by dispatch that there was shooting victim at St Josephs Hospital. Officers responded to the hospital and discovered the victim of the shooting was an onyx security guard. The investigation revealed that while the security guard was trying to escort the subjects out of Onyx he heard a loud gunshot. He then felt pain and burning in his right thigh and realized he was shot. He was helped into the "chocolate room" inside of the bar, by the owner (OBI) and another security guard named "country". He asked if an ambulance was responding and another security guard said, "I'll take you". Officers asked the victim why police were not notified that he was shot and he stated he thought the police knew about him being shot or that the other security guards or the owner notified the police. The owner of Onyx as well as security failed to inform police of the shooting victim, who is employed by Onyx as security guard and that the victim was driven to the hospital by another security guard.

51. On 07/06/13, at 2:15am, while officers were investigating the shooting previously described in item 50, another set of officers was observing patrons leaving Onyx. The officers observed the right rear passenger of a blue, Ford Crown Victoria, discharge a semi-auto handgun out the window of the auto, in the area of 5150 North 32nd Street. The vehicle was stopped and the three occupants were arrested. A .45 caliber Taurus handgun and Black 12 gauge Maverick Mossberg shotgun were recovered. Officers also located several spent .45 caliber casings in the auto. During a custodial interview the suspect stated he and his two cousins were at onyx and at closing time, while walking to their auto they heard one or two gunshots. He further stated he was drunk so he urinated on the side of the building. Once he entered the auto, he fired the handgun into the air.

52. On 07/16/2013, a meeting was arranged to discuss outstanding issues at Onyx, 3120 W Villard Av due to the district's appearance to contest the license renewal on 07/09/2013 and to review course of action from 05/03/2013 for abatement of nuisance activities. District Four Captain introduced a video of the shooting incident that depicts non-compliance with wandings of patrons. OBI stated that when it is "to busy", patrons are wanded after entering the club inside a hallway in the only place where there is no camera. The Captain asked OBI to explain what had happened on July 6, 2013. OBI stated he heard a gunshot and observed one of his security guards sitting on a couch in the "Chocolate Room" with what he thought was a scratch and tiny hole with blood on the security guard's leg. He said he thought the security guard hit his leg on a railing. OBI said he wanted the hospital to assess the injury so another security guard transported victim to the hospital. OBI was asked why he did not summon the police on scene to make the assessment and he again said he wanted the hospital to assess the injury. The Captain stated they needed to contact "Mario"(the victim) regarding the on-going shooting investigation. A phone number was provided that was later found to be disconnected. The Captain asked OBI what crime control measures he would implement to prevent similar incidents that occurred on 07/06/2013. OBI was asked if he would consider amending his license to have 25 years of age and older restriction, however he stated it would negatively impact his customer base. The Captain also asked OBI to address the weekend traffic control issues. The Captain stated MPD expends an inordinate amount of resources on traffic control for his establishment, which is not provided to other establishments in the district. The Security Manager, Derrick Smith, for Onyx disagreed with the Captains assessment because he has the largest number of security assigned to Onyx. He said he deploys teams of security guards to the Food Town parking lot as well as the parking lot located at 5150 N 32nd St and that security directs traffic. The Assistant City Attorney reviewed the crime for Onyx and during the period of 01/01/2013 to 07/10/2013 there were 12 incidents reported which was double the calendar year of 2012. In addition, for Class B establishments in the district, Onyx reported the highest crime and dispatched calls for service (82) in 2013, compared to (53) in 2012. OBI questioned the crime numbers and stated neither him or security was calling the police. OBI stated head of security is responsible for assessing the incidents and the need to call the police.

53. On 07/19/2013, Milwaukee Police personnel from District Four conducted an undercover investigation at 3120 W Villard Av, Onyx. Two officers attended the club as regular patrons to observe the methods of security, functionality of the club, and any suspicious or illegal activity. Officers entered the establishment and were patted down and only male officer was wanded with a hand held metal detector.

54. On 07/20/2013, Milwaukee Police were instructed to conduct a tavern check at 3120 W Villard Av, Onyx, and to monitor the patrons leaving as well as conduct traffic control. During the walk through of the interior the owner (OBI) was observed and an official count as of 12:30am from the front door was 324 people. There was also a line of about 10 people waiting to enter the club because of a special event called "Reloaded." Observed outside the area around club were vehicles parked on W Villard Av from N Teutonia to approximately N 33rd St as well as the parking lot of Villard Food Town at 3217 W Villard Avenue.
55. On 07/21/2013, Milwaukee Police personnel from District Four conducted an undercover investigation at 3120 W Villard Av, Onyx. Two officers attended the club as regular patrons to observe the methods of security, functionality of the club, and any suspicious or illegal activity. The officers entered the establishment where they were patted down and wanded with a hand held metal detector. Officers observed two females enter the establishment without being searched or wanded. The two females then went to the bar and were served drinks.
56. On 07/22/2013, Milwaukee Police were instructed to conduct a tavern check at 3120 W Villard Av, Onyx, and to monitor the patrons leaving as well as conduct traffic control. During the walk through of the interior the owner (OBI) was observed and an official count as of 12:32am from the front door was 315 people. No one was waiting outside even though an event called "Red Zone Sunday" was being held. Observed outside the area around club were vehicles parked on W Villard Av from N Teutonia to approximately N 33rd St as well as the parking lot of Villard Food Town at 3217 W Villard Avenue.
57. On 07/29/2013, Milwaukee Police were instructed to conduct a tavern check at 3120 W Villard Av, Onyx, and to monitor the patrons leaving as well as conduct traffic control for the "Red Zone Sunday" event. During the walk through of the interior the owner (OBI) was observed and an official count as of 12:31am from the front door was 402 people. Observed outside the area around club were vehicles parked on W Villard Av from N Teutonia to approximately N 33rd St as well as the parking lot of Villard Food Town at 3217 W Villard Avenue. It was observed that security was having a difficult time initially at closing time with patrons near the front exit.
58. On 08/12/2013, Milwaukee Police were instructed to monitor the patrons and traffic around the area of 3120 W Villard Av, Onyx, due to the weekly "Red Zone Sunday" event. Numerous vehicles were observed traveling westbound on W Villard Av in front of the club had stopped to let subjects out of their vehicles so they could get in line for the club. Officers were flagged down by patron who said his vehicle was rear ended when letting a passenger out to go stand in line.
While completing the traffic accident, a large crowd of patrons began letting out because of bar close and dispatch advised there were females physically fighting outside Onyx. Due to the crowd officers did not observe the fight because they were attempting to set up traffic control at 3300 block of W Villard Av to block eastbound travel. Shortly after, dispatch notified officers of an anonymous caller reporting a "riot going on in the street" involving approximately 150 people. Additional squads were requested to assist with the crowd of patrons and traffic. Due to the volume of traffic an ambulance, which was responding to the area of Onyx for a possible battery victim, was delayed because of the extreme difficulty in maneuvering through-stopped traffic.

At 3:30am, a squad was dispatched to a Battery complaint at Froedtert Hospital. The investigation revealed that the victim was at Onyx and at approximately 1:00am she was involved in an altercation inside the club with, someone she had dated in the past. The suspect pulled her to the ground by her hair. This incident was observed by security and both subjects were ejected. After exiting the club they began to physically fight each other. While victim was trying to run away one of her shoes fell off and the suspect picked it up and struck the victim to the left side of her face, causing visible swelling. This part of the incident happened in the parking lot across the street from Onyx. The suspect was not located and mailed a citation.

On 08/14/2013, officers went to 3120 W Villard Av, Onyx, to speak with the owner (OBI) regarding the incident, which occurred on 08/12/2013. OBI informed officers that he was unaware of it. OBI did say he was aware of the fight in the Villard Food Town parking lot. OBI also said if there is any fighting in the club, his security knows to eject the parties one at a time so the fight does not continue outside.

59. On 08/26/2013 at 12:11am, officers were dispatched to a Battery complaint at 3120 W Villard Av, Onyx. Officers contacted the caller, Gabrel Bledsoe who stated on 08/25/2013, at approximately 11:50pm, while on the main dance floor, she observed an Onyx security officer escorting an extremely intoxicated and staggering patron from the main dance floor to the hallway by the bathroom's. She heard security yell for the subject to calm down just prior to picking up the subject and "dropped him on his head." She gave a description of the subject and said he was unconscious for about 90 seconds. Then security escorted him to a couch by the main entrance. The subject was yelling, "who hit me" and security replied, "you got knocked out" and was escorted out of the club by his associates. She described the security involved as an "extremely large black male."

Another witness, Lucretia Workman, stated she observed a large security officer "slamming" a subject on the floor. She observed the subject was unconscious with a laceration to his nose. After the subject regained consciousness security escorted him to a couch and attempted to give him water. She advised security not to give the subject water due to possible concussion-like symptoms and moments later the subject left with associates.

Officers interviewed the security manager, Derrick SMITH, who stated he was not present during the incident. SMITH said as he approached the hallway he observed security officer Paul JONES escorting a very intoxicated and staggering patron to the couch and prior to reaching the couch observed the subject fall again due to his intoxication level. SMITH and JONES escorted the patron to the couch while trying to converse with the patron and giving him water. WORKMAN and BLEDSOE continued to agitate the patron by stating "they did this to you," and "I'm a nurse (WORKMAN) don't give him water." SMITH then escorted the patron to a secured area of the club. SMITH stated the patron advised him that he had "pint of vodka" and a "bottle of Remy" prior to be escorted by security and was apologetic for his actions.

Security officer JONES stated he observed a patron turning his hat backwards and throwing money on the stage. JONES stated both are direct violation of Onyx policies. JONES confronted the patron who became argumentative. JONES stated he grabbed the patron's right arm and attempted to escort him out of the club. After a brief struggle the patron was let go and fell to the ground at which time JONES placed his knee on the subjects chest to gain compliance.

JONES stated at this time other security personnel escorted the patron away from the scene and was unaware the subject had gone unconscious. Other security personnel interviewed, stated JONES never struck the patron and he lost consciousness after JONES let him go and he fell to the ground.

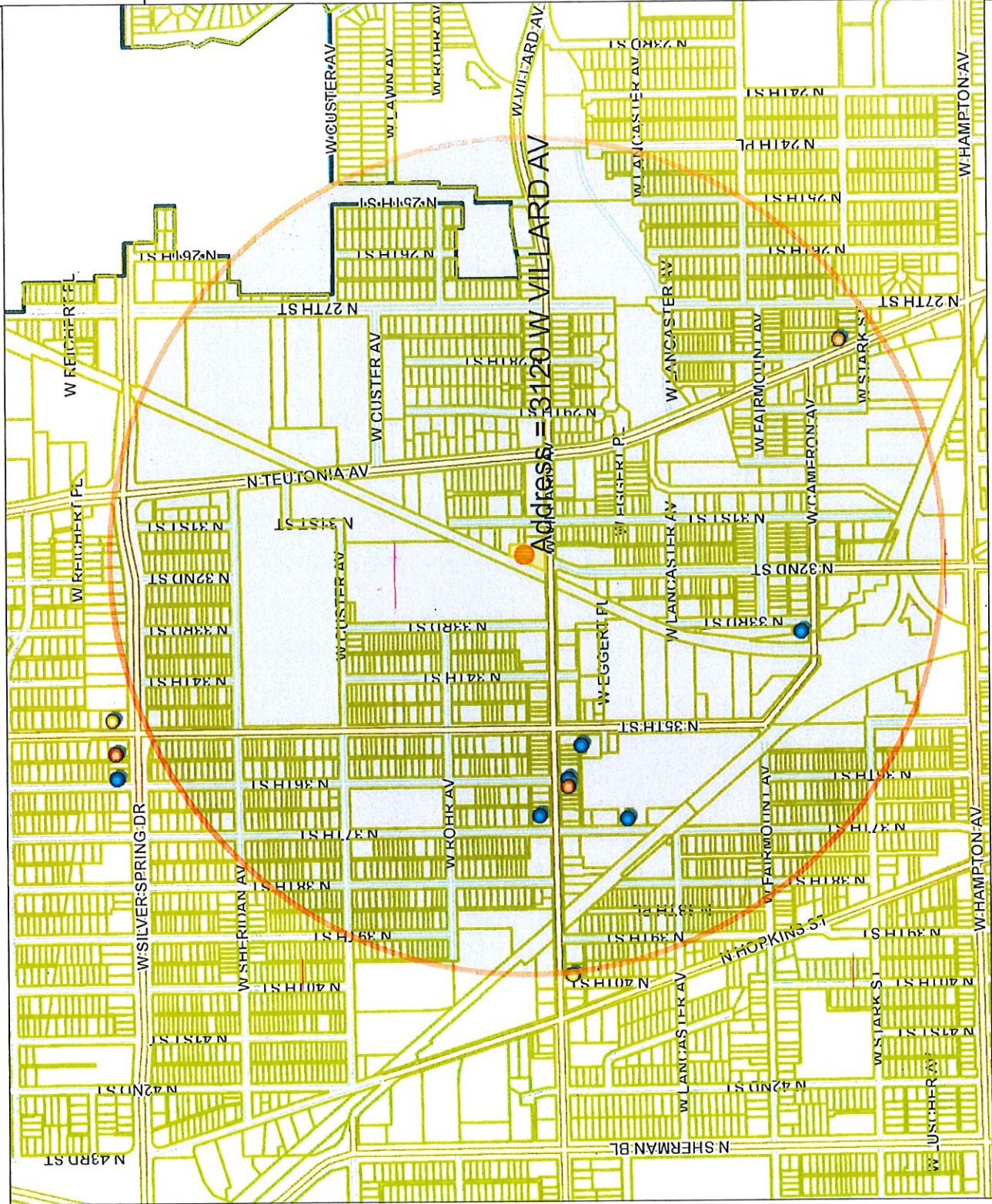
Officers interviewed the subject, Landrous Cox at St Josephs Hospital, in emergency room 18. COX immediately stated he did not call police and did not request to speak with them. Cox's physical description and injury to his nose was consistent with WORKMAN'S observations of the patron inside Onyx. COX to decline to give any specifics as to how he obtained his injuries.

60. On 08/26/2013 at 12:20am, officers were instructed to monitor the patrons and traffic around the area of 3120 W Villard Av, Onyx. Officers observed a subject being loud, boisterous, and disrespectful towards female patrons exiting the club. The disorderly subject was identified as (WEST) who was given an order to leave the premises to prevent further harassment of female patrons. WEST became verbally abusive towards officers by yelling profanities. During the altercation with WEST Onyx Security Manager SMITH advised that WEST was no longer welcome as a patron from July 2013 because of his continuously verbal abuse towards his staff and patron for several months. WEST was arrested for Loitering and/or Prowling citation and conveyed to District 4 for processing.
61. On Tuesday, August 27, 2013, a meeting was held at District Four at the request of Club Onyx owner Obiora Obi, with Captain Beecher, Lieutenant Seymer-Tabaska, Onyx Security Manager Derrick Smith and Mr. Obi's brother in attendance. Mr. Obi questioned why officers had gone to his establishment and requested a list of employees. Captain Beecher advised there was still an ongoing investigation being conducted. Captain Beecher discussed the security at the establishment and whether Mr. Smith was licensed. At a previous meeting Mr. Smith presented a card for Wisconsin Security Police Services Inc. During this meeting Mr. Smith stated he is an independent contractor and not affiliated with any security companies. It was discussed that there is no formal contract with Mr. Smith and Onyx or with Delta Ops who provides external security. It was determined that Mr. Smith is operating without a license, which is in violation of Stat Statue 440.26. It was also discussed that Mr. Obi stated that Mr. Smith carries a Taser while working. Mr. Smith is felon and there is concern with him carrying a Taser and being around the Delta Ops securities, who are armed.
62. On 09/02/2013 at approximately 1:30am patrons from Onyx Social Club (3120 West Villard Avenue) began to exit the business following a "Red Zone Sunday" event. Numerous fights broke out in the street in front of the business requiring the attention of security from the club as well as numerous Milwaukee police squads. During this altercation, at least one battery occurred as well as a state resisting arrest charge resulting from the injury to one Milwaukee police officer. A total of 34 police officers and 5 Sergeants were utilized during this incident. Milwaukee police incident report #132450010, 132450011 and 132450015 were filed.
