Enclosed is a sworn written complaint from Police Chief Arthur Jones regarding 8614 North 107 Street. Chief Jones has objected to the renewal of this operator's 2002-03 license. Because the objection was filed too late to notify the operator prior to license renewal, this request is being forwarded as a revocation request. The Food Dealer License at this location is held by Vinza, Inc. and, upon payment of the license fees, is valid July 1, 2002 to June 30, 2003. The operator has until August 30, 2002 to pay for his license without being considered late.

Please schedule a hearing to consider this matter before the Utilities and Licenses Committee pursuant to MCO Chapter 68-4 (15).

I wish to bring to your attention the following information concerning the above indicated premises, which is licensed as a food dealer to Vinza Corporation with Ann Marie Balsamo as the registered agent.

In April 2002 information was received by the Vice Control Division of the Milwaukee Police Department that cocaine was being sold from the restaurant by members of the family that operate the restaurant. An undercover investigation was initiated. Between May 22 and June 19, 2002, four controlled buys of cocaine in the amounts of two and four grams from a family member took place at the restaurant. Investigation revealed that arrangements to buy the cocaine was made with a family member at the restaurant and delivery of the cocaine was made at the restaurant after a family member contacted a known individual who then delivered the cocaine to the restaurant where the money was exchanged.

During a controlled buy of cocaine on May 29, 2002, a family member asked the registered agent if the cocaine was of good quality and she replied that it was. During a controlled buy on June 19, 2002, the registered agent allegedly reported to an undercover officer during a conversation that an individual was bringing the cocaine to the restaurant and that this individual "was careful and had good stuff" (meaning the cocaine). Ann Marie Balsamo during the course of the investigation reportedly made statements that indicate her knowledge that the drug dealing was taking place at the restaurant. The investigation culminated in the arrest of a family member and three other individuals for Conspiracy to Distribute Cocaine.

Your office informs this Department that the food dealer's license for these premises expired June 30, 2002. Based upon the above indicated information, I object to the renewal of the food dealer's license.
