Common Council File 060580 contains the following recommendations:

Recommendation of renewal, with a 10-day suspension based on the police report, of the Class "A" Malt license of Mohammad El-Hassan, Agent for "Krayem, Inc." for the premises at 416 E. North Ave. ("Quick Stop Foods") in the 6<sup>th</sup> aldermanic district.

Recommendation of renewal, with a 60-day suspension based on the police report, of the Class "B" Tavern and Tavern Dance license of Karen Hubbard, Agent for "Hubbard & Associates NA, Inc.", for the premises at 7330 N. 76<sup>th</sup> St. ("Karen's Club") in the 9<sup>th</sup> aldermanic district. (Committee vote: Ayes: 3, Noes: 2)

Recommendation of renewal of the Class "B" Tavern license with a 20-day suspension and non-renewal of the Tavern Dance license, based on the police report and neighborhood objections, of the licenses of Juan Sendejo, Sr. for the premises at 2325 S. 13<sup>th</sup> St. ("Johnny's Yellow" Rose") in the 12<sup>th</sup> aldermanic district. (Committee vote: Ayes: 4, Noes: 1)

Recommendation of renewal of the Class "B" Tavern license with a 60-day suspension and non-renewal of the Tavern Amusement (Cabaret/Nite Club) license, based on the police report, of the partnership licenses of Leonie and Ricardo McKenzie for the premises at 2035 W. Fond du Lac Ave. ("Leoric Sport Club Bar & Grill") in the 15<sup>th</sup> aldermanic district.

With regard to the file listed above, the Licenses Committee held an evidentiary hearing on October 3rd, 2006.

Pursuant to section 90-11, Milwaukee Code of Ordinances, and section 125.12(12), Wis. Stats., the Committee is transmitting a copy of its Report and Recommendations, regarding the above matters to your Honorable Body.

Re: Report of the Renewal Application of the Mohammad I. El-Hassan, as agent for "Krayem, Inc." for a Class "A" Malt license for the premises located at 416 East North Avenue in the City and County of Milwaukee, Wisconsin ("Quick Stop Foods").

- 1. Mohammad I. El-Hassan, as agent for "Krayem, Inc." (hereinafter the "Licensee") is the agent for "Krayem, Inc." doing business at 416 East North Avenue in the City and County of Milwaukee, Wisconsin ("Quick Stop Foods"). Said license expires at midnight, November 11, 2006.
- 2. An application to renew said license was filed with the Office of the City Clerk on September 12, 2006.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report that could form the basis of non-renewal or suspension of this license dated September 13, 2006. There were also neighborhood objections to loitering, littering, parking and traffic problems, drug and criminal activity, failure to maintain the property in compliance with municipal ordinances, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On September 19, 2006, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for suspension or non-renewal of the licenses of the Licensee. The matter was scheduled on the police report for a hearing on October 3, 2006 at 8:45 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee did appear and was not represented by counsel.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On December 2, 1999 the applicant was arrested for battery and disorderly conduct. The applicant was found guilty of battery (misdemeanor) on February 16, 2000 and the charge was amended to disorderly conduct (forfeiture) in circuit court. The applicant was found guilty of disorderly conduct (misdemeanor) on February 16, 2000 and fined \$200 and 60 days in the House of Corrections, and 9 months probation.
  - B. On January 1, 2003 at 3:18 p.m. officers of the Milwaukee Police Department responded to the licensed premises at 416 East North Avenue, Milwaukee, Wisconsin ("Quick Stop Foods") regarding trouble with a customer. The investigation revealed that a customer had been causing trouble and was kicked out of the store. The customer, however, states that he was battered by a store employee. When officers tried to check the store video tape, the machine had run out of tape and the incident was not recorded. The applicant was convicted of disorderly conduct on March 26, 2003. The applicant was cited for convenience store security camera required and found guilty on February 27, 2003 and fined \$165.00.
  - C. On March 14, 2003 at 4:30 p.m. a 20-year old police aide under the direction of City of Milwaukee police officers, purchased a 12-pack of beer from a clerk at the licensed premises at 416 East North Avenue ("Quick Stop Foods"). The clerk, Mustafa Mounir, was charged with sale to underage on May 8, 200e and fined \$100.00. The applicant was not cited.
  - D. On April 16, 2005 at 6:45 p.m., the applicant was cited for sale of alcohol to underage person at the licensed premises at 416 East North Avenue ("Quick Stop Foods").
  - E. On April 8, 2006 the applicant sold a tobacco product to an underage person at the licensed premises at 416 East North Avenue ("Quick Stop Foods"). Mohammad I. El-Hassan received a citation for sale of tobacco product to a minor.
  - F. In the years 2001, 2004 and 2005 this licensee was renewed with a warning letter for this premise. This licensee was first granted a Class "A" Malt license for this premise in 2002.
  - G. No neighbors appeared to testify as to the neighborhood objections.

## CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Mohammad I. El-Hassan, as agent for "Krayem, Inc." at 416 East North Avenue has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "A" Malt license without undergoing a ten (10) day suspension based upon the police report.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "A" Malt license of Mohammad I. El-Hassan, as agent for "Krayem, Inc." for this premises located at 416 East North Avenue ("Quick Stop Foods") with a ten (10) day suspension.

# RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "A" Malt license held by Mohammed I. El-Hassan as agent for "Krayem, Inc." be renewed with a ten (10) day suspension.

Said suspension is to be in effect between 12:01 a.m. November 12, 2006 and midnight November 21, 2006.

Re: Report of the Renewal Application for a Class "B" Tavern and Tavern Dance license of Karen D. Hubbard, agent for Hubbard & Associates NA, Inc." ("Karen's Club") at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin.

- 1. Karen D. Hubbard, agent for Hubbard & Associates NA, Inc. (hereinafter the "Licensee") doing business at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club"). Said license expires at midnight, October 18, 2006.
- 2. The renewal application was mailed to the licensee before July 14, 2006. An application to renew said license was untimely filed with the Office of the City Clerk on September 5, 2006.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated September 6, 2006, which could form the basis for non-renewal or suspension of the license. There were also neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, public urination, trespassing, fights, shootings, drug and criminal activity, and conduct detrimental to the public health, safety and welfare.
- 4. On September 21, 2006, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of police report that could form the basis for suspension or non-renewal of the license of the Licensee and the neighborhood objections. A copy of the police report was included with the notice. The matter was scheduled for a hearing on the police report and

neighborhood objections on October 3, 2006 at 9:15 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the notice and police report. The licensee was not represented by counsel.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - On June 1, 2001 officers of the Milwaukee police department responded to A. back up other officers at a large crowd outside of the licensed premises at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club"). As officers arrived on the scene, they observed shots being fired from the parking lot. Additional officers responded, including the Tactical Enforcement Unit. The applicant related to the officers that she had rented the party room to an unknown person for a "Jam for Peace-After Set" and that no alcohol was served. She also related that this was an underage event and anyone under the age of 21 was to have left by 11:00 p.m. There was no notification of this underage event to the police department as required by state law and local ordinances. The applicant was cited for presence of an underage person. However, that citation was not issued by the City Attorney's Office. The City Attorney's Office did, however, issue a citation for disorderly conduct which was dismissed by the Municipal Court. An incident report was filed.
  - B. On October 29, 2001 at 2:07 a.m. officers of the Milwaukee police department were dispatched to the licensed premises at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club") to investigate a fight. Upon their arrival, there were approximately 100 people in the parking lot engaging in loud and disruptive behavior. Several subjects were observed fighting in the parking lot. While attempting to clear the parking lot, officers came across a subject lying unconscious on the ground. That subject was an apparent victim of a battery. Two subjects who identified themselves as brothers of the victim intentionally interfered with the investigation. They were asked to back away from the scene but became belligerent. One had to be decentralized and taken into custody. Another person attempted to pull him away from police, and was also taken into custody.
  - C. On August 17, 2002, officers of the Milwaukee police department were dispatched to meet a supervisor regarding a premises check at the licensed premises at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club"). Upon arrival, they found six operating amusement machines being operated without licenses posted. Also, the Class "B" tavern license was not posted in the room where alcohol was being served. The licensee told officers that she had posted the Class "B" license but it kept falling down so she placed it in the office. The

licensee was cited for Class "B" license to be posted and it was dismissed on December 20, 2002 without prejudice. The licensee was cited for amusement game license not posted and on December 20, 2002 was found guilty and fined \$400.00.

- D. On May 8, 2004 at 1:49 a.m., officers of the Milwaukee police department were dispatched to a shooting at the licensed premises at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club"). The licensee was on the premises and stated that she called the police because of a fight in the tavern. Approximately five females were involved in the fight. Initially, the licensee denied calling in the shooting. Police learned that there was a large fight involving many people in the tavern and that two females had left the tavern. However, they returned to the tavern and were bleeding and claimed they had been shot in the parking lot. The licensee, her son, a security person and a bartender denied hearing gunfire, but were reluctant to provide police with information regarding what had occurred. The victims had bullet fragments in their hands and back. The victims stated that there was a party at "Karen's Club" when a fight broke out between approximately 30-40 people. The security people pushed everyone out and someone fired shots into the crowds.
- E. On August 27, 2004, City of Milwaukee police officers were sent to a shooting at the licensed premises at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club"). They found security personnel crowding around a car in the parking lot. The victim of the shooting was in the car and was pronounced dead. Witnesses stated that the victim was shot while in the car, in the parking lot. Several of the security personnel left the scene and were uncooperative. This incident was considered by the Licenses Committee on September 28, 2005.
- F. On September 19, 2005 at 1:54 a.m., City of Milwaukee police officers were dispatched to 7330 North 76<sup>th</sup> Street for a shooting complaint. Officers spoke with a security guard, identified as Johnathan Manyfield, who was on duty and stated he was located at the entrance of the door when he heard one gun shot and told everyone to get inside. Manyfield had everyone back away from the door and heard nothing further due to the music playing in the club. Manyfield further stated the next time he went to the door is when police arrived on the scene. Officers also spoke with Karen Hubbard, the licensee, who stated the club was closed for a private party. The investigation revealed that a subject, who was in the parking lot of Karen's Night Club, was shot. Officers separated and interviewed witnesses who all stated they did not know the subject who was shot, nor did they know who he was with. The gunshot victim was identified as James Teague. The Criminal Investigation Bureau

- responded and filed a report regarding this incident. This incident was not considered for the 2005 renewal.
- On May 20, 2006 at 2:05 a.m., officers of the Milwaukee Police G. Department were dispatched to 76th Street and Good Hope Road for a shots fired complaint. Investigation revealed that 50-75 people were fighting in the parking lot and, as police arrived, began to flee. Officers were checking the parking lot for any evidence of shots fired or injured persons when other patrons from the licensed premises at 7330 North 76th Street ("Karen's Club") who were leaving told police that there had been a large fight in the parking lot, but they didn't know what it was over or who was involved. Officers checked inside the rear bar/banquet hall, where there were numerous people inside. No one appeared to be injured or in need of medical assistance. Patrons inside denied there was a fight. Other officers who were responding, were flagged down by a bouncer who stated there was a subject that had just been beaten up. Officers were led to the basement of the banquet room where they found a subject, identified as Cleotis Tuggles lying on the floor with what appeared to be a stab wound to the center of his chest. Tuggles also was bleeding from his face and had swelling as well. Conflicting and uncooperative witnesses hindered this investigation. Many patrons claimed there were no gunshots. Due to the lack of police help on scene, police were unable to detain anyone for further questioning that may have provided more information. Tuggles received medical treatment at an area hospital. A report was filed by the Criminal Investigation Bureau.
- H. On May 28, 2006 at 11:19 p.m., officers of the Milwaukee Police Department conducted a tavern check at the licensed premises at 7330 North 76<sup>th</sup> Street ("Karen's Club"). Upon arrival of the officers, several guests from a birthday party were leaving the premises. Guests had come from the back room, which was separated from the bar. Officers spoke with Karen Hubbard, the licensee, who stated her 19 year old daughter had a birthday party and that no alcohol was served. Officers found at least 30 bottles of beer in a cooler in the room the party was held in. Officers advised Hubbard that, per city ordinance, no alcohol should be in the room where minors are present.
- I. The prior record of this premises reveals that it was renewed with a 10-day suspension of the Class "B" Tavern license and a 30-day suspension of the Tavern Dance license in 2004 and renewed in 2001 and 2002 with a warning.

# **CONCLUSIONS OF LAW**

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council

pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.

- 2. Based upon the above facts found, the Committee concludes that the licensee Karen D. Hubbard as agent for Hubbard & Associates NA, Inc. d/b/a Karen's Club at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of her Class "B" Tavern and Tavern Dance license without undergoing a sixty (60) day suspension of said license.
- 4. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to renew the Class "B" Tavern and Tavern Dance license held by Karen D. Hubbard as agent for Hubbard & Associates NA, Inc. at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club") with a sixty (60) day suspension.

### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) noes recommends that the Class "B" Tavern and Tavern Dance license held by Karen D. Hubbard as agent for Hubbard & Associates NA, Inc. at 7330 North 76<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Karen's Club") be renewed with a sixty (60) day suspension.

Said suspension shall be in effect from the time of the Common Council action on October 24, 2006 through midnight, December 22, 2006.

Report on the Renewal Application of the Class "B" Tavern and Tavern Dance License of Juan J. Sendejo, Sr., for the premises located at 2325 South 13<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Johnny's Yellow Rose").

- 1. Juan J. Sendejo, Sr. (hereinafter "the Licensee") is the holder of a Class "B" Tavern and Tavern Dance License for the premises located at 2325 South 13<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Johnny's Yellow Rose"). Said license expires at midnight on November 3, 2006.
- 2. An application to renew said license was filed with the Office of the City Clerk on September 1, 2006.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 6, 2006, the Milwaukee Police Department responded with a report that could from the basis for suspension or renewal of said license. There were also neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, public urination, trespassing, fights, shootings, drug and criminal activity, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On September 21, 2006 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department report and neighborhood objections and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on October 3, 2006, commencing at 9:15 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the notice and was represented by Attorney Peter Donohue, 610 South 5<sup>th</sup> Street, Milwaukee, Wisconsin 53204.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. On January 10, 1998 at approximately 11:00 p.m. Milwaukee police officers responded to a shooting at the licensed premises at 2325 South 13<sup>th</sup> Street ("Johnny's Yellow Rose"). The investigation revealed that David Cherry (d.o.b. 12/19/76) was attending a birthday party at the location when he saw a window break and heard six gunshots. Mr. Cherry then noticed that he had been shot. Mr. Cherry stated that he did not see the shooter but stated that he knew it was a member of the Mexican Posse Street gang. A 17-year old witness stated that the suspect came into the hallway entrance with several other individuals, and at that point thought they were gong to end up fighting. The 17-year old stated to a suspect "If we're gong to fight let's just fight and get it over with." At that time the suspect stated "MP-C-14 Killers" and pulled out a pistol, pointed the gun in his direction and fired 2 or 3 times. The bullets struck Mr. Cherry. The suspect was identified and a warrant was issued for his arrest. The suspect turned himself in to police.
- On August 13, 2005 at 11:15 p.m. officers of the Milwaukee Police Department В. observed a large crowd in front of the licensed premises at 2325 South 13th Street ("Johnny's Yellow Rose") and began to conduct a tavern check of the tavern. Officers spoke to Leonel Valencia (white male, d.o.b. 5/26/71), who stated he had rented the hall fro the licensee, Juan Sendejo. Mr. Valencia stated he was told that he could sell 400 tickets to enter the hall. The capacity for the hall was 240. Officers observed that the occupants appeared to be under 240, however, noticed that some of the patrons appeared to be underage. Officers were able to talk to the licensee, Juan Sendejo, who was bartending at his other tavern on South Kinnickinnic. Mr. Sendejo stated that neither he nor the company who rented the hall has a permit for an underage party. Mr. Sendejo stated he would meet the officers back at the licensed premises ("Johnny's Yellow Rose"). Mr. Sendejo then ordered everyone who was under the age of 21 out of the dance hall. The rest of the patrons were asked to leave the hall and reenter with a valid ID which caused many patrons to become angry. One woman identified as Ventura Nungaray (white female, d.o.b. 5/12/77) was yelling to the crowd "Don't leave until they give us our money back!" This kept the crowd from dispersing and made the crowd hard to manage. More squads were called in for crowd control. With additional units, the crowd became manageable, and the hall was shut down for safety reasons. Mr. Sendejo was cooperative with all police requests. A citation for disorderly conduct was issued to Ventura Nungaray.
- C. This premises was renewed with warning letters to the licensee in 2002, 2004, and 2005.
- D. Objecting neighbors complained to the Licenses Committee of numerous disturbances from noise and litter at this location, parking problems, gang activity, and fights attributable to patrons of this premises, particularly at closing time.

E. Particularly telling was a contemporaneous record kept by one neighbor, Mr. Arnold Ode, which demonstrated the issues regarding this premises for the year of 2006. That record demonstrates that Mr. Ode observed the following disturbances during the year 2006 alone:

F. Of concern to the Committee was the claim of the licensee and his supporters that a refuse dumpster had been stolen and not replaced because of an apparent dispute between the licensee and the commercial refuse company regarding liability for the stolen dumpster. Pictures submitted by the objectors and taken by one of the objectors reveal that the dumpster was not in any way secured, and that after its theft plastic refuse bags were merely laid outside of the premises. They leaked, smelled, created an infestation of vermin and flies. Liquid matter was picked up by automotive tires and driven throughout the neighborhood. Section 79-3-4 of the Milwaukee code of Ordinances provides in relevant portion:

#### 4. FOR COMMERCIAL AREAS.

a. Receptacles to be Secured. The owners or operators of shopping centers, commercial or business establishments are to secure all of their solid waste receptacles not meant for public or their patrons' use and which are located on their premises but outside of any building. If such solid waste receptacles are not secured, the owners or operators of such shopping centers, commercial or business establishments shall provide enclosures constructed so as to prevent ready access to such receptacles. Such enclosures located on the property shall further be constructed so that they shall provide a compatible and practical arrangement on the premises and surrounding area. b. Large Appliances to be Enclosed. Owners or operators of business and commercial establishments storing large appliances such as refrigerators, stoves, washing machines and other similar items outside of the building structure, shall provide enclosures of the area wherein such items are stored in the same manner and as provided in par a.

c. Definitions. For the purpose of subs. 3 and 4, the following

terms therein are defined as follows:

- c-1. "Approved waste receptacles" shall mean those as provided and defined in s. 79-4.
- c-2. "Secure" shall mean to be locked or closed in such a manner so as to prevent ready access to contents thereof.
- c-3. "Shopping center" shall mean a group of commercial establishments planned and developed generally as a unit with off street parking facilities provided on the property for patrons of said establishments.
- G. It is clear that the activities regarding the illegal parking of cars, accumulating garbage bags causing the infestation of vermin, and amplified and loud music relate directly to the activities allowed by the tavern dance license, in addition to the Class "B" Tavern license.

## CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Juan J. Sendejo, Sr. has not met the criteria to allow renewal of his Class "B" Tavern license without undergoing a twenty (20) day suspension of the Class "B" Tavern license, held by him, and nonrenewal of the Tavern Dance license held by him. The Licenses Committee of the Milwaukee Common Council finds the police report and neighborhood objections as stated above to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a twenty (20) day suspension of the Class "B" Tavern license and nonrenewal of the Tavern Dance license of Juan J. Sendejo, Sr. for the premises located at 2325 South 13<sup>th</sup> Street in the City and County of Milwaukee, Wisconsin ("Johnny's Yellow Rose") based upon a police report and neighborhood objections.

## RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) nayes, and one (1) excused recommends that the Class "B" Tavern license be renewed with a twenty (20) day suspension and that the Tavern Dance license held by the licensee not be renewed.

Said suspension of the Class "B" Tavern license is to be in effect from midnight November 4, 2006 through 12:01 a.m. November 23, 2006.

Re: Report of the Renewal Application of Leonie A. McKenzie and Ricardo D. McKenzie for a Class "B' Tavern and Tavern Amusement (Cabaret/Nite Club) partnership license for the premises located at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill").

- 1. Leonie A. McKenzie and Ricardo D. McKenzie (hereinafter the "Licensees") are the holders of a Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) partnership license for the premises at 2035 West Fond du Lace Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill"). Said license expires at midnight, November 25, 2006.
- 2. An application to renew said license was filed with the Office of the City Clerk on September 1, 2004.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee police responded on September 6, 2006 with a report which could form a basis for non-renewal or suspension of the license. There were also neighborhood objections to loitering, littering, drug and criminal activity, shootings and fights, cruising, excessive use of police resources, loud music and noise, presence of underage, over capacity, disorderly premises, allowing patrons to leave the premises with open intoxicants, and conduct which is detrimental to the health, safety and welfare of the neighborhood.
- 4. On September 21, 2005, the City Clerk's Office provided timely notice to the Licensees, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee police report, and neighborhood objections, and included a copy of the Milwaukee police report. The matter was scheduled for a hearing on the police report and neighborhood objections on October 3, 2006 at 10:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensees did

appear and admitted receipt of the notice and were represented by Attorney James H. Hall, Jr., 324 East Wisconsin Avenue, Suite 1200, Milwaukee, WI 53202.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On March 27, 2004 at 1:15 a.m. officers of the Milwaukee Police Department were flagged down by two females at the location of 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin. The females stated there was a male inside the tavern who was "bleeding to death." Inside the licensed premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill") officers observed broken bottles and glasses on the floor, trails of blood, overturned tables and chairs; broken pool cues and bloodied pool balls. Lying on the dance floor was a male bleeding heavily from deep lacerations about the head. Ricardo McKenzie called 911 to report the incident. At a birthday party the victim had been attacked by 25-30 patrons when he attempted to assist in breaking up a fight that occurred around the pool table. The victim was struck with bottles, chairs, pool cues and pool balls.

Security at the location was posted at the entrances to the premises, and had a difficult time getting to the victim because of the crowd that formed around the victim.

- On May 4, 2004, at 2:07 a.m. while on patrol, officers of the Milwaukee Police В. Department observed that lights were on inside the licensed premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill"). Approximately 15 cars were parked around the tavern. The officers could see numerous patrons inside the tavern (approximately 30), and music was still playing. An unknown patron locked the door and did not permit officers to enter. The officers were denied entry for approximately 5 minutes. Once inside, the officers discovered the pool table did not have a permit. The partner, Ricardo D. McKenzie, was cited for amusement machine permit (30 patrons after hours), and immediate entry to police. The citations with respect to amusement machine permit and patrons after hours were dismissed without prejudice. From previous hearings, the Committee is aware of the fact that in exchange for the dismissal, the partner pled no contest to immediate entry of police on August 26, 2004 and was found guilty and fined \$343.00.
- C. On June 5, 2004, at 12:40 a.m. while on patrol, officers of the Milwaukee Police Department heard loud music at the intersection of 24<sup>th</sup> and West Lloyd Street in the City and County of Milwaukee, Wisconsin. It was coming from the licensed premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill"). The officers spoke to Ricardo D. McKenzie, who was advised by the officer that he personally on numerous occasions, that the music from the tavern that was too loud. He became argumentative and stated that the police were simply harassing him. When leaving the tavern, the officers observed five vehicles parked on the grass adjacent to the tavern. Patrons leaving were seen to be leaving in those vehicles. As the patrons left the tavern, the officer observed a male carrying an open bottle of beer out of the bar. The partner, Ricardo D. McKenzie, was cited for noise nuisance,

removal of an intoxicant, off street parking. As to the noise nuisance citation Ricardo D. McKenzie was found guilty and fined \$399.50 on December 8, 2005. As to the removal of intoxicant citation the Ricardo D. McKenzie was found not guilty on December 8, 2004. As to the off street parking citation, it was dismissed as to Ricardo D. McKenzie on December 8, 2005.

- D. On August 30, 2004, at 12:49 a.m. while on patrol at the intersection of North 21<sup>st</sup> Street and North Avenue in the City and County of Milwaukee, Wisconsin, Milwaukee Police officers could hear loud music. They found it to be coming from the licensed premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill"). Upon arriving at the tavern, they found the front doors as well as the side door to be open. A verbal warning was given to the security person at the front door that the door needed to be closed after 10:00 p.m. Officers observed the doors to be wide open for another 10 to 15 minutes. Ricardo D. McKenzie was issued a citation for doors closed after 10:00 p.m. The citation was dismissed without prejudice on May 11, 2005. Ricardo D. McKenzie was issued a citation for noise nuisance and was found guilty on May 11, 2005 and fined \$228.00.
- E. On September 2, 2004, at 1:35 a.m. a Milwaukee police officer was sent to back up another squad that had been sent to the licensed premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill") on a complaint of trouble with a subject. The backup officer noticed a multitude of people standing in the parking lot at 2251 North 21<sup>st</sup> Street as well as people standing in the road blocking traffic on 21<sup>st</sup> Street. Large groups of patrons from the tavern were congregating around the tavern. The officer observed a Buick in the 2200 block of North 21<sup>st</sup> Street with the radio on so loud that it could be heard beyond 50 feet. The driver stated that he had just left the tavern and was cited for noise nuisance.
  - F. On September 30, 2004 at 12:45 am Milwaukee police officers could hear loud music coming from Leoric Sports Club Bar & Grill, 2035 W Fond Du Lac Ave. while they were a block away from the premise. They also counted patrons as they left the tavern at closing and counted 201 patrons. Maximum capacity of the premises is 180 persons. Ricardo McKenzie was issued citations for Noise Nuisance and Occupancy, both cases were dismissed (noise nuisance on August 10, 2005 and occupancy on March 8, 2005).
  - G. On January 8, 2005 at 1:32 am Milwaukee police were sent to investigate a subject with a gun at Leoric Lounge, 2035 W. Fond du Lac Avenue. A Security Officer from the tavern had called police and had observed a patron with a firearm. The person was arrested for carrying concealed weapon.
  - H.. On January 23, 2005 Milwaukee police responded to a call of a subject with at gun at Leoric Sport Club Bar & Grill, 2035 W. Fond du Lac Avenue. A security person stated there was no gun, but a fight had occurred between two patrons. One of the security officers had been struck in the head. One patron was cited for assault & battery and the other for disorderly conduct.
  - I. On January 28, 2005 at 1:30 am Milwaukee police observed a male walk out of

- Leoric Sport Club Bar & Grill, 2035 W. Fond du Lac Avenue with a bottle of beer and drink from it. He was issued a citation for public drinking.
- J. On February 8, 2005 at 1:07 am Milwaukee police were sent to a fight outside Leoric Sports Bar & Grill, 2035 W. Fond du Lac Avenue. Two female patrons began fighting in the tavern; it continued in the parking lot. One was struck on the forehead by the other with a beer bottle. When police tried to enter the front door, it was locked. Approximately 100 patrons were in the tavern. As patrons were leaving the tavern at 2:00 am, they were observed by police yelling profanities loudly, revving the car motors and playing car stereos loudly. Patrons were observed walking over front lawns of neighboring houses.
- K. On February 15, 2005 at 1:32 am Milwaukee police were sent to a fight at Leoric Sports Club Bar & Grill, 2035 W. Fond du Lac Avenue. They observed about 75 people in front of the tavern, and about 20 were physically engaged in fighting. The fight started in the bar between patrons and security personnel. Once the crowd dispersed, an officer observed Mrs. McKenzie leave the back of the tavern, get into her pickup truck, rev the engine, and then spun the tires which hurled mud and rocks at a group of police standing behind her truck. One of the fighters was underage. Leonie A McKenzie was issued citation for disorderly premise which was dismissed without prejudice on August 10, 2005 he was also issued a citation for presence of underage and found guilty and fined \$354.00 on August 10, 2005.
- L. On February 19, 2005 at 1:45 am Milwaukee police and a Milwaukee Code Enforcement Inspector conduct a license premise check of Leoric Sport Club Bar & Grill, 2035 W. Fond du Lac Avenue. While attempting to gain entry to the tavern, they found the front door locked and had to pound on the door for access. At closing time as patrons were leaving, the officers observed several patrons leave the tavern with open bottles of beer. Leonie A McKenzie was issued citations for Permitting Patrons to Leave premises with open intoxicants which was dismissed without prejudice on August 10, 2005, he was also issued a citation for Immediate Entry For Police and on August 10, 2005 was found guilty and fined \$358.00.
- M. On February 23, 2005 at 12:15 am Milwaukee police were sent to 2035 W. Fond du Lac Avenue for trouble with a subject. A security person employed by Leoric Sport Club Bar & Grill patted down a person entering the tavern, and found a plastic baggie with white chunky substance. She was arrested for possession of controlled substance-cocaine.
- N. On May 9, 2005 at 12:37 am, Milwaukee police were sent to a trouble with a subject at Leoric Sports Club Bar & Grill, 2035 W. Fond du Lac Avenue. A security officer stated that during a weapons check she found a corner-cut baggie of off white chunky substance in a purse of a person entering the tavern. The person was arrested for possession of controlled substance cocaine.

- O. On July 21, 2005 at 12:36 am Milwaukee police were sent to 2035 W. Fond du Lac Ave. for a wanted subject. Security officers from Leoric Sports Club Bar & Grill were instructed in the past to call police if this subject returned. In the past this subject pulled out a handgun on the security personnel. Because he was 19 years old he was issued a citation for Presence of minor and arrested for disorderly conduct armed. The tavern owners and the security officers were very cooperative with police.
- P. This premise was renewed with a fifteen (15) day suspension for the 2005 license year based upon items 5A and 5B only.
- Q. On July 21, 2005 at 12:36 a.m. Milwaukee police were sent to 2035 West Fond du Lac Avenue for a wanted subject. Security officers from Leoric Sports Club Bar & Grill were instructed in the past to call police if this subject returned. In the past this subject pulled out a handgun on the security personnel. Because he was 19 years old he was issued a citation for presence of minor and arrested for disorderly conduct-armed. The tavern owners and the security officers were very cooperative with police.
- R. On September 4, 2005 at 12:50 a.m., City of Milwaukee police officers were flagged down for a fight that involved security officers at Leoric Bar at 2035 West Fond du Lac Avenue. Officers entered the tavern and observed a subject fighting with security officers employed by the tavern. This patron was identified as Marcel Burks (black male, d.o.b. 5-15-79). Burks continued to fight with security and officers despite officers continuously identifying themselves as police. Security officers also turned over to police a bag of white chunky substance believe to be cocaine. Security officers stated they had found it on the floor inside the tavern. Burks was issued personnel citations for disorderly conduct, resisting/obstructing an officer and assault and battery. The licensee, Ricardo McKenzie, was issued a citation for disorderly premises. The substance was tested and found positive for cocaine base. Ricardo McKenzie was cited with disorderly premises. At the hearing the Committee was told these citations were not issued.
- S. On October 5, 2005 at 11:30 p.m., City of Milwaukee police officers were flagged down for a trouble with a subject at 2035 West Fond Du Lac Avenue. Officers found security restraining a male subject on the floor at the tavern, security personnel stated the subject, identified as Brandon Stanback (black male, d.o.b. 3-6-86), provided security with a false ID and was refused entry into the bar. Stanback then became upset and started to fight with security officers. Stanback also resisted officers' arrest and became combative when placed into custody. Stanback was issued citations for underage misrepresenting and disorderly conduct.
- T. On October 8, 2005 at 1:21 a.m., City of Milwaukee police officers were dispatched to 2035 West Fond du Lac Avenue for crowd and cruising control due to tavern closing. Officers arrived to find about 100 cars cruising the area and it took several

- squads to clear the area. Officers cleared the scene by 3:37 a.m. No violations were found in Leoric.
- U. On October 9, 2005 at 2:15 a.m., City of Milwaukee police officers were dispatched to 2035 West Fond du Lac Avenue for crowd and traffic control. It took seven squad cars 30 minutes to gain traffic control and clear the area.
- V. On November 11, 2005, City of Milwaukee police officers were dispatched to 2035 West Fond du Lace Avenue for a disorderly subject. Officers found security detaining a subject for attempting to fight with same. Security personnel stated the subject, identified as Robert Kimbrough (black male, d.o.b. 9-19-84), became disruptive and security attempted to remove him from the tavern when he became combative. A citation was issued to Kimbrough for disorderly conduct.
- W. On December 8, 2005 at 12:50 a.m., squads were sent to monitor the crowds at Leoric Sports Bar at 2035 West Fond du Lac Avenue. Officers in an unmarked squad car observed a male at the back door of the business about to urinate. This subject, upon seeing officers, discarded a baggy under a car that was nearby. Officers stopped this subject and identified him as Paul Green (black male, d.o.b. 3-16-80). Green stated to officers that he had just walked out from Leoric bar with a friend and needed to use the bathroom. The substance tested positive for cocaine. Green was arrested for possession of a controlled substance-cocaine.
- X. On January 15, 2006 at 2:28 a.m., City of Milwaukee police officers were dispatched to 2035 West Fond du Lac Avenue for a shooting. Officers found a 21-year old male laying on the pavement in a parking lot across the street from the bar. This male had 4 gun shot wounds and was semi-conscious. This subject was identified as Robert Kimbrough (black male, d.o.b. 9-19-84). (Kimbrough has been cited in the past for disorderly conduct at Leoric on November 11, 2005). The investigation revealed that a black female shot Kimbrough and then fled in a white Cadillac. It was also determined that two security personnel on the scene had fired rounds at the female shooter. Security personnel also stated that the shooter and Kimbrough had been inside of Leoric just a short time earlier. The Criminal Investigation Bureau handled the investigation.
- Y. On January 26, 2006 at 1:30 a.m., applicant received a citation for posting of occupancy capacity at 2035 West Fond du Lac Avenue which is pending trial on September 21, 2006.
- Z. On January 31, 2006 at 1:35 a.m., City of Milwaukee police officers were dispatched to 2035 West Fond du Lac Avenue for a fight complaint. Upon arrival, officers observed a male subject exiting Leoric and being chased by 5-6 security personnel, who had their guns drawn on Leoric property. Security officers were able to decentralize this subject to the ground. Security personnel assisted and this subject continued to resist officers and not remove his hands from under his body. Security personnel used OC and were able to get the subject into custody. This

subject was identified as Jesse Williams (black male, d.o.b. 11-18-81). Investigation revealed that security was escorting out another patron, Christian Person (black male, d.o.b. 11-21-80), when Williams became involved. Williams was also escorted out of the tavern along with Peterson. Williams then proceeded to pick up a brick and throw it at a 1' x 3" window on the front door, breaking it. Williams then reached in and unlocked the door and walked back into the bar. Williams then punched Johnnyffer Feliciano (w/m 11-10-80) in the eye causing pain and swelling. Feliciano is a security officer, Officers spoke to Person regarding this incident and had provided officers a false names earlier (Terrelle Carroll and Jamil Mosely) and would not provide give his date of birth. Person was eventually fingerprinted and positively identified, Williams was arrested and charged with battery, resisting arrest and damage to property. Person was arrested and charged with resisting/obstructing officer and received a citation for disorderly conduct by patron prohibited. The licensee, Ricardo McKenzie, received a citation for disorderly premises prohibited. Ricardo McKenzie was cited with disorderly premises prohibited and the ticket is not able to be found in system under the citation number or name. At the hearing, the Committee was told by the licensee that, in fact, the ticket did not exist.

- AA.On March 9, 2006 at 12:17 a.m., City of Milwaukee Police were dispatched to Leoric Sport Club for a battery complaint. The investigation revealed that security for the bar had a policy of patrons under 23 to be patted down for weapons before entering the bar. A subject, identified as Jed Hall (black male, d.o.b. 8-4-84) try to gain entry, but refused to be patted down. Security refused entry to Hall and asked Hall to leave. Hall became angry and refused to leave. Hall started to become disorderly and was creating a public disturbance. More security officers were called to help out with this disturbance. Security attempted to restrain Hall until police arrived, but Hall was resisting. Security then stated that they threw Hall to the ground hitting Halls head on a snow bank causing a small abrasion. Hall refused medical attention. Halls friend identified as Lance Merchant (black male, d.o.b. 3-28-77) then refused to leave the area also and began yelling profanities. Merchant was then handcuff by security officers and detained until police arrived. Both Hall and Merchant were issued each two citations for trespassing and disorderly conduct.
- BB. On April 1, 2006, City of Milwaukee police officers were flagged down for a fight complaint by security for Leoric Sport Club. Officers observed a large number of patrons exiting the tavern arguing loudly and pushing one another. Security attempted to disperse this group, however, it continued to gather a larger crowd. Officers were able to disperse the crowd with most subjects complying except for a female subject. She was later identified as Erica Coleman (black female, unknown date of birth). Coleman was attempting to entice the crowd to fight by running up to autos, kicking at the doors and yelling profanities at the occupants. Coleman then opened the door to one auto, trying to strike one of the passengers. Officers attempted to arrest Coleman and she began to resist arrest. Coleman was arrested and given two citations for disorderly conduct and resisting/obstructing officers.

- CC. This licensee was first licensed for this premise in 2002. It was renewed with an amended tavern supplement in 2003, renewed with a 15-day suspension in 2004, and renewed with a 10-day suspension in 2005.
- DD. According to the alderman's office, no neighbors appeared in opposition to this license because there are no neighbors in the immediate area.
- EE. At hearing it was discovered that the Milwaukee Police Department has initiated proceedings to declare this a nuisance premises and has charged for police service pursuant to § 80-10, Milwaukee Code of Ordinances.

#### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts the Committee concludes that the licensees, Leonie A. McKenzie and Ricardo D. McKenzie have not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of their Class "B" Tavern without undergoing a sixty (60) day suspension and nonrenewal of the Class "B" Tavern Amusement (Cabaret/Nite Club) license. The Committee finds the police report and neighborhood objections to be true.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a sixty (60) day suspension the Class "B" Tavern license and nonrenewal of the Tavern Amusement (Cabaret/Nite Club) partnership license held by Leonie A. McKenzie and Ricardo D. McKenzie for the premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill").

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of two (3) ayes, zero (0) notes and two (2) excused recommends that the Class "B" Tavern license be renewed with a sixty (60) day suspension and the Class "B' Tavern Amusement (Cabaret/Nite Club) partnership license held by Leonie A. McKenzie and Ricardo D. McKenzie for premises at 2035 West Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin ("Leoric Sport Club Bar & Grill") not be renewed.

Said suspension is to be in force from 12:01 a.m. November 25, 2006 through midnight, January 24, 2007.
