Dear Mr. Nesta:


Our office has received your claim relating to the towing of your car. You indicate that you parked your vehicle on Kilbourn Avenue on September 23, 2002, that your vehicle had an overnight parking sticker, but the next morning your vehicle was towed. You believe that there were not adequate signs indicating no parking. You are seeking a refund of the towing fee and the \$35.00 parking ticket you received.

Our investigation reveals that your vehicle was towed on September 24, 2002 for being illegally parked. According to the Milwaukee Department of Public Works – Street and Sewer Maintenance Division, signs were posted on Friday, September 20, 2002 indicating “Temporary No Parking”. Your car was towed for being parked in a posted construction/tow-away zone. If you wish to contest the legality of the tow, you must contest the ticket issued with the tow. You may do so by contacting the Ordinance Enforcement Division at 414-286-2676. The City followed proper procedure and accordingly, we are denying your claim.


