The Department of Employee Relations recently received the attached correspondence from Milwaukee District Council 48, AFSCME, AFL-CIO. The letter indicated that Mr. James Field, an Auto Machinist in the Department of Public Works, Operations Division, Fleet Services Section, will replace Candace Hoyt, an Accounting Assistant I, in the Department of Public Works, Administration Division, as the District Council 48 Contract Administrator, Local 33.

The D.C. 48 Contract Administrator, Local 33, is under Pay Range 934 in Section 23 of the Salary Ordinance. Because the pay rate for a D.C. 48 Contract Administrator, Local 33, is tied to an incumbent's pay rate (including any fringe benefit adjustment), as a regular City employee, the current rate of pay for Pay Range 934 reflects the pay received by Ms. Hoyt. Therefore, Pay Range 934 must be amended to reflect a new rate of pay to be received by Mr. Fields.

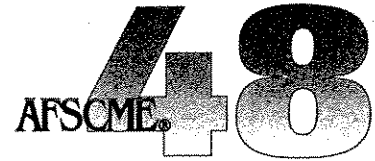
