

Amendment No. 1

AMENDMENT NO. 1 to Contract No. 08-025 (CM), between the City of Milwaukee (CITY) through the Department of City Development (DCD) and Board of Regents of the University of Wisconsin System (the UNIVERSITY), doing business as the Division of Cooperative Extension of the University of Wisconsin-Extension, on behalf of the Milwaukee County Cooperative Extension (MCCE), is hereby amended, modified, altered and changed in the following respects only.

WHEREAS, pursuant to the terms of the original Agreement, the parties hereto desire to exercise the option to extend the Time of Performance of said Agreement for an additional 90 days through June 30, 2010; and

WHEREAS, the parties hereto agree, that compensation to the UNIVERSITY for said extension will be made pursuant to Section IV of the Agreement, in monthly installments of \$5,000; and

WHEREAS, in consideration of the said extension to the Agreement, the parties hereto agree, to increase the not to exceed amount of Section IV (5) of the Agreement from \$90,000.00 to \$105,000.00; and

WHEREAS, this Amendment is made in consideration of the payments, performances, promises, and covenants and obligations, which are set forth in the original Agreement and as, set forth herein; and

WHEREAS, this Amendment shall in no way act as a waiver of the price, terms, conditions and obligations, not herein amended, imposed on the parties by the original Agreement heretofore executed by them and identified in the above caption. Any rights or obligations, which either of the parties have by virtue of the original Agreement shall remain in

full force and effect, except as is expressly and specifically amended, modified, altered or changed herein.
