This letter shall serve as notice of my objection to the licensing for the business operating at 2237 N Holton Street, Citgo Gas Station. It shall also serve as my opposition to the current owner being licensed and my opposition to the current operator of the facility being licensed at this location. The operation causes litter to fly through the neighborhood due to not emptying garbage cans throughout the day.

There have also been numerous dangerous occurrences resulting from the manner with which the facility is being operated. The safety of the neighborhood is diminished as a result of the City of Milwaukee continuing to allow them to operate at this location. Shootings, loud late night music from one and more vehicles at a time, loud vehicles screeching out of the parking lot, car alarms going off from customers, panhandling at all hours, drug dealing on site, and refusals to improve. The refusals from management include, but are not limited to refusals to cooperate with neighbors, refusals to call the police on individuals that are dealing and harassing customers, refusals to incorporate signs that direct customers to not engage in illegal activity, refusals to hire permanent security guards at all hours.

Employees are behind bullet proof glass but the operation puts the neighborhood at risk by allowing illegal activity to continue unabated. The 24 hour license should not be renewed. The food wrappers are littered throughout the area and come directly from this establishment. Garbage cans are blown over for hours without being cleaned up. New high output lights are pointed at neighboring homes causing light pollution and intense light to flood into nearby homes. The establishment is being fined by the City but refuses to stop harassing neighbors with these lights.

24 hour licensing needs to be terminated immediately as there is no viable plan of operation that could be believed from the operators. The noise cannot be controlled by this operator and there is no way to properly stem this problem besides to not allow them to operate longer than normal hours. Promises made in the past at these licensing hearings have never been implemented. Feces and urine on the building and surrounds due to not allowing customers to use the bathrooms with excuses and apologies instead of fixes. With the litter, condition of the premises inside and out, and health issues stemming from the establishment the food license should be terminated immediately.

The business allows panhandlers to pump gas for customers and buy them items and is used as cover for drug dealing. The safety of allowing homeless drug dealers that have recently smoked drugs is a severe safety issue. The license for a filling station should be suspended for ½ year minimum due to these violations of laws.

I would like to appear in person along with my neighbors to oppose these licenses. Sincerely,

5. On 01/20/20 at 10:19pm, Milwaukee Police conducted a license premise check at the address of 2237 N. Holton Avenue. The only violation found was an opened ½ gallon of milk. The employee was told to move it away from the other products for sale.

Items #2 #3 #4 update with court disposition

- 6. On 11/04/20 at 10:06pm, Milwaukee Police were dispatched to St Mary's Hospital 2301 N. Lake Dr. for a sick and injured complaint. Officers identified the victim of a substantial battery and located a scene at 2237 N. Holton St. Officers spoke with the clerk at the gas station who allowed officers to review video of the incident. Officers discovered that the victim was panhandling outside the location and got into a physical altercation with the suspect who was also panhandling. The suspect during the altercation struck the victim with a glass bottle causing injury. The gas station clerk stated to officers that the subjects usually panhandle near the business. When the subjects are told to leave they become verbally and physically combative.
- 7. On 03/30/21 at approximately 9:00pm, Milwaukee Police conducted a license premise check at 2237 N. Holton St. during the course of the premise check other officers were responding to a robbery investigation. The business was cooperative with the officers and provided video, of the incident. The video revealed that the incident took place outside on the lot of the gas station. From the video officers were able to determine the time frame of the incindet, the suspect and vehicle description.

8. On 07/11/2021 at 7:24pm officers observed a pop-up tent selling Milwaukee Bucks merchandise on the parking lot of 2237 N. Holton St. The officers spoke with the subject selling the shirts. He stated he was from Ohio and did not know he needed a license. He was able to get a co=worker to the sight that had a sellers permit. The subject stated they paid the manager of the gas station \$500 to use the property. The officers spoke with the applicant, who stated he did not give them permission and wanted them removed.

- 9. On 08/07/2021 at 2:50am officers were dispatched to a Shots Fired at 2237 N. Holton St. The investigation revealed a patron was filling up his car with gas, when a car pulls up in front of his parked auto. The two drivers exchanged words. The driver of the second car attempted to get in the store but the clerk locked the door. The driver returned and again had words with the first subject. The car drove off and the first patron produced a gun firing at the auto. The second subject produced a firearm and shot back at the first subject. The officer spoke with the clerk and he provided the officer with video of the incident. The officers contacted the applicant and he stated he was aware of the incident and that there was no damage to the station.
- 10. On 04/28/2022 at 9:39pm officers conducted a license premise check at Citgo on Holton, 2237 N. Holton St. During the check the officers observed several food items to be displayed for sale after their expiration dates. The items were removed from the counter and the clerk stated he would advise his manager. The officer did speak with the agent by phone.

This license Premise report is written by PO David LETTEER, District 5 Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 07-11-21 at 7:24 p.m., as we were driving by Citgo on Holton, 2237 N. Holton St., which is a licensed gas station in the city of Milwaukee, PO MACRAE and I observed a pop up tent, in the northeast corner of the parking lot, which appeared to be selling Milwaukee Bucks merchandise.

We stopped at the tent to learn if the person selling the merchandise was properly licensed by the city of Milwaukee to sell the items.

We spoke to the only worker at the tent, Ben Z. MOMENT (b/m 01-17-70) who stated he was helping Alejandro MENDEZ sell the items. MOMENT stated he was from out of town, Ohio, and did not know he needed a license to sell the merchandise. We asked if MENDEZ was in the area of if he would be coming back to sell the merchandise. MOMENT stated that MENDEZ was there earlier in the day, but that he (MOMENT) was there selling merchandise since about 1:00 p.m.

PO MACRAE informed MOMENT that he could be cited for selling the merchandise without a permit. MOMENT was able to contact a person by the name of Jerry, who was at another stand on 76th and Good Hope Rd., selling merchandise.

Jerry stated he could come down to us and we could sort this out. Jerry eventually did arrive at our location and did present a valid City of Milwaukee Sellers permit.

We spoke to Jerry, who was identified as Princeton J. WEATHERS (b/m 04-08-66). WEATHERS informed us that he had another stand on N. 76th St. and W. Good Hope Ave., where he was selling similar items. We informed Jerry that in order for MOMENT to sell items at this tent, he would need a sellers permit in order to do this and that the seller's permit that WEATHERS had, did not cover MOMENT or anyone else at any other merchandise stand.

While investigating this merchandise stand, it was learned that an employee of the gas station, a "Manager" told WEATHERS that he could sell the Bucks merchandise on the property of the gas station for \$500.00 and that the stand had been on the gas station property for a couple days.

PO MACRAE made contact with the property owner and agent of the gas station, Grewal PRITPAL, who stated he did not give anyone permission to sell merchandise on his property. GREWAL wanted the stand removed from his property and that if they returned, he would want them cited or arrested for trespassing. GREWAL stated that he would refund WEATHERS the \$500.00 as well.

WEATHERS and MOMENT took the merchandise and the tent, removing the items from the gas station property. They were informed that if they were to sell merchandise like this again, whether it is for the Bucks or another sports team, just to call city hall and inquire about obtaining a City of Milwaukee seller's permit. We also informed them, that if they were to be on private property, to make sure that they have permission from the owner of the property, not an employee.

GREWAL was informed that we would be writing this report.

On 08-07-21 at 2:50 a.m., Sq. 5340 (PO COLWELL and PO ROEMBKE) responded to a shots fired complaint, at 2237 N. Holton St., which is a licensed gas station in the city of Milwaukee.

Upon arrival officers conducted their investigation, revealing that at or about 2:47 a.m., there appeared to be a patron who was filling his vehicle with gas, when a white vehicle, which was driving recklessly north on N. Holton St., entered the lot of the gas station, from the east, driving very closely to the front of the patrons vehicle. The driver of the white vehicle, parked his vehicle in front of the patron who was filling his car with gas.

The driver of the white vehicle exits his vehicle and the patron who is filling his car with gas, begins to say or yell something at the other driver. The driver of the white vehicle walks away from his vehicle and attempts to enter the gas station store. The clerk, who observed this, had already locked the entrance door. The driver of the white vehicle pulls on the door, not getting in, the driver goes back to his white vehicle and words are exchanged between him and the patron who is filling his car with gas.

The driver of the white vehicle gets back in his vehicle, backs out of the lot (eastbound) at a high rate of speed, off of the lot and onto the city street into southbound lane of traffic, but facing northbound. As the driver of the white vehicle drives north, in the southbound lane of traffic, the patron who was filling his car with gas, produces a firearm and fires gunshots towards the white car. The driver of the white car then returns gunfire towards the patron. This caused other people who were in the gas station lot to take cover behind objects.

The white colored vehicle drives to W. North Ave, form N. Holton St. As the vehicle is driving north, and possibly west on W. North Ave., another person who is at the gas station runs to the north side of the lot and produces a firearm, firing the firearm several times at the white vehicle.

While officers were conducting their investigation, the gas station clerk assisted the officers with obtaining DVR video of this incident, which was captured on several different camera views.

On 08-07-21 I contacted the listed agent of the property, Pritpal GREWAL and I wanted to know if the gas station had been struck by gunfire, also I wanted to know if his employee had informed him on what happened regarding the shooting.

GREWAL stated he was informed of the incident and also watched the video of the incident. He stated that his employee did lock the door to the gas station, so as that people could not enter or leave the gas station during this incident. GREWAL stated the gas station was not damaged by gunfire. No one claimed to be hurt by the gunfire or by the reckless driver.

I informed GREWAL that I would be filing this report.

On Thursday, April 28, 2022, while in full duty uniform wearing activated axon body worn cameras, PO BURLO and I, conducted a license premise report at 2237 N Holton St (Citgo On Holton), which is located in the City and County of Milwaukee.

Upon arrival, PO BURLO and I were met by the premises employee who was identified as Shekar CHOUHAN (M/A, DOB 11/09/1996) who stated he is a cashier at the location. CHOUHAN was the only employee observed working at the location. CHOUHAN stated his scheduled work hours at the location are from 9:00 PM until 7:00 AM.

PO BURLO and I, conducted a walk through of the the first floor of the location. I observed that the premise is equipped with high definition resolution surveillance cameras throughout the interior and exterior of the location. PO BURLO and I, checked the expiration dates of the food items for sale inside of the premise. I located one (1) expired "Prairie Farms" whole milk which was dated 04/26/2022 on the day of 04/28/2022 and two (2) expired "Prairie Farms" Butter dated 03/19/2022 on the day of 04/28/2022. Those items were removed from the shelves. No other expired items were located inside the premise. PO BURLO and I observed many prodúcts to have no expiration date listed on their packaging or placement which made reading the expiration date difficult.

Officers advised CHOUHAN of the findings. He was cooperative while talking to officers and stated he would inform his manager, not identified, on 4/29/22, before he leaves work.

All licenses for the premises were located posted on a wall behind the register.


