Dear Ms. Beaumont:

We have received your claim in the amount of \$120.00, relating to damage from a loss in the spring of 2016.

This notice of claim was filed on October 25, 2016. Wisconsin Statute §893.80(1d)(a) requires that a notice of the circumstances of the claim be filed within 120 days after the happening of the event giving rise to the claim. This notice is untimely.

The Forestry Section records indicate that this matter was not reported to nor investigated by them at that time. On February 12, 2016 they removed the trunk of a 19-inch diameter Norway Maple street tree at 5276 South 22<sup>nd</sup> Place. They followed standard procedures. They have no record indicating damage associated with the operation. As such, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the
