We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Mary Gaurkee, 6711 West Morgan Avenue, Milwaukee, WI 53220, alleges that on April 30, 2002 she sustained injuries when she fell on an uneven part of the alley located behind her home. She claims damages in the amount of \$7,500.00.

Our investigation reveals that the Infrastructure Services Division records from April 30, 2001 to May 15, 2002, indicate that they received only one complaint, a call from the Alderman's Office, about a pothole in the alley behind 6711 West Morgan Avenue on May 6, 2002. The area was patched the same day. Upon notification of a defect the division will send

a repair crew to correct it usually within 24 hours. Prior to this complaint, the City had no notice of this defect in the alley and because of this lack of notice, the City would not be liable. Accordingly, we recommend that this claim be denied.
