Dear Ms. Bryd:

This office is in receipt of your claim in the amount of \$152.04, relating to damage sustained to your vehicle on March 26, 2001 when it allegedly collided with potholes at North 7th Street and West Concordia Avenue.

The Infrastructure Services Division records indicate that potholes have been patched in this area as recently as January 22, 2001. However, a search of their records show no calls regarding potholes since this date until after your loss. Upon notification of a road defect the division will send a repair crew to correct a hazard within 24 hours. Since the City had no notice of any defect in the roadway, and because of this lack of notice, the City of Milwaukee cannot accept liability for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
