Common Council File 010338 contains a resolution to ratify and confirm the final labor agreement between the City and the Milwaukee District Council 48, AFSCME, AFL-CIO. The agreement covers wages, hours and conditions of employment for the period of January 1, 2001 through December 31, 2002. The Milwaukee District Council 48 represents 2,099 city employees.

This agreement provides annual salary increases of 2.5% for 2001 and 3.0% for 2002. The estimated cost of these increases is \$1,961,543 in 2001 and \$4,374,240 in 2002 (includes salary increases, overtime and rollups). The cumulative cost over the two-year life of the contract is \$6,335,783. Funds for these costs are provided in the Wages Supplement Fund for 2001 and will be included in the 2002 Budget.

Pension, Life Insurance and FICA costs related to the salary increases are estimated at \$866,626 over the life of the contract. Although the cost increase related to pension benefits is attributed to the year in which salary costs and benefits are changed, the actual cost depends on the actuarial assumptions and pension fund earnings.

Other contract changes include: An increase in the contribution of employees enrolled in the Basic Plan to \$50 per month for single enrollment and \$100 per month for family enrollment (from \$40 and \$80) starting January 2002, an increase in the Major Medical lifetime maximum for employees enrolled in the Basic Plan from \$250,000 to \$500,000, an increase in each shift and weekend differential by five cents per shift, an increase in the Safety Shoe Allowance for eligible employees from \$105 to \$115 annually (\$130 annually for certain Forestry employees), an increase in the maximum reimbursement for tuition and textbooks from \$900 to \$1,000 annually (2002), a revision of years needed for additional vacation and reallocations and reclassifications of various positions within City government. The net effect of these changes is anticipated to be \$1,472,445 over the life of the contract.

The contract also includes a Domestic Partnership provision for same-sex and opposite-sex partners. This provision allows health and dental insurance and funeral leave benefits for domestic partners of City employees who are registered as such by the City Clerk (as provided under Chapter 111 of the Milwaukee Code of Ordinances). The fiscal impact of this change is estimated to be \$66,098 over the life of the contract.

Any ordinance changes necessary for the implementation of this contract will be discussed in separate Common Council File(s).

RECOMMENDATION: ADOPT THE RESOLUTION INCLUDED IN THIS FILE APPROVING A 2001-2002 LABOR AGREEMENT WITH THE MILWAUKEE DISTRICT COUNCIL 48, AFSCME, AFL-CIO.
