
PLEASE TAKE NOTICE that on and before May 26, 2007, Ms. Lisa Bullocks lived at 3303 West Walnut Street in Milwaukee, Wisconsin with her six children. At approximately 5:00 p.m. on May 26, 2007, a stolen vehicle driven by an unknown driver (who was eventually apprehended) lost control and ran into the Bullocks residence. The stolen vehicle was being chased through a residential neighborhood by the Milwaukee Police Department. Milwaukee Police Officers were at the scene and it was determined that there may be structural damage to the house and the Bullocks family was told they would have to relocate until the house was repaired. The Bullocks family stayed at the scene because they were afraid their house would be burglarized before it could be boarded up. The police officers on the scene assured them that they could leave the scene to move into a hotel which was arranged by Red Cross and that they would make sure the house was secured.

The house was eventually boarded up with the exception of a hole on the corner of the house and one window on the side of the house. Subsequently the house was burglarized and the Bullocks family lost the items attached here to as Exhibit A. The value of the items stolen/destroyed is \$10,000.00 to \$12,000.00.

It is believed that the loss of these items was caused by the negligence of the City of Milwaukee employees in failing to properly board up and otherwise secure the premises.

This notice is made pursuant to Section 893.80 of the Wisconsin Statutes.
