## **NOTICE OF CLAIM**

**NOTICE IS HEREBY GIVEN** to the City of Milwaukee, Milwaukee, Wisconsin, pursuant to §893.80 Stats., that a claim is hereby made for personal injuries and damages sustained by Patricia Wright, as set forth below:

1. The name of the law firm representing Patricia Wright is Dowling & Blumenfield, LLP, 735 N. Water Street, Suite 1200, P.O. Box 611, Milwaukee, WI 53201-0611.

2. Patricia Wright, whose address is 4747 N. Green Bay Avenue, Milwaukee, Wisconsin 53209, sustained personal injuries on August 23, 1999 when she tripped and fell after stepping on a defective piece of curb in front of 4747 N. Green Bay Avenue, Milwaukee, Wisconsin 53209.

3. The proximate cause of said injuries was the negligent manner in which the curb was maintained by the City of Milwaukee, resulting in Ms. Wright falling when she stepped onto a section of the curb which was loose and then shifted causing her to slip and fall, breaking her ankle.

4. As a direct and proximate result of the negligence of the City of Milwaukee and its employees, Patricia Wright suffered a broken ankle, and other personal injuries, damages including medical care and treatment, lost wages, pain, suffering and disability and the loss of enjoyment of life, all in the total amount of \$150,000.

6. A Notice of Injury was duly filed with the City of Milwaukee on or about October 29, 1999, advising said municipality of the circumstances of this claim.

7. This claim for damages is brought by the undersigned, as one of the duly authorized attorneys for Patricia Wright.



3. The proximate cause of said injuries was the negligent manner in which the curb and sidewalk were maintained by the City of Milwaukee.


4. As a direct and proximate result of the negligence of the City of Milwaukee and its employees, Patricia Wright suffered a sprained ankle, and other personal injuries.
