File # 021344 is a resolution authorizing the acceptance and expenditure of contributions received from federally forfeited tangible property or cash for increased or enhanced law enforcement efforts and the department's anticipated expenditures of these funds.

Background

- 1. This resolution authorizes the expenditure of \$379,300 to fund items included in the approved 2003 Asset Forfeiture Plan.
- 2. Common Council File # 920252 requires Common Council authorization for the Milwaukee Police Department to expend money from its Asset Forfeiture Funds.
- 3. In 2002, approximately \$144,500 was spent from the Asset Forfeiture Fund. Funds available from this account historically average up to \$300,000 per year.
- 4. The Asset Forfeiture Fund Account is replenished on a periodic basis, throughout the year, as the U.S. Department of the Treasury forwards funds to MPD.

Discussion

- 1. The Milwaukee Police Department is requesting authorization to spend \$379,300 from the 2003 Asset Forfeiture Fund Account. Council File # 021181 communicated the MPD plan for the 2003 Asset Forfeiture Fund expenditures.
- 2. The asset forfeiture program funds a mix of new and continuing items and programs.
- 3. The following items and programs are included for the anticipated funding:

- 1. The expenditures detailed in this resolution will leave an approximate balance of \$20,096.01 in the Asset Forfeiture Trust Account.
- 2. These expenditures do not have a fiscal impact upon the city.

Further Information

- 1. The 2003 Asset Forfeiture Plan provides information on funding for items totaling \$379,300. Revisions to this plan occur as needs or priorities of MPD change.
- 2. MPD issues a separate communication detailing the actual expenditures from the previous year's Asset Forfeiture Fund.
