Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by PO Matthew DIENER, assigned to District 2, day shift, squad 2166. On 07/01/2023, at 11.39am, multiple calls came into the Milwaukee Police Department regarding shots fired in the area of 719 S 5th St. Several callers reported hearing several shots. Upon arrival, myself and investigating officers observed that the target of the Shots Fired was Hex Nightclub located at 715 S 5th St.

Witnesses observed a dark sedan pull up in front of Hex Nightclub, and fire multiple rounds into the building. Investigating officers examined the front facade of Hex Nightclub. A total of 18, .40 caliber shell casings were lying in the street in front of the night club. All of the windows in the front of the building were shot out. Fortunately, no persons were present inside Hex Nightclub at the time of the shooting. I next observed a bullet hole in the upper window of the business next to Hex Nightclub. The business next door is Folia Plants and Hair Salon, which was opened for business and occupied.

The manager of Hex Nightclub, Carl R. WILLIAMS, B/M, 05/03/1974, arrived on scene shortly after learning that the nightclub was shot up. According to WILLIAMS, he stated that the nightclub was definitely closed at the time of the shooting and no persons were present inside the establishment. Williams stated that approximately 2 months ago, on April 5th, 2023, Hex Nightclub was the target of another similar style shooting (case #23-095-0165).

WILLIAMS stated that he had an idea of who possibly is responsible for the shootings. Williams stated that his lounge started to have a "Latin Night" at least once a month. Williams explained that his clientele generally is an all-black crowd, but in an attempt to be more diverse because of the area, Hex started to host Latin Night featuring Latino acts of entertainment. Williams went on to explain that a few days prior to the last shooting, two groups of Puerto Rican attendees had got into an argument and a light physical altercation, prompting the club to ban all that were involved. Williams stated that the last shooting was probably out of retaliation for kicking out the groups of people. Over the past two months, Williams stated that his club allowed one of the two groups to come

back to the club, possibly angering the other group. However, on this date, July 1, 2023, the allowed group of people had planned to host and promote a famous Puerto Rican rap artist "Hades 66" at Hex Nightclub, whom they flew up from Puerto Rico. The event was to be held later on in the evening on July 1st. WILLIAMS suspects that he believes that in an attempt to foil the festivities, the rival group shot up his night club to prevent the rap artist event from taking place.

WILLIAMS was able to provide video footage which captured the suspect vehicle turn southbound from W. Bruce St., onto 5th St. The vehicle continued south on S. 5th and stopped right in front of Hex Nightclub. Once the car was stopped, gunfire expelled from the front and rear passenger side windows. After all shots were fired, the car continued southbound at a high rate of speed, disregarding the red light at S. 5th St. and W. National Ave., continuing southbound. The vehicle left the frame and the direction of travel was no longer observed.

Squad 2166. On Monday, July 3, 2023, a Notice of Nuisance Premise letter was mailed to the building owner of 715 S 5th St, which is occupied by Hex Nightclub. The premise qualifies as a Nuisance Property pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises. The owner was notified that the following described nuisance activities at the premises on the corresponding dates, qualify the premises as a nuisance:

- 1) On Wednesday, April 5, 2023, at approximately 8:47pm Milwaukee Police officers responded the premise for a "Shots Fired" complaint. Upon arrival officers observed multiple shots that were fired into the premise, to include the front windows, front entry door, and interior walls of the premise. There was a total of 11, 9mm casings recovered in front of the business. The business was unoccupied and was closed during the incident. During the investigation investigating officers learned the shooting might've been in retaliation to a rap artist being removed from the premise for starting fights inside before his performance, several nights before the incident occurred. This nuisance activity is contrary to MCO 80-10-2-c-1-L.
- 2) On Saturday, July 1, 2023, at approximately 11:37am Milwaukee Police officers responded to the premise for a "Shots Fired" complaint. Witnesses observed a dark sedan pull up in front of the premise, and fire multiple rounds into the building, with surveillance video capturing the vehicle with the front and rear passengers both firing multiple rounds into the premise in a "drive-by" style. A total of 18, .40 caliber shell casings were lying in the street in front of the premise with multiple shots that were fired into the building, to include all the front windows, front entry door, and interior walls of the premise. The manager arrived on scene and explained this incident might be ongoing from the shooting back on April 5, 2023, and believes that in an attempt to foil the festivities, the rival group shot up his night club to prevent tonight's rap artist from performing. This nuisance activity is contrary to MCO 80-10-2-c-1-L.

This report is written by PO Matthew DIENER, assigned to District 2, day shift, squad 2190. On Saturday, July 1, 2023, at approximately 11:40am, Squad 2190 (DIENER) responded to 715 S 5th St, Hex Nightclub, for a Shots Fired complaint. Upon arrival I observed that the front of the nightclub was shot numerous times with .40 caliber casings recovered. The manager, Carl WILLIAMS, responded shortly after the incident and was told what happened. WILLIAMS stated that he believes the incident is an ongoing issue between his promoter, Juan C SILVA (w/m, 4-13-75), and a previous rapper that SILVA promoted. WILLIAMS stated that back in early April 2023 SILVA had to tell the performing rapper that he booked, and his entourage, to leave the club for trying to start a fight with another group of patrons and being unruly before they could perform.

Then on April 5, 2023, at approximately 8:41pm, Hex was the target of a shots fired into the building, where 11, 9mm casings were recovered (see IR# 23-095-0165). I then spoke to SILVA, who stated that his promotion company is named "JC Promotions", and that he was bringing in a rapper from Puerto Rico to perform tonight (7/1/23). SILVA stated that he believes the person responsible for both shots fired incidents at HEX was the rapper that he kicked out back in April, and that this rapper is trying to ruin his business through these incidents. I asked SILVA the name of the rapper he kicked out back in April as a possible lead to develop as a suspect in these incidents, at which point SILVA actively declined to give the name of the rapper out of fear of retaliation from this subject.

Having knowledge that Hex Nightclub is not supposed to use promoters as part of their submitted plan of operation, I verified on LIRA, the City of Milwaukee's license database, that in fact Hex did check "NO" under 4. PROMOTERS/SOUND AMPLIFICATION in their City of Milwaukee Business Renewal Application form and 2022-2023 Plan of Operations, and that Hex, by hiring promoters, is operating outside of their established 2022-2023 Plan of Operations.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 02/14/22 at 1:30am, Milwaukee Police conducted a license premise check at 715 S. 5<sup>th</sup> Street. The only violation observed was the officers observed people smoking inside the establishment. The applicant was cooperative.
- 2. On 03/04/22 at 12:34am, Milwaukee Police conducted a license premise check regarding a parking complaint at 715 S. 5<sup>th</sup> Street. Officers interviewed a Milwaukee Parking Enforcement Supervisor who stated he heard that the tavern charges patrons to park on the public street. Officers did observe cones blocking off a parking space and security for the establishment stated that they were the businesses cones and picked them up when asked by police to remove them. Officers interviewed the applicant who was cooperative but he stated the cones were not the property of the tavern. He said that they do not charge people to park in the street and blamed a subject across the street for the rumor. The subject across the street said he parks vehicle in a private lot and the cones belonged to the tavern at 715 S. 5<sup>th</sup> Street.
- 3. On 03/18/22 at 1:27am, Milwaukee Police were monitoring the taverns in the 700 block of S. 5<sup>th</sup> Street when they observed a large crowd in front of 715 S. 5<sup>th</sup> Street. The crowd was arguing loudly, pushing, shoving, and some were being restrained by other patrons. Additional squads were called to disperse the crowd and the patrons left the area driving recklessly. A

- walk through of the tavern revealed a group of patrons still arguing and an odor of burnt marijuana. Security told officers that when they turned on the lights in the tavern a female started a verbal argument with her boyfriend. The applicant was on scene and cooperative.
- 4. On 04/16/22 at 2:29am, Milwaukee Police, while on patrol, heard gunshots coming from the 500 block of W. National Avenue. When the arrived in the area, they were informed by a witness that people were shooting in front of 715 S. 5<sup>th</sup> Street. Officers tried to enter the establishment but found the door locked and after several attempts, that applicant opened the door for police. While inside, officers observed workers cleaning up debris from the floor and the applicant told officers that two females engaged in a fight and were escorted out of the tavern. When staff member were asked if they heard any shots being fired, they said they did not see or hear anything. Officers later found casings in the street and on the sidewalk in front and to the south of the establishment. The applicant and staff were cooperative.

- 5. On 06/26/22 at 4:30p.m., a citizen walked into the District to report a stolen firearm. The citizen stated on 06/26/22 at approximately 12:00a.m., they parked their vehicle in front of 715 S. 5<sup>th</sup> St., and when they returned, a rear passenger window was broken and their firearm was stolen from the glove compartment. An officer attempted to retrieve video surveillance from 715 S. 5<sup>th</sup> St.
- 6. On 07/23/22 at 2:40a.m., Milwaukee Police were conducting follow up regarding a separate investigation at 715 S. 5<sup>th</sup> St., when they were advised an employee's vehicle had been broken into and a firearm stolen.
- 7. On 10/15/22 at 9:30p.m., Milwaukee Police conducted a License Premise Check at 715 S. 5<sup>th</sup> St. No violations were found and the employee was cooperative with police.
- 8. On 10/30/22 at 9:30p.m., Milwaukee Police conducted follow up at 715 S. 5<sup>th</sup> St., regarding a fight that occurred in the early morning hours. The employee on scene was cooperative and allowed officers to view video surveillance.
- 9. On 12/08/22 at 1:30p.m., Milwaukee Police conducted a community meeting with bar owners and the Walkers Point Association, regarding common problems with the taverns on S. 5<sup>th</sup> St. The agent for 715 S. 5<sup>th</sup> St., was present and issues discussed were parking/traffic issues and patron behavior upon leaving the establishments.
- 10. On 03/03/23 at 10:30p.m., Milwaukee Police were on patrol when they observed traffic backup in the area of 715 S. 5<sup>th</sup> St., due to valet parking. The officer advised security they cannot block the main flow of traffic while valet parking vehicles. The security officer stated they understood, however, later in the evening the same problem was occurring and the officer once again had to advise security.
- 11.On 03/05/23 at 11:58p.m., Milwaukee Police were dispatched to a Fight at 715 S. 5<sup>th</sup> St. Investigation revealed security observed a patron fall and when they assisted the patron to his feet, the patron pushed another patron. The security officer escorted the patron out and stated that behavior was not welcome, however, the patron was upset and called the police. The employees were cooperative and no violations were observed.

- 12.On 03/15/23 at 12:02a.m., Milwaukee Police were dispatched to a Tavern Violation at 715 S. 5<sup>th</sup> St. Officers were advised the caller stated their minor child was allowed in the tavern using a fake id, and consuming alcohol. The officers attempted to contact the caller, however, only received voicemail. The officers did not observe anyone that appeared to be underage inside the club. The officers interviewed the manager and advised of the complaint as well as prior noise complaints. The manager requested officer's assistance with security in preventing incidents inside and outside the club. The manager was receptive to all of the officer's suggestions and agreed to purchase an ID Scanner to prevent minor's from entering. The manager was cooperative.
- 13.On 04/05/23 at 8:41p.m., Milwaukee Police were dispatched to a Shots Fired call at 715 S. 5<sup>th</sup> St. Investigation revealed the closed business had been shot into by a subject walking by. The manager arrived on scene and stated they recently purchased an ID Scanner that has led to them turning more patrons away, but hasn't had any problems with anyone. The manager was cooperative and allowed officers to view video surveillance of the incident.
- 14. On 07/01/23 at 11:40a.m., Milwaukee Police responded to 715 S. 5<sup>th</sup> St., for a Shots Fired Investigation. On arrival officers did observe the unoccupied tavern had been struck by gunfire. The officers recovered 18 shell casings and all of the windows had been shot out. The officers further observed a bullet hole in the window next door, which is a hair salon that was occupied at the time of the incident. The officers interviewed the manager who stated they believed this incident and an incident on 04/05/23, were the result of a dispute with their promotor and a canceled performance. Due to the fact the "no" box on page 4, question 4 of the agent's application had been checked, the business was operating outside of it's Plan of Operation. (3 license premise reports related to this item)
- 15. On 07/03/23 Milwaukee Police drafted and mailed a Notice of Nuisance Premise to the building owner of 715 S. 5<sup>th</sup> St.

Hello,

I am sending this email out of pure disappointment in the public safety and protection of the citizens of Walker's Point in District 2.

A few months back, when Hex Night Club submitted their liquor license renewal, an objection out of pure concern with our safety in the neighborhood. While I didn't know if my objection would make any headway, I thought the numerous 911 calls from people in the neighborhood would have, OR maybe the drive-by shooting that happened a few months back would have had some influence on this club being shut down. Clearly, no one takes those matters very seriously because here we are 3 months later, with no action, witnessing ANOTHER drive-by shooting at the club. This time in BROAD DAYLIGHT with countless citizens out and about on a Saturday morning just trying to shop and enjoy a meal with their families. At 11 am, in BROAD DAYLIGHT, a car pulled up in front of the night club yesterday, 7/1, and lit up the night club with 20+ shots. At first people were unsure what was going on but it was so ungodly loud that you couldn't help but immediately be concerned and know that it was close. When we all realized what just happened and that they were in fact gun shots, everyone was immediately TERRIFIED. People started scrambling throughout the neighborhood rushing to their cars with pure terror, unsure if terrified that that they were safe. Luckily, was safe in my shooting just happened

Now living in a city, I understand that things can happen and gun violence is a strong issue in our country today, but an 11 am attack on a night club that's not even open, and not even the first attack in 3 months, but the second, is a MAJOR issue. Whoever shot up the nightclub is CLEARLY sending a message to the business or the owner or whoever. It was a very obvious, calculated attack. No citizens were hurt thank God, BUT anyone who is willing to come out in broad daylight with people EVERYONE and shoot up a club is clearly also very capable of who knows what else when the sun goes down. ENOUGH is ENOUGH. WHEN IS ACTION GOING TO BE TAKEN. This club has brought NOTHING BUT TROUBLE to the neighborhood in just the that I have lived here, I can't imagine all the mess and chaos it has caused for as long as its been open.

The <u>WORST</u> part of the matter, and why I KNOW the district is not taking this serious enough is that the nightclub boarded up the windows and **opened for business** the SAME NIGHT of the shooting!?? There is still an active police investigation going on and it was allowed to open the same night for business? My fear is that the district won't take action until its too late and will have a lot worse to answer to than an owner upset for losing his business. Now, I would absolutely <u>never</u> push for a person to lose their business or livelihood just because. I cant imagine all the time, money, and dedication that goes into running your own business, but the citizens of district 2 shouldn't have to lay in bed at night, holding their breath, terrified, every time they hear a tire squeal night. Who wants to live in constant fear like this?

WE as a community need answers what is being done about this because this CANNOT keep happening. I had to watch the news anchor interview a **13 year old** about the shooting. A 13 year old should be able to be outside, playing with his friends on the sidewalk, without having to worry about getting shot in a residential area. This street is no place for a night club, one, much less a night club with countless incidents and strikes on its belt.

I would like to submit an objection for the Hex Nightclub Alcohol License Renewal on the basis of the safety and welfare of the public and the neighborhood of Walker's Point. I moved Only being in this the nightclub, numerous dangerous and chaotic acts from the patrons of the club. I have not had a problem with the noise from the night club itself, but rather the chaos that the customers of night club bring to the neighborhood. so everything that happens outside of the club, numerous street fights, intense speeding down the street, people hanging out of moving car doors while screaming and blasting music at 3 am (on week nights, might I add), blatant driving under the influence, and the worst of all was just a few weeks ago there were cars drag racing. This all taking place between the hours of 1:30-3 am with people going to and from the club after close. The incident of the cars drag racing was so severe that I had to call the police out of fear that someone was going to die or get severely injured. That night, a group of individuals left the Two cars moved off to club and headed to their cars which were parked the side streets and started blasting music, while two cars backed up and started racing down the street from Bruce to National, would circle back around the block and continuously race out of control. This caused not only an insane noise disturbance at 3 am on a week day, but the street already is not very wide to begin with and there were cars lined up and down on both sides of the street making it even narrower. The drivers (who very well could have been under the influence of alcohol and/or drugs after leaving the club), were speeding so fast while numerous individuals were leaving the club and walking the streets. God forbid someone wasn't paying attention or was under the influence from the club and walked into the street, they would not be alive today. The drivers also could've easily lost control of their cars and crashed into other cars, buildings, people, etc. My fear is that one day the danger will turn deadly for an innocent bystander or multiple people. I keep trying to give this club a chance by not calling the police, although multiple incidents where I especially those could have, but it's gotten to the point where others do not feel safe. With the club open for what seems to be 5 nights a week, residents don't even have the opportunity to feel safe for more than half of a week or even get a good, peaceful nights sleep. Whether it's been the noise at ungodly hours of the morning on week nights, the fighting, the car racing, or anything else, it is just sad that this great community is getting so effected by the terribly, irresponsible night club customers with zero regard for others. The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/14/22 at 1:30am, Milwaukee Police conducted a license premise check at 715 S. 5th Street. The only violation observed was the officers observed people smoking inside the establishment. The applicant was cooperative.
- 2. On 03/04/22 at 12:34am, Milwaukee Police conducted a license premise check regarding a parking complaint at 715 S. 5th Street. Officers interviewed a Milwaukee Parking Enforcement Supervisor who stated he heard that the tavern charges patrons to park on the public street. Officers did observe cones blocking off a parking space and security for the establishment stated that they were the businesses cones and picked them up when asked by police to remove them. Officers interviewed the applicant who was cooperative but he stated the cones were not the property of the tavern. He said that they do not charge people to park in the street and blamed a subject across the street for the rumor. The subject across the street said he parks vehicle in a private lot and the cones belonged to the tavern at 715 S. 5th Street.
- 3. On 03/18/22 at 1:27am, Milwaukee Police were monitoring the taverns in the 700 block of S. 5<sup>th</sup> Street when they observed a large crowd in front of 715 S. 5<sup>th</sup> Street. The crowd was arguing loudly, pushing, shoving, and some were being restrained by other patrons. Additional squads were called to disperse the crowd and the patrons left the area driving recklessly. A

- walk through of the tavern revealed a group of patrons still arguing and an odor of burnt marijuana. Security told officers that when they turned on the lights in the tavern a female started a verbal argument with her boyfriend. The applicant was on scene and cooperative.
- 4. On 04/16/22 at 2:29am, Milwaukee Police, while on patrol, heard gunshots coming from the 500 block of W. National Avenue. When the arrived in the area, they were informed by a witness that people were shooting in front of 715 S. 5<sup>th</sup> Street. Officers tried to enter the establishment but found the door locked and after several attempts, that applicant opened the door for police. While inside, officers observed workers cleaning up debris from the floor and the applicant told officers that two females engaged in a fight and were escorted out of the tavern. When staff member were asked if they heard any shots being fired, they said they did not see or hear anything. Officers later found casings in the street and on the sidewalk in front and to the south of the establishment. The applicant and staff were cooperative.

- 5. On 06/26/22 at 4:30p.m., a citizen walked into the District to report a stolen firearm. The citizen stated on 06/26/22 at approximately 12:00a.m., they parked their vehicle in front of 715 S. 5<sup>th</sup> St., and when they returned, a rear passenger was broken and their firearm was stolen from the glove compartment. An officer attempted to retrieve video surveillance from 715 S. 5<sup>th</sup> St.
- 6. On 07/23/22 at 2:40a.m., Milwaukee Police were conducting follow up regarding a separate investigation at 715 S. 5<sup>th</sup> St., when they were advised an employee's vehicle had been broken into and a firearm stolen.
- 7. On 10/15/22 at 9:30p.m., Milwaukee Police conducted a License Premise Check at 715 S. 5<sup>th</sup> St. No violations were found and the employee was cooperative with police.
- 8. On 10/30/22 at 9:30p.m., Milwaukee Police conducted follow up at 715 S. 5<sup>th</sup> St., regarding a fight that occurred in the early morning hours. The employee on scene was cooperative and allowed officers to view video surveillance.
- 9. The security officer stated they understood, however, later in the evening the same problem was occurring and the officer once again had to advise security, to which they cleared up the problem.

On 03/05/23 at 11:58p.m., Milwaukee Police were dispatched to a Fight at 715 S. 5<sup>th</sup> St. Investigation revealed security observed a patron fall and when they assisted the patron in standing, the patron pushed another patron. The security officer escorted the patron out and stated that behavior was not welcome, however, the patron was upset and called the police. The employees were cooperative and no violations were observed.

The manager arrived on scene and stated they recently purchased an ID Scanner that has led to them turning more patrons away, but hasn't had any problems with any one. The manager was cooperative and allowed officers to view video surveillance of the incident.

On Thursday, December 8, 2022, at 1:30 pm, while assigned to Squad 2166, I met with licensees or representatives of Walker's Lounge (Felipe MARTINEZ), Snifters, (Julio MALDONADO), Hex (property owner Larry PACHEFSKY), and Hamburger Mary's (Ashley WRIGHT) and Walker's Point Association President, Simmi URBANEK, at Arts @ Large, located at 1100 S 5th St, in order to discuss common problems between the taverns on S 5th St and to work together to find solutions that would benefit the customers, residents, and taverns. The licensee for Hex, Eric WHITELAW, was invited but did not attend.

Attendees discussed the issue with thefts from motor vehicles, patrons being allowed to leave taverns with food/alcohol, traffic flow, noise, littering and other nuisance behavior of patrons departing businesses. Attendees were reminded that the behavior of patrons after they have left a tavern is reflective upon the tavern and that patrons should be monitored after leaving the tavern.

Attendees discussed the issue of parking and traffic flow on S 5th St at close of business. It was suggested that the taverns share closing time information with each other so that a tavern(s) that is not busy on a particular night could close earlier in the night to allow the busier tavern that night to have space to let customers out. Attendees were encouraged to contact the City of Milwaukee to have a traffic study done and to possibly limit the flow of traffic in the area (S 5th st and surrounding east/west streets) to limit traffic congestion.

Attendees discussed sharing security personnel/and/or knowledge in real time related to ejected or troublesome patrons so that a patron could not be ejected from one tavern and simply enter another in the area. Attendees also discussed the possibility of hiring off-duty MPD officers to patrol the S 5th St area as an "extra-duty" assignment. Attendees stated that they were generally content with MPD's current presence level in the area.

Attendees also discussed the idea of bringing back the "S 5th St Festival" in 2023.

This report is written by Police Officer (P.O.) Quentin C. ARNOLD, assigned to District Two, Late Power Shift, Squad 2432 partnered with P.O Antwan POWELL. Officer POWELL and I were equipped with an AXON body worn camera, which captured this investigation.

On Wednesday, April 5th 2023 at approximately 8:41 P.M., Squad 2432 Officer POWELL and I (While in full duty Milwaukee Police Uniform with the Milwaukee Police Badge on our outer most garments, operating a marked Milwaukee Police Squad 254 equipped with operating emergency lights and audible siren) were dispatched to a shots fired at HEX NIGHTCLUB at the address of 715 S. 5th St. located in the City and County of Milwaukee, WI.

Officers were in the area prior to shots fired and broadcasted the approximate shots fired location, followed by a citizen calling in an additional shots fired call. Officers located HEX NIGHTCLUB shot into several times in the front of the building. Responding Officers were able to enter through the broken front windows and successfully clear the building without locating anybody inside.

We contacted the business agent WHITELAW, Eric and informed him that we need someone from HEX to respond to their establishment. WHITELAW stated that he was out of town in Chicago but, he will be contacting other managers to inform them to go to HEX. Shortly afterwards WILLIAMS, Carl who is part owner and manager, along with another manager RHODES, Romiesha arrived on scene.

Upon their arrival I spoke to both managers and asked if there has been any issues that would cause someone to target their business. Both stated that they've had no issues and security hasn't had any issues with patron's ether. WILLIAMS stated that they recently installed an identification card reader which has caused them to turn away more patrons but nobody has created a scene.

WILLIAMS then allowed us to look at camera footage which captured the incident in the front of the business. The video footage allowed us to see an unknown male subject walk past the business northbound before turning around and walking southbound and shooting into the business eleven times. The cameras in the front of the business were damaged during the shots fired and are no longer operational.

WILLIAMS was cooperative throughout the entire investigation. There were no violations observed.
