Pursuant to Chapter 92-10 of the Code of Ordinances of the City of Milwaukee, you are hereby commanded to appear on January 19, 2010 at 8:30 A.M. at a hearing before the City's Licenses Committee to be held in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin to show cause why your Precious Metal and Gem Dealer license should not be revoked or suspended. The hearing is being initiated because of the City of Milwaukee's receipt of a signed and sworn written complaint filed by the Chief of Police seeking the revocation of the Precious Metal and Gem Dealer license issued for your establishment located at 1306 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin. A copy of this complaint is attached hereto. You are also being provided with a copy of sec. 92-10 of the Milwaukee Code of Ordinances.

On January 19, 2010 at 8:30 A.M., you will be given an opportunity to speak on your own behalf, and to respond to and challenge any charges or reasons given by witnesses at the aforementioned hearing in support of a revocation or suspension of your license. You may present your own supporting witnesses, under oath, at this hearing, and you may also confront and cross-examine opposing witnesses. If you wish to do so, and at your own expense, you may be accompanied by an attorney of your own choosing to represent you at this hearing.

If you, Firdous Chandani, fail to appear in person before the Committee on January 19, 2010 at 8:30 A.M. in Room 301-B, of City Hall, as required by the Summons, the Committee will proceed to consider the allegations of the Complaint, which allegations shall

be taken as true. If the Committee determines that the allegations are sufficient, the law requires that the license shall be revoked or suspended.
