Dear Alderman D'Amato:

This case is an action brought pursuant to Wis. Stat. § 74.37 for allegedly excessive real estate taxes imposed for the year 2005. The plaintiff and the City have reached a settlement whereby the 2005 assessment of the taxpayer's property will be reduced from \$912,500 to \$811,250. This settlement was reached after a careful review of the taxpayer's property by the Assessor's Office. We recommend the approval of this settlement which will be memorialized by a stipulation and order signed by the court. This stipulation and order would require the City to refund the difference for the tax year 2005 with interest to the plaintiff within 30 days of the judge's signing the final approval of the settlement. The amount of this settlement will be \$2,480.51, plus statutory interest as of the date of payment. Plaintiff was originally claiming a refund of \$4,961.02 for 2005. Such City funds would come from the Remission of Taxes Account. Please do not hesitate to contact this office if you have any questions or concerns.
