Dear Honorable Aldermen,

We, the undersigned submit this petition to your Council, to show our support for the proposed "Police In Taverns" ordinance, despite the official stance of the Milwaukee Police Association, which would allow police to provide security for taverns, as an overtime initiative.

We submit this petition with the understanding that this initiative will be on a volunteer basis and not a mandatory assignment. We are aware and understand that similar operations like this are currently being conducted in several US cities and are proved to be successful.

We feel that our concerns were not fairly represented by the Milwaukee Police Association when the Association made their official comments outlined in the Milwaukee Journal Sentinel. As stated in the article, Vice President Thomas Fischer made the comment; "there's no support for it among the rank and file". From the several signatures submitted, that statement is obviously not true.

We feel that during a time of overtime crackdown, this initiative would allow for officers to work the desired overtime at the expense of tavern owners rather than from city tax dollars. It would provide a service to not only the taverns but also the public, by warding off such violent crimes and quality of life threats that surround a tavern environment. It seems to us that everyone wins with this ordinance.

We thank you for your time to review our petition. We hope that we, together, can make another avenue of approach in the fight on crime, which has been plaguing this city. We look forward to your vote for this ordinance with our concerns in mind.
