To Whom It May Concern:

I am writing to you regarding the most dangerous cab ride ever.

Cab driver attempted to take me out of the way in an effort to secure a higher fee. When I spoke up, immediately he began to belligerent me by acknowledging I had been drinking by saying "you drunk, shut up". I had used same service for drop off and the cost was \$12.00, and with pick up fee was \$12.25. Had I not spoke up I am sure it would have been higher.

When the time came to pay I inserted credit card in chip reader, he said came up invalid. I knew card was valid so inserted again he said invalid again. I opened door to exit he began to drive while my foot was on the ground at an accelerated speed for about half block screaming I am going to take you to the police station. Grant you I am a senior citizen, and was being dropped off at a known senior building.

Upon arrival to police station I gave cab driver same card in presence of officer. In retrospect the chip reader wasn't working. Driver so unprofessional and angry I would not let him take me out of the way, he had not the ability to try the card himself initially. Office was extremely apologetic as well as providing me with information as how I could make a complaint.

On 09/16/2017, I experienced the worst cab ride ever. Driver tried taking me for a ride (cash up). I spoke up immediately. Just as quick driver began to belligerent me by acknowledging I had been drinking. He screamed at me "you drunk, shut-up."

Took me home, I inserted card for the \$12.25 fee, (whereas previous ride same distance cost 12.00) he said came up invalid. In that I knew card was valid I opened door put foot on ground and he drug me from back door of Westlawn Garden parking for seniors for about half a block screaming I am going to take you to the police station. We went to police station I used same card by swiping as your card chip insert obviously was not working, in retrospect.

I was greatly inconvenienced. Also I am of age to drink, do have auto, knew I was going to be drinking and decided to be responsible and use your service as I had done before and still will because you come quick to area. I was not drunk. Officer called me another cab and was extremely apologetic. A fifteen minute ride turned into a two and a half hour ordeal.

Please be advised that I am disputing fee.

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
