There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Dear Members of the Licensing Division and Common Council,

On behalf of the capress our concerns regarding the renewal of the Food Dealer's License and Extended Hours Establishment license for the BP gas station located at 27th and Lisbon. Our community has long struggled with issues stemming from the station's operations, including loitering, panhandling, public drug use on the premises, and disturbances, particularly during after-hours. Despite being a key location in the area, the station's condition and management practices do not meet the standards we hope for in our neighborhood.

Residents have consistently observed troubling behavior on the property that disrupts our community's sense of safety and comfort. Visible drug use and incidents of disorderly conduct have become distressingly common, especially after hours. The absence of security on-site has allowed these issues to persist unchecked, creating an environment where problematic behavior is not only tolerated but appears to go unaddressed. As a result, many residents avoid this station altogether, and those who do patronize it feel increasingly uncomfortable.

The state of the property further amplifies these concerns. Litter regularly accumulates on the grounds, and the gas pumps are often dirty or in visible disrepair. Such neglect signals a lack of commitment to cleanliness and order, which in turn contributes to the atmosphere of disregard that encourages the problematic activity we frequently see on the property.

Though we have noticed some improvement in recent weeks, we are concerned that this positive shift may be tied to the timing of the license renewal application. Our community deserves consistent, year-round attention to these issues—not just improvements timed around licensing deadlines.

In light of these concerns, we respectfully request that the following conditions be made part of the license renewal process:

- Regular Maintenance and Cleanliness Standards: Require the station to adhere to a
  daily schedule for litter removal, pump cleaning, and basic property upkeep. Routine city
  inspections would help enforce these standards, ensuring the station maintains a
  welcoming and orderly environment.
- Proactive Security Presence: Mandate a visible security presence on the premises, especially during extended hours, to deter loitering, panhandling, and other disruptive activities. Trained security personnel could help prevent issues before they escalate, improving the safety of patrons and surrounding residents.

 Commitment to Sustained Improvements: Condition the license on year-round compliance with cleanliness, security, and conduct standards. We recommend regular city check-ins or unannounced visits to verify ongoing adherence, ensuring that positive changes remain in place well beyond the renewal period.

4. Enhanced Beautification and Community Investment: Require the station to invest in landscaping improvements, such as adding greenery, maintaining flower beds, or installing other beautifying elements on the property. Such enhancements would signal a commitment to the community's well-being and help foster a more inviting, family-friendly environment.

5. Community Liaison: Encourage open communication between station management and a designated representative of the raised and addressed promptly. A formal liaison would foster accountability and support collaboration in maintaining neighborhood standards.

By implementing these conditions, the BP station at 27th and Lisbon would demonstrate a commitment to operating as a responsible business and valued community partner. We are confident that with sustained effort, this location can be transformed from a source of concern to an asset for residents.

Thank you for your attention to this matter and for considering these concerns and suggestions as part of the license renewal process. We are hopeful that these measures will contribute to a safer, cleaner, and more positive community environment.

Dear Licensé Division Committee:

I wish to express my opposition to granting extended hours for both service stations/convenience stores located at 2624 and 3033 W. Lisbon Ave.

(just south of Lisbon Avenue) since 1988, thus the last 36 years. To live here is to accept the daily reality of sex work, drug dealing, and never-ending trash in our streets. Lisbon Avenue (and the surrounding residential streets) is a trash filled, sex work and street drug market from N 27th to N 35th Street and is visible for everyone to see. During my time here I have eagerly embraced multiple efforts to combat those challenges, but over time I have lost hope of impacting the 24/7 sex work or drug dealing.

I do, however, pick up the trash on the street, boulevards and vacant lots along Lisbon Avenue from just east of 27th St. to 36th St. starting at about 6:00 a.m. every Saturday and Sunday morning, weather permitting. I long ago learned that if I want something done, and I can do it, I just need to do it myself, and litter I can handle. The litter generated by these businesses is never ending, and from what I observe, there is little effort by the business owners to do anything about it. During these mornings on the street, the foot and vehicular traffic from the sex workers and drug dealers is constant. Avoiding violence (directed at others, not me, usually) is a part of my regular routine.

I also drive by each of these locations at 5:45 a.m. every weekday heading east, and the foot and vehicle traffic is constant, and it appears to be about much more than purchasing gas.

Reaearch has shown that sex work can only thrive where the sex workers have access to convenience stores. The stretch from 2624 W Lisbon to 3033 W Lisbon with their extended hours, along with the liquor store at 29th Street (opens at 8:00 a.m., closes at 9:00 p.m.) creates the perfect ecosystem for sex work and the street drug market to thrive 24/7.

Denying extended hours will not solve the problem, but it is one tool the city can use, and that those of us who live this life daily can hope will lessen the problem.

My wife and I

down the street at 34th and Lisbon and live very nearby.

We oppose a renewal of extended hours At BOTH 2624 and 3033 W Lisbon Ave for multiple reasons. Longer than any of the years and operated a business for over 1- we've lived in : current 24/7 operations. The times we have had most problems have coincided with out-of-control illegal street life, which coincides with 24/7 operations in our neighborhood. During years that area businesses operate within the guidelines of non-24/7 "good neighbor agreements" our neighborhood is at its best. The last time this occurred was in the mid teens (2016+/-). The long slide coincides with variances permitting 24/7 operation, erratic security and poor business practices.

2-Over the years of operation, no matter who owns and manages the 24/7 businesses, they ultimately cater to a culture of 24/7 street-based night life that is very disruptive to our community. I used to get gas at 3033. No more. We don't have a 3-shift workforce that needs gas, chips and soda pop 24/7.

3-Many of our customers comment on activities seen around BOTH 3033 W Lisbon and also 2624 W Lisbon AV. The overnight traffic that supports illegal drug dealing and human trafficking is frequently a closed loop between 27th and 35th St, resulting in high rates of criminal activity and chaotic traffic as well as tremendous quantities of trash. I frequently drive east, departing and returning early mornings. Rarely do I see cars pumping gas though the pumps are tied up with cars with trunks and doors open and frequently girls hustling near sidewalks. This is the business they permit to occur on and near their properties.

When allowed to persist, the streets become unwalkable due to pimps, John's and prostitution/drug-muling, leaving it uncomfortable and unsafe to walk to school or even wait for a bus. My tenants prefer the take their car to the community garden a block away so as not to be harassed by cars trolling neighborhood. My employees who must walk past these businesses to get a bus are harassed daily.

A customer recently noted, "it's no surprise that Lisbon and Greenfield Ave have similar problems". 24/7 operations have a direct link to high vacancies, high transitory rental and higher rates of percapita criminal activity. Perhaps this isn't a new phenomenon to Lisbon, as many point to x-rated Parkway Theatre (owned by 2 brothers from Racine) as the turning point in the 70s but the point remains that such disruptions import more problems.

4-It is not the responsibility of MPD to solve this problem alone. It is the responsibility of businesses to conduct themselves in a fashion that does not disrupt family's peaceful enjoyment of their residence; rental or otherwise. For the sake of our business and community, please deny extended hours renewals to BOTH 3033 and 2624 W. Lisbon.

- 3. On 12/29/14 at 11:12 pm, Milwaukee police responded to 2624 W Lisbon Avenue for a ShotSpotter that occurred at 1843 N 30<sup>th</sup> Street. Investigation revealed a vehicle left N 30<sup>th</sup> Street at a high rate of speed and entered the parking lot of 2624 W Lisbon. The driver exited the auto and walked into the store, despite officers ordering the driver to stay in the car. The subject then entered the gas station and officers observed the subject walk to one area of the store and shortly thereafter, exited and attempted to re-enter his car, when officers arrested him. An officer entered the store and could smell a strong odor of marijuana and based on his observations of where he last saw the subject at, walked over to that area and observed two clear plastic sandwich bags containing an off white chunky substance, suspected of cocaine, placed inside of a Munch peanut butter box. Police also viewed video surveillance of the incident. The substance tested positive for cocaine. The suspect was found to be in possession of \$4,263.50, that is consistent with that of street level sales.
- 4. On 11/14/2015 a 17 year old working in conjunction with Milwaukee Police Department and Wisconsin WINS was able to purchase a Swisher Sweet Cigarillo from the clerk at Lisbon BP, 2624 W. Lisbon Av. The clerk admitted to the sale. The applicant was mailed a letter to enroll in the MARTS program.
- 5. On 11/14/15, applicant was cited for Sale of Cigarettes to Minor/Underage at 2624 N 26<sup>th</sup> Street.

6. On 12/29/2015 at 12:26am officers were dispatched to 2624 W. Lisbon Ave for a ShotSpotter call. A call was also received from the business for shots fired. The applicant stated to officers a fight started by the door and he heard several shots outside. The applicant provided the officers with video of the incident. The video showed occupants of two different autos getting into an argument by the front door. One of the subjects runs back to his car and appears to be pointing something at the other auto. Nine casings were recovered in the area that subject was standing. All subjects fled prior to police arrival. Milwaukee Police Department report # 15-363-0008 was filed.

- 1. On 03/27/16 at 3:21 am, Milwaukee police were dispatched to 2624 W Lisbon Avenue. Investigation revealed a subject inside the station had a gunshot wound to the right shoulder. The victim has entered the station to make a purchase and when exiting, the suspect came from behind the gas pumps and pointed a gun at the victim and fired from close range, striking the victim. Both subjects began to fight with the suspect fleeing from the area. The incident was caught on video surveillance. Officers were unable to make contact with the owner of the premise.
- 2. On 01/05/17 at 9:03 am, Milwaukee police were dispatched to 27<sup>th</sup> and Lisbon for a battery complaint. Upon arrival, police located the victim on the sidewalk in the 1800 block of N 27<sup>th</sup> Street. The victim suffered traumatic injuries to his head and despite lifesaving measures by MFD, the victim was pronounced deceased at the scene. Investigation revealed the victim was an employee at the Lisbon BP located at 2624 W Lisbon. Video surveillance captured the victim confronting the suspect as soon as the suspect entered the premise. It appeared that the victim ordered the suspect to leave the store. The suspect then grabbed several items from the premise and headed for the door. The victim and suspect engaged in a brief struggle, and the suspect broke free and ran west across N 27<sup>th</sup> Street. The victim, who was carrying a baseball bat, chased after the suspect. The two went out of camera range but came back into view and in the distance, the suspect could be seen striking the victim while he is on the ground. A witness observed the incident and provided a statement to police.

3. On 09/21/2017 Milwaukee police conducted a drug related investigation at 2624 West Lisbon Avenue. During this investigation, officers observed a suspected hand to hand drug transaction and conducted several field interviews. The result of this investigation included the arrest of two subjects for Possession with Intent to Manufacture, Distribute or Deliver Cocaine or Cocaine Base. Milwaukee police incident report #172640187 filed.

4. On 06/17/2017 the applicant was cited in the City of Milwaukee at 5758 W. Appleton Av for Sale of Cigarettes to Minor/Underage.

An employee stated they saw the subject laying on the ground when they arrived to work.

On Thursday 10/12/2023 at approximately 11:16PM P.O Richard TOLENTINO and I arrived on scene located at 2624 W Lisbon Av which is located in the City and County of Milwaukee for a shooting. Upon arrival I started to canvass the area in search for witnesses. I came across an unknown female who wants to remain anonymous on the sidewalk in-between the gas station and the street, the unknown female stated that she seen 2 male subjects wearing black/dark gray sweats run westbound on W Lisbon Av after shots were fired. No other witnesses were found. I then helped fellow officers locate spent bullet casings and bullet fragments in the area and placed markers/cones on all casings and fragments that were found. SGT Rebecca Wallich asked me to reach out to the caller who called this in to dispatch via telephone to gain more information of what has previously taken place. Upon speaking with the caller, she provided little to no information about her identity and about the shooting and stated that I refer to the cameras in the business to get all the information I need. She did say she was in the gas station while the shooting took place but didn't want to provide any further information.

CIB conducted follow up interviews and processed the scene, several bullet fragments and casings were recovered.

I did not view any camera footage of the incident but attached if Officer Williams' review.

On Thursday, October 12th, 2023, squad 3240 (myself, and P.O. Deja SLOAN) were dispatched to the residential area of 2700 W Lisbon Ave (which is in the city and county of Milwaukee, WI) for a shooting complaint.

Upon arrival, we helped secure the scene and then went on to view the incident as recorded by the gas station where this incident occurred at. I observed four-five individuals who either aided in this shooting incident or spoke with the individuals who conducted this shooting incident. Due to this, when a shooting victim showed up at St. Joseph Hospital around the same time, I then went there to see if the subject matched the description of a would-be second victim or one of the suspects.

Upon arrival, I observed the same red underwear that one of the shooters wore at the time of the incident to be in a chair in the room with the gunshot victim. In this same chair was also the same black pants the shooter was observed wearing as well. The subject had a mask on at the time of the incident but also had the same structural design as the shooting victim as well. This incident came over as a second shooting with a dispatched location of St Joseph's Hospital but through investigation and video review it was determined it was a second subject shot during the shooting at 2624 W Lisbon Av.

The dispatch notes stated the following: Caller states that 4-5 subjects are soliciting the area, since this morning and are refusing to leave.

Upon arrival I observed a green building with 2 glass entrance doors on the West side of the business. Further observation revealed that the business seemed to be solicited by a subject who was standing in front of the gas station. As I approached the gas station, I did not observe anything out of place, nor did I hear anything unordinary.

Upon entering the business (BP), I spoke to the caller, Paras D SINGH (a/m, 10/28/01) who is an employee of BP. SINGH stated that the business is being solicited, and when he asked unknown subject to leave, the subject replied, "It's raining, and I have nowhere to go."

I reviewed video surveillance footage, which showed the same subject soliciting the business, since the morning of the same day (10/13/23). The video shows the employee asking the subject to leave the premises, which seemed to have caused a conflict, as both the subject and employee were demonstrating aggressive body language towards one another (yelling and pointing). It is to be noted, the time stamp on the surveillance video was in correlation with my iPhone time.

During my investigation, I did not observe any violations in the licensed premise.

The business was cooperative with the investigation.

The business did not have any security guards on scene.

The business had security footage which I reviewed.

On scene we came into contact with Cortez L LOWE (b/m, 04-06-1975) who was identified via Wisconsin ID and accused of soliciting and was still on premises at the time of our arrival. LOWE was asked to leave the premises which he did. A wanted check of LOWE revealed that he had a warrant (#302612-A) with the Department of Corrections for a probation violation. I spoke to the caller, Parasdeep SINGH (A/M 10-22-01) phone number 262-232-4411. SINGH stated on Monday March 2, 2024, he was cleaning the parking lot of the gas station, throwing out garbage. One of the items that SINGH threw out was a 5 gallon bucket. SINGH stated while back inside the gas station, the unknown individual confronted him in regards to SINGH throwing his bucket in the garbage demanding that SINGH retrieved his bucket from the dumpster. SINGH stated that the individual would leave the gas station and return at times to continue causing a disturbance. SINGH stated that at one point the individual punched the glass divider and yelled at him to about his bucket. SINGH stated that the man was creating a disturbance and that he asked the man to leave.

I asked SINGH if any threats were made or if any property was damaged during the incident, SINGH replied that nothing was damaged and that he was not threatened

I reviewed video surveillance which showed the following:

13:31.07- I observed a black male wearing a blue sweatshirt, with a black zip up, a brown jacket, and blue jeans and confront SINGH in the gas station.

13:34.08- I saw the black male yelling at SINGH through the glass separating them before leaving the BP gas station using the south entrance at 13:34.10.

13:34.52- The black male was seen reentering BP gas station in what appeared to be a calm demeanor.

13:35.03- The black male is then observed in the gas station using his cell phone, while continuing to yell at SINGH cause a disturbance. Approximately 4 seconds later he is observed punching the protective glass separating him and SINGH. He continued to yell at SINGH for approximately 1 minute before he is seen leaving the gas station at 13:37.07

On 05-28-2024, at approximately 11:03P.M, P.O Alexander LEITZKE and I (squad 3241) were dispatched to a shooting at the address of 945 N 12th St (Mt Sinai Hospital) located in the City and County of Milwaukee. P.O LEITZKE and I were equipped with Axon body cameras activated.

The male subject later identified as Christopher F POWELL was admitted by MD Alina WINAMS at approximately 10:56P.M.

POWELL stated he was shot in the left forearm by an unknown suspect at the location of 18th-or 19th and W Chambers St on the southside of the street. POWELL then stated he heard glass breaking, individuals screaming, tires squealing, and approximately 20 gun shots. POWELL stated he flagged down a driver who then picked him up and drove him to St. Joseph's hospital in which he never checked in. POWELL stated he was then brought to Mt Sinai Hospital.

POWELL did not wish to provide any further information to officers while on scene.

I then went to the emergency parking lot regarding a female subject whom was related to the gunshot victim (POWELL). The female subject was observed in handcuffs detained for officer safety later identified as Daniell S SMITH (F/B 05-22-1977). P.O STOJANOVIC advised SMITH she was not under arrest and was only detained at the moment. SMITH was observed in distress and tears and stated she shot POWELL in his arm after he threw a brick at her. SMITH stated POWELL is her boyfriend and the firearm used during the incident was not on her person and was inside of her vehicle on the driver side. SMITH described the firearm as a 9mm with red hollow points in it.

SMITH voluntarily disclosed that POWELL threw a brick at her head and she discharged her gun. SMITH stated "you gunna see my gun bullets in him" and "Tired of men fucking with me". SMITH stated she pleaded to POWELL to let her take him to the hospital. SMITH was then placed into the back of the squad car.

While I was in the emergency parking lot I observed the blue, 4dr, Pontiac Grand Prix with a broken rear windshield. I then observed a 9mm casing in the front driver seat placed on top of what appeared to be a seat cushion and a teal and black firearm with the muzzle facing straight up in the air, placed between the driver door and driver seat.

P.O LEITZKE and I reviewed security footage with public safety officers at Mt Sinai Hospital. Security footage revealed a blue 4dr, Pontiac Grand Prix bearing a temporary tag W6846Y, and two occupants inside of the above listed vehicle drive to the Emergency entrance at 10:53P.M. I also observed a male subject exit the vehicle from the front passenger seat while being assisted by three public safety officers in front of the emergency entrance. I also observed the above listed vehicle drive out of the emergency lane and park her vehicle in the west emergency parking lot of Mt Sinai Hospital. The vehicle was parked in the middle of the parking lot facing southbound until P.O. STEINBERG and P.O. ORTIZ arrived at the blue Grand Prix with SMITH located in the driver's seat.

On Saturday, June 1, 2024, at approximately 12:05 AM, Squad 3340, PO Luke ARNOLD and I was dispatched to a Property Damage Complaint that occurred at the BP Gas Station located at 2624 W Lisbon AV, which is located in the City and County of Milwaukee.

Upon our arrival I observed a red 2009 Ford F150 (no Plates) to have broken windows to the driver side, rear windshield, and front passenger window.

I spoke to the caller/licensed premise employee, who identified himself as Harjit SINGH (w/m 01-26-1992) who is the 3rd shift clerk of the gas station. SINGH stated that on May 31, 2024, at approximately 11:18 PM, 5 Juveniles entered the gas station lot and damaged his supervisor's vehicle windows. Which was the 2009 Red Ford F150.

There were no Witnesses on scene.

The business was cooperative with the investigation. The business did not have any security officers on scene. SINGH stated that this incident started after he refused services to a customer who he knows to be a frequent thief within the Gas Station.

I reviewed video surveillance footage -

Video surveillance shows the customer entering the lot at approximately 10:38 PM. She is driving an older model Honda Odyssey. She gets out of the driver seat but does not get gas nor come inside the gas station. She stands out of view behind the gas pump. The customer is depicted as a black female, approximately 30-40 years of age, with black and brown hair, wearing a black tank top, and multi colored pajamas pants.

In the video, a black female, approximately 15-17 years of age, 5'05", approximately 120 pounds, with a black ponytail, wearing a black t-shirt that has "AC DC" in pink on the chest, black shorts, and pink sandals, exits the Honda Odyssey, and enters the gas station. 2 more children, both black females, approximately 4-5 years old also enters the gas station with the 15-17 year old. The 2 younger children exit and go back to the Honda Odyssey while the older child is still inside the gas station.

It appears that there is a conversation with the older child and the gas station clerk at the time, which is SULTAN. It is believed that this is when they are refusing to provide service to the female, who eventually leaves back to the Honda odyssey.

At this time, both 4-5 year olds are observed carrying what appears to be garbage and empty bottles from inside the vehicle and are throwing it inside the gas station. They then go back into the Honda odyssey.

The Honda odyssey leaves the gas station at approximately 11:01 PM and travels eastbound on W Lisbon AV.

At approximately 11:18 PM, (Camera Channel 10) depicts 5 Juveniles running from N 27th St from the north and enters the gas station parking lot. The video shows that at least one of the 5 juveniles is the same 15-17 year old that enter the gas station prior who was refused services. She goes to the passenger side of the SINGH's Supervisor's vehicle, the 2009 Red Ford F150, and begins the tap on the windows with an unknown object. She is unable to break the rear passenger side window but is able to break the front passenger side window. After the window breaks, all 5 subjects flee the scene northbound on N 27th ST.

The actors are described as follows;

Suspect 1- black female, 15-17 years of age, 5'05", approximately 120 pounds, with a black ponytail, wearing a black t-shirt that has "AC DC" in pink on the chest, black shorts, and pink sandals

Suspect 2- b/f, 15-17 years old, wearing all black

Suspect 3- b/f, 15-17 years old, wearing all black

Suspect 4- b/m, 15-17 years old, wearing all black

Suspect 5- b/m, 15-17 years old, wearing all black

While on scene, I observed the licenses posted and they were up to date. During my investigation for this property damage complaint, I did not observe any violations in the licensed premise.

I was able to get a hold of the vehicle owner by phone, who is also the licensed premise agent. He was identified as Aftab SULTAN (w/m 09-18-966). He was cooperative during the investigation. SULTAN stated that he was not on scene during the incident and was advised by his employee SINGH, who told him to call police.

On Thursday, July 25th, 2024, 8:50 a.m., Squad 3120 (P.O. Blaine GRABOWSKI and myself) were dispatched to 1400 East Brady Street, to meet with a caller regarding a Carjacking complaint that occurred at 2624 West Lisbon Avenue (BP Gas station), in the City and County of Milwaukee approximately 3 hours earlier according to the caller.

Upon arrival, the victim, Michael J. DENMAN (W/M 11/05/70), stated that he was traveling to his parent's house in Pewaukee, Wisconsin in his 2018 gray FORD FLEX WI registration #AHZ-9711. DENMAN was unsure of the exact time but knew that the incident had occurred at the BP gas station located on North 27th Street and West Lisbon Avenue. DENMAN did say that the entire incident took place on the northside of the gas station near the east pumps, and that he remembers seeing a fence. DENMAN stated that he has been on a 5 day crack binge and that his life has been spiraling out of control since he and his wife began their divorce. According to DENMAN, he has hit rock bottom in his divorce and is homeless staying in his vehicle in rough neighborhoods of Milwaukee. DENMAN stated that prior to becoming homeless several weeks ago he lived in West Bend, Wisconsin.

DENMAN stated that at 3:30 a.m., he pulled into the BP gas station located at 2624 West Lisbon Avenue in the City and County of Milwaukee, because his vehicle ran out of gas. According to DENMAN he observed three subjects smoking crack behind the gas station on the northside of the lot and invited them into his vehicle. DENMAN stated that a black male 30-40, med complexion, winter hat, all black clothing told him to sit in the passenger seat and put his keys on the dashboard, which he did. The black male then got into the driver's seat and DENMAN asked him for gas money. DENMAN stated he asked the subject not to do anything "bad" to him, at which time the suspect struck him with a fist multiple times on his right cheek and chest. DENMAN could not provide a description of the other 2 suspects.

DENMAN then ran from his vehicle and at this time the suspect chased him on foot and put him in a "head lock". At this time DENMAN was able to break free and ran eastbound on West Lisbon Avenue, and walked to 1400 East Brady Street, where he called for help. DENMAN could not account for the several hours from when he was "carjacked" until he called police at 8:39 a.m. DENMAN stated that he lost his cell phone several weeks ago and could not call for help.

DENMAN had some bruising on the right side of his face but complained of no other injuries. DENMAN was conveyed per his request via Bell Ambulance 439 to Columbia St. Mary's Hospital, ROOM ELS TO TREATION OF THE PROPERTY OF THE PROPERT

23 for further medical assistance.

After speaking with DENMAN, I went to the BP gas station located at 2624 West LISBON Avenue. Upon arrival, I was provided access to the security cameras by staff, at which time I began to search for the incident. I then located the footage of the incident which occurs on 07/25/2024 at 5:49 a.m. and the incident ends at approximately 6:02 a.m. on 07/25/2024. I then took photographs depicting the scene of this incident.

I was let into the space to view the video footage by Parasdeep SINGH (A/M 10-22-01) an employee. While watching the video of the incident, I observed the following take place:

At approximately 5:49 a.m. I observed DENMAN's 2018 gray FORD Flex traveling southbound on North 27th Street, at which time the vehicle makes a left turn into the parking lot of 2624 West Lisbon Avenue, and park at the north side of the gas station at the northeast fuel pump. I observe DENMAN exit his vehicle and approach a group of people sitting near the dumpsters on milk crates on the far northeast corner of the parking lot. DENMAN appears to talk to the subjects for several minutes at which time he returns to his vehicle with some of the subjects that were sitting on the milk crates. At 6:00 a.m. there appears to be a struggle inside of DENMAN's vehicle, at which time he is observed exiting the passenger side of the vehicle. Suspect 1, is observed exiting the vehicle behind DENMAN, wearing a black winter hat, black shirt, blue jeans, and what appears to be gold sunglasses. Suspect 1 begins to strike DENMAN multiple times as both he and DENMAN appear to run south through the parking lot of the gas station, across West Lisbon Avenue, and southbound on North 27th Street out of view of the cameras. After DENMAN flees from his vehicle, a black male, black hooded sweatshirt, white t-shirt underneath, and light colored jeans is observed exiting the vehicle, placing the gas dispenser back on the pump, and then fleeing in DENMAN's vehicle westbound on West Lisbon Avenue.

While on scene, I observed the licenses posted and they were up to date. The business was cooperative. I did not observe any violations while on scene.

On Thursday, August 8, 2024, at 10:28 PM, PO Gregory JOHNSON and I (squad 3431) responded to the BP Gas Station, located at 2624 W Lisbon Ave in the City and County of Milwaukee, Wisconsin for a Shots Fired call for service. Upon arrival, officers located and recovered 34 spent casings in the parking lot of the gas station and were notified of two occupied vehicles (vehicle owners were the callers for police service) that had been struck by gunfire. This incident occurred on 8-8-24 at 10:13 PM at the BP Gas Station at 2624 W Lisbon Ave.

PO Jonathan STEINBERG and PO Ricco DALESSANDRO (squad 3288) and PO David BUI and PO Michael MARX (squad 3289) also responded to assist with the investigation.

Victim Interviews: Milton BLAS-FLORES (w/m, 11-4-81) and Mardelina S SORIA-ESPINOZA (w/f, 12-29-84)

PO-STEINBERG interviewed MARDELINA S SORIA-ESPINOZA (w/f, 12-29-84) and Milton BLAS-FLORES (w/m, 11-4-81), who stated that they were stopped at a red traffic signal at N 27th St/W Lisbon Ave facing northbound when they observed multiple subjects shooting at the gas station located at 2624 W. Lisbon Ave. The victim's stated their vehicle had been struck by gunfire twice. PO STEINBERG observed a bullet hole in the front windshield and front bumper of SORIA-ESPINOZA and BLAS-FLORES' vehicle.

Victim Interviews: Preetkaran SINGH (w/m, 06-19-02) and Fnu GUNJAN (w/f, 01-06-03)

I interviewed Preetkaran SINGH (w/m, 06-19-02) and Fnu GUNJAN (w/f, 01-06-03) outside of their residence at 1818 E Kenwood Bl. SINGH stated that they were leaving dinner at a restaurant and were traveling northbound in the 1700 block of N 27th St. SINGH stated that they stopped at the red traffic signal at N 27th St/W Lisbon Ave when they heard multiple shots fired nearby. SINGH stated that he heard glass shatter in the vehicle and that glass flew everywhere. SINGH stated that he also heard the bullet go past his ear inside of the vehicle. SINGH stated that he immediately turned left to go westbound on W Lisbon Ave to get out of the area, and then drove back to his residence at 1818 E Kenwood BI to wait for police, SINGH stated that he was not struck by gunfire but that he was struck by glass particles from the windshield. SINGH refused medical attention. I observed dried blood on SINGH's face and right arm. I also observed several minor scrapes to SINGH's arms that appeared to be from glass.

GUNJAN stated that they were driving northbound on N 27th St when they heard multiple shots fired and glass breaking from the vehicle. GUNJAN stated that she was also struck by glass. I observed dried blood on GUNJAN's arms and hands as well as several minor cuts and scrapes that appeared to be from glass. I observed a bullet strike to the front windshield of the vehicle. The bullet appeared to have travelled through the windshield, before striking the driver slde headrest and coming to a rest in the rear driver seat.

## Interview of Employee: Harjinder SINGH (w/m, 02-10-92)

PO MARX spoke to the cashier at the gas station, identified as Harjinder SINGH (w/m, 02-10-92). SINGH stated to PO MARX that he heard a lot of loud bangs in the parking lot but thought that they were fireworks. SINGH did not see anything related to the shots being fired outside of the gas station. SINGH was cooperative and allowed PO MARX and I to view video of the incident.

I viewed video of this incident from the BP Gas Station. The video depicts the following:

22:11 - suspects arrive at the gas station and park on the west side of the building.

22:11 - 22:13 - suspects are in and out of the vehicle and are standing in the parking lot as they appear to be looking around the area for someone

22:13:35 - suspects are looking at what appears to be a vehicle driving southbound on N 27th St past the gas station and immediately duck down as if they are avoiding gunfire

22:13:37 - all 4 suspects return gunfire and fire multiple gunshots southbound on N 27th St.

22:13:50 - suspects enter the vehicle and flee the gas station southbound

It should be noted that I was unable to download the video from the gas station's hard drive due to an error with the system. I recorded a copy of the surveillance video with my body-worn camera which was uploaded to Axon.

While on scene, I observed the licenses posted and they were up to date. During my investigation, I did not observe any violations in the licensed premise.

On Thursday August 29th, 2024 approximately 3:00pm I was stopped by a black male, light skin, tall, medium build but in a older model van as I entered the Lisbon BP located at 2624 W. Lisbon . I dismissed his accusations of "I work here" as he was sitting in a stall blocking the gas pumps and walked out from his vehicle with a stack of cash that that was larger then his hand. He stated "It pays well". I figured he was just excited about the money that he had and wanted to boast about his savings. I continued on.

On Friday August 30th, 2024 at approximately 3:34pm I drove into the Lisbon BP located at 2624 W. Lisbon for follow up. As I approached the gas station there was loiters and individuals on the lot and coming and going from vehicles. As I exited my squad car several unkept women started to yell out "Police" "Police". Some of the loiters began to hide their what appeared to be crack pipes and drugs and walk off.

As I continued to walk into the parking lot a black suv rolled down its front passenger window and stated "I'm working". I approached the vehicle as it was claiming to be working in for the Lisbon Bp.

The Driver stated "We just went through this yesterday bro". Yesterday I was stopped by the same black male, light skin, tall, medium build but in a different vehicle. He was now in a newer model black Chevrolet with Indiana Plate 663CY6.

The driver stated he was employed and was working and then I notified him that I would be doing a licensed premise report. The driver who was actively working and making sure no one is in the parking lot stated that his name was Julius M. PHILLIPS (B/M 12-03-84). PHILLIPS stated that he hasn't had an off day in two months.

PHILLIPS while working had a black female who appeared to be under the influence of narcotics and or drugs in the front passenger seat. During the friendly talk a white male approximately 45 years old that was sweaty and pale rose from the back seat of the vehicle. The white male then stated "This is my car, I'm just letting him borrow it."

PHILLIPS appeared to not only fail at his job with loiters and prostitution that is occurring but seems to have an active role in the drug dealing and problems occurring with the gas station.

I observed the Lisbon BP gas station cameras and can see exchange from several other individuals

coming and going from PHILLPS car right behind the gas station.

I spoke to Amrinder SINGH (I/M 01-02-98) who stated that he works everyday from 12pm to 12am. SINGH stated that PHILLPS may work security on third shift with the night guys.

I had to leave for a ShotSpotter that occurred on 27th and Lisbon.

When I arrived back to the gas station to pull video with another officer, The owner of the gas station arrived. I spoke to the owner Identified as Aftab SULTAN (I/M 09-18-66) who stated that he does not have security. I notified him that PHILLIPS claimed that he was working security and that one of his other employees stated that he may work 3rd shift. I notified SULTAN that citizens have stated the gas station workers stated the employees were selling drugs but then complaints that "security" sells drugs. SINGH stated to me and SULTAN that PHILLPS is not an employee he is "security".

SULTAN stated that PHILLIPS is not an employee. SINGH stated that PHILLIPS would always park and loiter at the gas station and then PHILLPS asked to do security.

SULTAN stated that he would like to get a restraining order on PHILLIPS. PHILLIPS does not work at the gas station.

I gave SULTAN, PHILLIPS information as PHILLIPS freely and voluntarily identified himself as a working employee and gave his information. Just in case SULTAN may have forgotten an employee or a manager hired PHILLIPS.

SULTAN stated he would be looking into PHILLPS and possibly get a restraining order.

While on scene, I observed the licenses posted and they were up to date.

Per the district community partnership unit this location is a designated nuisance premise.

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has received, reviewed, and accepted your proposed course of action for abatement of nuisance activities occurring at the premises located at 2624 W. Lisbon Avenue the premises"), pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises.

Be advised that you now have 45 days from the date of this notice of acceptance to implement the course of action. The premises will be monitored during the implementation period and if you follow through and properly implement the course of action, no further action will be taken; except that if nuisance activities persist thereafter, you may be asked to modify and re-submit your course of action for review, and acceptance or rejection.

If you fail to properly implement the accepted course of action within 45 days, and a subsequent nuisance activity occurs at the premises, the premises will be subject to placement of a special charge as a lien on the property by the Commissioner of the Department of Neighborhood Services for the cost of any police services and enforcement.

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.

Dear CPU Officer PO Hudson,

Thank you very much for meeting with us last week. We did an open records request from MPD and reviewed the Call Summary. There are about 73 calls within the last year.

In your most recent letter dated September 9/11/2024 there were 3 shooting incidents that triggered the nuisance letter. All those incidents took place between 6:35pm and 11:00pm. In addition, after reviewing the Call Summaries it is apparent that a majority of the Police response takes place in the afternoon through midnight.

Below are the measures that my client will take to address your September 9/11/2024, nuisance letter:

- 1. As I mentioned at our meeting when I am hired for a business that serves the public, i.e., gas stations, bars and restaurants I have scheduled a meeting at the premises with MPD Community Liaison Officer to discuss additional ways that my clients can mitigate and address issues on the premises. We will schedule such a meeting with you.
- 2. We will train our employees on the protocol when different issues arise. Some like loitering/trespassing our employees can ask the loiterer to leave the premises and tell them the police will be called if they don't leave. Other issues like drug use, guns, violence or similar issues we will have our employees immediately call MPD. Many licensed businesses are concerned that when they call MPD a PA-33 will be generated which will be read at their license renewal hearing and could jeopardize their licenses. We will call MPD when it is necessary regardless of a PA-33 being generated.
- Because it is difficult for one employee to be behind the register and also go outside to address loitering or any other problems, we now have 2 employees so that one can still be behind the cash register and one that can monitor and go outside to address any issues. That additional employee will work from noon to midnight, which according to the Call Summary is when a majority of the problems take place.
- 4. Customers and others will be discouraged from loitering/trespassing outside the property. Our second employee will make sweeps of the outside premises throughout the times that he is working to ensure no one is

- loitering/trespassing and to pick up any litter and to look for any evidence of drug activity.
- 5. We will install a microphone inside and speaker outside so our employee can warn people loitering/trespassing to leave ASAP or the police will be called.
- 6. We will run employees and prospective employees through the CCAP database to see if they have any criminal record and will fire them and/or not hire them.
- 7. We currently have 12 security cameras, 5 outside and 7 inside and will add additional cameras and or redirect the current cameras based upon the suggestions of MPD. Those cameras have or will soon be registered with MPD.
- 8. My client currently has 20 canopy lights and 6 pole lights outside. Per the advice of MPD my client will install additional outside lighting and/or redirect their current lights to assure security and discourage loitering.
- 9. My client will diligently monitor their cameras for signs of problems and will call MPD when necessary.
- 10. My client will add additional "No Loitering" and no "No Trespassing" signs on the premises.
- 11. My client will draft and serve no trespassing orders against identified nuisance persons, such as Julius Phillis, and provide them to you.
- 12. My client will institute a standing complaint with MPD to allow the police department to remove any individuals, such as Julius Phillips, loitering on the property.
- 13. We will Exchange names and telephone numbers with the owners and operators of neighboring premises.
- 14. Subject to these groups being in existence, participate in a local block watch, neighborhood association, and /or business association.
- My client will set up an E-Notify account with the City of Milwaukee to receive emails and notifications from District Three.
- 16. My client will regularly file open records requests from MPD regarding the property.
- 17. My client will remove any signs that are blocking the exterior windows.

- 18. We are currently working with Les Johns, a licensed security guard to try and find a cost-effective way to secure the premises during the most problematic times.
- 19. We will, as needed, make repairs to windows, doors and lights and improve landscaping.

This report is written by P.O. Jonathan STEINBERG, assigned to DISTRICT 3 Late Power Shift, 3430.

On Monday, September 24,2024 at 11:31 p.m., Squad 3430 (myself and P.O. DALESSANDRO) was flagged down for a trouble with subject at the BP gas station located at 2624 W. Lisbon Ave..

Upon our arrival I observed security officers telling a black male subject to leave the property. One of the security officers, who was identified as Blair B. HUDSON (B/M, 07/20/95) told the subject to leave the property multiple times. While on scene the subject continued to get close to HUDSON and get in his face outside the gas station near gas pump 3. HUDSON stated he was going to knock the unknown male subject out and then struck the subject in the left side of the face with a closed fist. The unknown black male subject then fell to the ground. Two other unknown subjects picked the subject up and placed him into a white SUV parked at gas pump 4. Due to a large crowd forming we requested additional squads to the scene. Three additional squads responded including a supervisor.

P.O. DALESSANDRO spoke with HUDSON, who stated he struck the unknown subject with a closed fist, because the unknown subject got in his face and yelled at him. HUDSON stated the unknown subject also was touching and grabbing at him. I spoke with the unknown male subject after he became conscious, who stated multiple times he did not want anything and refused to identify himself. The unknown subject also refused medical attention and refused to give his information to MFD. We also spoke with the cashler, who was identified as Sunny SINGH (W/M, 01/26/92), who was cooperative and allowed us to review the video footage of the incident. The business had three-armed security officers on scene. HUDSON did continue to argue with the crowd of people on scene after striking the subject. I advised HUDSON to stop and go inside the gas station. I also advised HUDSON to contact his supervisor and stated he should leave the business for the night in fear of retaliation.

On Thursday, October 3, 2024, my partner (P.O. Blaine GRABOWSKI) and I were dispatched to 2624 W Lisbon Ave to check the welfare of a citizen.

Prior to our arrival, the following was entered into the Milwaukee Police Cad system:

10/03/24 13:03:43 (pct-1505): CLR STATES THERE IS A FEMALE ON THE GROUND, SHE CAN'T MOVE

10/03/24 13:03:51 (fd-1540): WOMAN DOWN 30s

10/03/24 13:05:38 (pct-1505): FEMALE DOWN ON THE LOT, NFI

10/03/24 13:10:46 (fd-1542): PNB

Upon arrival, I observed an unknown black female, later identified through previous encounters as Lindsey MARTICIA (B/F, 5-2-1991) laying in the northwest corner of the parking lot with Milwaukee Fire Department personnel (Truck 9, Lt POTTER and Med 18, Lt ARPS, Red Shift) performing life saving measures. Due to the possibility that MARTICIA was possibly pregnant, Med 18 transported her to St. Joseph's Hospital where she was treated by Dr. BRILLIANT at 1:38 pm.

St. Joseph's Hospital also attempted life saving measures but were ultimately unsuccessful and pronounced MARTICIA deceased at 1:49 pm.

I spoke a witness identified as Anna R DIBBA (B/F, 4-20-1995) who stated she was getting gas at pumped #6, which is located on the north side of the gas station. When she finished, she leaving the gas station and about to exit the northwest entrance, which is when she observed MARTICIA propped up against a tree. She stated that she wasn't breathing at the time and laid her down on her back and attempted life saving measures by conducting chest compressions for approximately 3-5 minutes. DIBBA did state that MARTICIA she found narcan in her purse and administered it to her which was unsuccessful.

P.O. MARX spoke with gas station clerk identified as Sunny SINGH (A/M, 1-26-1992) who stated he arrived at work at approximately 12:30 pm when saw MARTICIA laying on the ground. SINGH did not know how she got there or how long she was laying there. SINGH was cooperative during our investigation and let us view video surveillance of the incident.

#### Camera 4

12:10:27 pm- I observed MARTICIA walking eastbound on W Lisbon Ave across the street. It appeared by the way she was walking she was under the influence of an unknown narcotic. After crossing the street she sits at the bus stop for approximately 1 minute before engaging in a conversation with an unknown black male. The black male was wearing a black jack and blue jeans. It still appeared that MARTICIA was under the influence of an unknown narcotic due to the way she was moving her body around.

#### Camera 8

12:14:08 pm-I observed MARTICIA continue to walk eastbound flailing around. The unknown black male is still engaged in conversation with her. It is unknown what is being said but MARTICIA is flailing her arms while standing on the street (W Lisbon Ave) until she falls down at approximately 12:15:56 pm. The unknown male helps her up but she continues to move her body around in an uncontrolled manner. At approximately 12:17:30 pm the unknown black male grabs MARTICIA and walks her across the parking lot. As they are walking MARTICIA is still flailing around, having a hard time walking on her own.

#### Camera 10

12:18:28 pm-I observed both MARTICIA and the unknown black male walk across the parking lot until she falls down to the ground at 12:19:09 pm and lays on the ground at approximately 12:19:27 pm. She lays down on her back and I observed very little movement.

12:27:13 pm-I observed MARTICIA still laying on the parking lot of the gas station when a black male wearing a green jacket approaches her on a bicycle and checks on her. He stands by her appearing that he is trying to get her up but eventually he picks her up off the ground and moves her to a nearby tree approximately 5 feet north of where she was laying and props her up against it.

1:01:00 pm- I observed DIBBA approach the victim and move her from the tree and attempt life save measures.

At approximately 1:09 pm- Milwaukee Fire Department pulls up and takes over the care of MARTICIA.

It is unknown if MARTICIA was actually under the influence of illegal narcotics at the time of her death. St. Joseph's Hospital listed the reason for treated was she was suffering from a cardiac arrest.

While on scene, I observed the following licenses that all expired on 1/31/25: Cigarette & Tobacco, Weights & Measures, Extended Hours, Food Dealer, and Filling Station. During my Investigation, I did not observed any violations in the licensed premise.

Per the district community partnership unit this location is a designated nuisance premise. The business is currently under an abatement grace period.
