This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/12/22 at 2:46am, Milwaukee Police were dispatched to 3246 S. 27th Street for an entry complaint. Officers interviewed the caller who stated that he arrived at the location to clean at about 1:00am and noticed the back door was slightly open. When he entered the establishment, he observed papers all over the ground and a broken window. He attempted to call his boss and when he received no answer, he locked up the business and left. Officers attempted to contact the owner and when they received no answer, they boarded up the window and left.

2. On 06/06/22 at 11:20am, Milwaukee Police were dispatched to 3246 S. 27th Street for a battery complaint. The caller/ business agent stated that a subject was sleeping outside near the business; the subject woke up approached the owner trying to instigate a fight. The agent went back inside the business fearing for her safety. The subject then proceed to damage the owner's vehicle, which was parked outside. The next day 06/07/22 officers of District 6 dealt with a subject who matched the description of the suspect, at a nearby business. Officers then contacted the business agent to view a photo array, and the agent was able to identify the suspect from the photo array. The Identified suspect was the same individual that created a disturbance and damaged the vehicle at the business on 06/06/23.

3. On 12/22/23 at 4:47pm, Milwaukee Police were dispatched to 3246 S. 27th Street for a threat compliant. Investigation revealed that a terminated employee was threating to damage the premise because she wanted her last payroll check. The applicant was given information regarding a restraining order and both parties were advised.

This report was written by P.O. Szidon MCNULTY, 08392, Squad 6130, assigned to District 6, Dayshift, along with my squad partner, P.O. Kurt SALTZWADEL.

On Monday, 06-06-2022 at 11:20 AM, we were dispatched to a Battery Complaint at the Ned's Pizza 3246 S 27th. Upon our arrival, I talked to the victim, Leanne GRANO and she stated she was standing outside with James GAULKE and they were discussing her business. GRANO stated a W/M, 602, 30-40's, 170 pounds wearing a red hooded SWeatshirt was sleeping about 40 feet away from them in an adjacent mail area. GRANO stated this suspect got up and approached them and asked them if they wanted to fight. GRANO stated this suspect spat at them, but missed and he walked back toward where he was sleeping.

GRANO stated that she and GAULKE, feared for their safety and walked back into her business, Ned's Pizza and locked the front door. GRANO stated the suspect returned with a metal trash can lid and he threw it at her car's windshield which was parked in front of her business in the first designated parking area, which damaged the windshield, causing \$1000 damage. On Tuesday, 06-07-22 at 8:13 AM, Squad 6190, P.O's Sean LESNJACK and Kristopher M MADUSCHA were dispatched to a battery complaint at Walmart, 3355 S 27th. P.O. LESNJAK stated that the Security Guards told him that ZARATE threw bottles and garbage in front of the store, which created a disturbance. P.O. LESNJAK stated Security informed him that they confronted ZARATE and ZARATE punched them in the face, causing pain and he later threw a rock at their security vehicle, which caused minor damage to the vehicle. P.O. LESNJAK stated they later arrested Pedro A ZARATE, W/M, 08-04-83, for Assault and Battery, Cit#J980V8VN3N, Vandalism, Cit#06827HWRJN and Disorderly Conduct, Cit#06827HWRJM and brought him to District 6 to be processed.

P.O. LESNJAK called me to inform me that ZARATE might be a suspect in our incident because he looked at our reports and he has dealt with ZARATE in the past and he has a history of getting into arguments, fighting and damaging property. I contacted my victim Leanne GRANO and asked her if she would come into District 6 to look at a photo array. GRANO came in and identified ZARATE at 12:50 PM as the suspect that created the disturbance and damaged her property on 06-06-22.



Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
