Dear Mr. Owczarski

I am writing this letter because I still feel deeply that Mr. J's Nightclub should have its license revoked or not renewed at its renewal term. In the weeks since August 16th, when I wrote Alderman Rainey, The Mayor, and Captain Birch-District 7 MPD, the email which is embedded in this letter, our neighborhood has seen many better days. Mr. J's nightclub, made some type of change and because of the change we have not had the crowds, noise, public urination, gunshots, car break ins, etc. I have pictures of subsequent Saturday nights when there is no traffic, and the neighborhood is at peace, to the point that people feel comfortable sitting outside on nice nights. I do not believe this is a change which will bring them the type of income that they were used to, and I believe that they could revert to the previous model, without notice to the neighborhood and we would go back to the same problems. The neighborhoods on both sides of Fond Du Lac Avenue are residential and the negative impact of this club is detrimental to the neighbors who reside here. We also are hearing that the new owner of the building that houses Mr. J's, may be looking to add a "grocery" store in its place and wants a liquor license. If they are the owners of another "grocery" store on Fond Du Lac Avenue, grocery is a front for liquor. We do not need any more liquor stores, there are many liquor stores already around us.

I look forward to hearing from you about what the next step in the process is.

Dear City of Milwaukee Officials – I am writing this letter because the time has come for the city to back up the residents who live near and around Mr. J's Nightclub, 4610 W. Fond Du Lac Avenue and shut it down. The licensing needs to be revoked.

Over the weekend we experienced our second homicide outside of that nightclub. It capped off 2 nights of gunfire from patrons at car breaker (the regular occurrence of breaking into vehicles in search of guns and valuables), and whomever shot the man outside of the club.

From August of 2020 when the club reopened after the initial pandemic shutdown, car break ins, public urination, gunshots and shootings, loud music, and litter skyrocketed. I and the rest of my family have watched these car breaker pop window after window out of cars, week after week, then we have to hear the cussing and screaming from mad patrons, which sometimes doesn't stop until 3am. I have called 911 and the non-emergency number multiple times:

After the last murder right before Christmas (2020), the club shut down.

Our objections to this club were ignored and the club reopened on April 1st. Since then, there have been 5-6 shootings that I know of, multiple cars broken into.

My children have had to fall to the ground when they hear the gun shots because we are afraid that these bullets will come through our home. We don't live on Fond Du Lac Ave., but the club is so packed that the patrons park in the neighborhood. It is also now near impossible to get through to 911, and the non-emergency is a 30+ minute wait time to get through, even during hours that you think wouldn't be busy. Now on Saturday night (after a Friday night in which patrons whose cars were broken into, shot at the car breakers – since they were coming from the club or going to it, why did they still have guns on them...), we had another murder. This led to chaos in driving, city buses were route down loud music, horns honking, vigils, and hysterical people at 2:30am screaming, crying, and falling out in the street. A lot of this didn't even end until nearly 4:00am. The trauma is real over here. We lock our gate on the inside at night and reside in the back of the house, we shouldn't have to live in fear like this. Even if we were not in a pandemic, I would not have anyone come over to my home with all of this drama.

This again is a residential neighborhood and the trauma from Mr. J's nightclub is impacting our quality of life negatively. It brings nothing positive to our neighborhood, it is not fitting in with our neighborhood. It is another negative sucking the life out of our area. It is giving our area a bad reputation, which in turn will cause a depreciation in the value of our homes and cause good neighbors to flee and be replaced by others who do not care about living in a decent neighborhood. I am very close to thinking about moving. I love my home and my neighborhood, I have great neighbors, but the stress of knowing every weekend will bring added stress is getting to be too much. We deserve better. The little tax revenue that this club

brings to the city cannot touch the amount of taxpayer dollars spent policing and investigating all the shootings and mayhem that this club brings to our area. At a recent meeting, the club managers admitted that they cannot control their patrons, so why should the neighborhood bear the brunt of this madness. There is no benefit to us. It is a blight on our community.

Again, I stress the license or all licenses of Mr. J's Nightclub need to be revoked immediately and they be shutdown permanently so that our neighborhood can heal from all of this trauma. 2 murders since late December are more than enough, how many more lives need to be lost and how much more trauma should my neighbors, my children and family have to experience?

I would love to hear back from all involved, at your earliest convenience. One last thing. No more new liquor licenses should be permitted, there are more than enough.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. The applicant is on Federal Supervision. Email notification to the United States Probation office on 06/09/2017 requesting they provide information to the License Division regarding the probation/parole status and the end date of the status.

2. On 07/14/2018 officers investigated a shots fired complaint at Mr J's, 4610 W. Fond du lac Av. The investigation revealed the security guard outside got into an argument with a subject who wanted in after closing. The subject physically attacked the guard. The subject then got into a car and attempted to run down the Security guard. The security guard went into the business to get away and the subject drove through the door in an attempt to strike the security guard. The security guard, fearing for his safety, discharged his firearm at the vehicle. Vehicle then fled.

3. On 07/30/2018 officers received a complaint there was underage patrons at Mr. J's, 4610 W. Fond du lac Av. The officers conducted a licensed premise check and did not observe any underage patrons. The manager, Jessica KEY, was cooperative with officers.

4. On 03/03/2019 officers observed several vehicles in the area of 4610 W. Fond du lac Av parked illegally. The officers cited the vehicles and observed patrons of Mr J's exit the bar and enter the illegally parked autos.
5. On 03/14/2019 officers conducted underage tavern enforcement in District 7. An underage Police Aide attempted to gain entry to Mr J's, 4610 W. Fond du lac Av. The Police Aide was allowed entry by security at the door and ordered a beer at the bar. The bartender was identified and issued a citation.
6. On 08/18/2019 at 2:08am officers were dispatched to a shooting at 4410 W. Fond du lac Av. The investigation revealed several casings on the sidewalk in front of Mr J's, 4610 W. Fond du lac Av. The officers interviewed the bartender at Mr J's, who was identified as the applicant. He was cooperative and provided surveillance video. The video shows a patron inside Mr J's, exit and walk back and forth on the sidewalk. Another subject approaches the patron outside and attempts to hit him. The patron retreats and pulls out a gun, firing it at the subject. The video does not show who shoots back at the patron striking him 9 times. The patron then runs off out of camera view.

7. On 01/23/2021 at 8:06pm officers were dispatched to a Tavern Check at Mr J's, 4610 W. Fond du lac Av. The caller stated the business was open with 200 people inside and they did not have a license. The officers arrived and found the business open with approximately 60 patrons inside. The officers spoke with the bartender and requested to see the licenses. They were provided with licenses that expired on 01/21/2021. The bartender was advised to close the bar because there is no business license. The officers were unable to contact the applicant because the phone was disconnected. The business was issued a citation for Distribute Alcohol at Unlicensed Premise.

8. On 04/23/21 at 10:57, Milwaukee Police were dispatched to 4610 W. Fond Du Lac Avenue for a noise complaint. Investigation revealed that there was no violation.
9. On 06/27/21 at 1:36am, Milwaukee Police were dispatched to 4901 W. Hoyt Place for a shooting complaint. Investigation revealed that an unarmed security guard who works at 4610 W. Fond Du Lac Avenue was patrolling the blocks around the establishment when he was shot while patrolling on W. Hoyt Place.
10. On 07/18/21 at 8:44pm, Milwaukee Police were dispatched to 4610 W. Fond Du Lac Avenue for a subject with gun complaint. Investigation revealed that a subject entered the tavern with a rifle and security tackled the subject. When the subject was tackled he discharged one round striking a window. The subject was detained until police arrived. The manager was cooperative throughout the investigation.

11. On 07/18/21 at 5:15am, two subjects walked into the Seventh District Station and reported that they were robbed at 4513 W. Leon Terrance. The subject said they left the tavern at 4610 W. Fond Du Lac Avenue around 2:50am and were robbed at gunpoint a short time later.
12. On 07/19/21 at 5:31pm, a subject reported to police that his vehicle was broken into on 07/18/21. The vehicle was parked at 4401 W. Leon Terrance and the victim walked to the tavern at 4610 W. Fond Du Lac Avenue. When he returned, his vehicle was broken into and a firearm was stolen.
13. On 07/21/21 at 7:45pm, a citizen entered the Seventh District to report his friend's vehicle was broken into while it was parked in the lot at 4610 W. Fond Du Lac Avenue. Inside the vehicle were two handguns and a laptop. A report was taken.
14. On 08/08/21 at 12:46am, Milwaukee Police were dispatched to 4610 W. Fond Du Lac Avenue for a shooting complaint. Investigation revealed that there was no shooting but a boy/girl trouble which was not physical in nature.
15. On 08/15/21 at 12:55am, Milwaukee Police were dispatched to 4610 W. Fond Du Lac Avenue for a shooting complaint. Surveillance footage revealed that a patron of the tavern walked up to a group of men standing on the sidewalk next to the tavern. The patron then punched one of the subjects in the face and the subject walks out of camera view. The patron then gets hit with gunfire in the facial area. He hits the ground and retrieves a handgun from his waistband and discharges it several times. The patron later dies.
16. On 11/19/21 10:55pm, Milwaukee Police were dispatched to 4610 W. Fond Du Lac Avenue for a noise complaint. Officers interviewed the applicant who said he would turn the music down and the caller was satisfied.

On Friday, April 23, 2021 at 10:57 PM, I (Squad 7290 - In full duty uniform, operating a marked Milwaukee Police Department Wagon, equipped with an activated AXON body camera) was dispatched to 4610 W. Fond Du Lac AV. in the city and county of Milwaukee, Wisconsin, in regards to a noise complaint call for service.

On Scene Investigation;

Upon arrival at 11:11 PM at the listed location, I called the caller at; (414) 339 - 6045, later identified as; Theresa C. SCOTT (B/F, 05-08-1972) who stated she lives at 4535 W. Leon Tr. behind 4610 W. Fond Du Lac. Av. (Mr. J's Bar) and stated the bar was playing loud music causing a disturbance. I then drove around the area and did not hear any loud music and then I changed locations to SCOTT's residence. When I arrived at SCOTT's residence I explained to her that the music was not loud and/or causing a disturbance. SCOTT agreed and stated she was more concerned with why the bar was allowed to open again. I then further explained to SCOTT that I could not hear the music at her residence and that the bar was opened by means of a license renewal.

Due to no violation occurring at the particular time I did not enter the business, I did however call and spoke to the Manager - Cyrilene A. BLADES (B/F, 01-14-1966) and advised her that I would need to file a license premises report due to a call for service at the location.

Upon arrival the victim, Edward O HARRIS JR B/M 07-03-1965, was located on the porch of the residence with one (1) gunshot wound to the left thigh. HARRIS JR stated he works for Mr. J's Lounge (4610 W Fond Du Lac Ave) as unarmed security. He was walking on W Hoyt Pl (at approximately 4802 W Hoyt Pl) when he heard what he thought to be fireworks. HARRIS JR stated he heard a loud boom then noticed he was shot. HARRIS JR stated he ran to the address of 4901 W Hoyt Pl because he knows someone that lives there and they would call 911. HARRIS JR stated nothing was happening at the time that would lead him to believe he would get shot.

Mr. J's Lounged has security that patrols the blocks around the establishment. HARRIS JR is one of the security that performs that duty. HARRIS JR was on duty at the time of this incident and patrolling on W Hoyt Pl.

HARRIS JR was transported by MFD MED 5 (Blue shift LT Dennis LEWIS) to Froedtert Hospital.

There were two (2) ShotSpotter's located at 4535 W Fond Du Lac Ave (Flex #81-624377 CAD 21-178-0175 and Flex #81-624378 CAD 21-178-0195) that are possibly related.

There are nine (9) .40 caliber casings recovered at 4535 W Fond Du Lac Ave in the alley.

There are no witnesses to the shooting on scene.

I did not make contact with the owner or establishment of Mr. Jay's Lounge while on scene.

On Thursday, July 21st, 2021 at approximately 7:45 PM while assigned as Desk Officer, Fred A DURR III (B/M 05-08-1985) walked into District Seven to report two handguns and a laptop were stolen out of a friend's vehicle at 4610 W Fond du Lac AV which is in the City and County of Milwaukee.

Interview of Fred A DURR III (B/M 05-08-1985):

DURR stated his friend Eddie C SILAS (B/M 04-30-1984) gave him permission to drive his vehicle, a 2010 red Dodge Ram (VIN 1D7RV1GP9AS149150) WI Truck plate SU7218, on Sunday July 11th, 2021. DURR stated he was parked in the parking lot at Mr. J's Lounge at 4610 W Fond du Lac AV at approximately 9:00 PM - 10:00 PM and entered the business. DURR stated at approximately at 1:00 AM on Monday, July 12, 2021 a bunch of patrons including himself, heard some gunshots in close proximity to the business. DURR stated he ran out to this friend's truck to leave the area. DURR stated he was attempting to roll up a rear window when he looked back and observed broken glass on the back seat. DURR stated he observed the rear passenger window was broken out as well as the rear window. DURR stated he observed his blue zipper backpack was missing from the backseat of the truck. DURR stated he had two firearms and a laptop inside the backpack.

DURR stated the first firearm taken was a Sig Sauer 9mm all black compact handgun, loaded with 12 unknown full metal jacket rounds with an unknown serial number at this time. DURR stated he paid approximately \$500 in US Currency. The second firearm taken was a Ruger 9MM all black handgun, loaded with 17 unknown full metal jacket rounds with an unknown serial number at this time.
