You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

REYES stated this subject makes customers feel uncomfortable and he also walks up to customers parked vehicles and look inside their windows for change. REYES stated this subject also holds up the drive thru line by standing in front of customers vehicles panhandling begging for money.

REYES stated he's told the subject multiple times that he cannot panhandle on private property and the subject stated that he's allowed to.

REYES described this subject as a B/M, mid 30s, 5'7, med build, glasses, missing teeth, white and beige Nike tennis shoes, wearing a black and red sweater.

I was not able to view surveillance video footage of this incident as the staff that was currently working did not have the password to access the surveillance footage.

It should be noted the business was very cooperative.

All of the business licenses were up to date.

I then checked the surrounding areas and did not locate the subject.

This concludes my report.
