Dear City Clerk:


On April 19, 2022 at approximately 6:40 a.m. I turned off Sherman onto Douglas. As I turned left from Douglas into the parking lot at 4200 W. Douglas Avenue in Milwaukee, my car made a loud sound. The tire caught one of the deeper potholes in the center of Douglas Avenue and instantly began to deflate. I was able to pull into the lot of the school where I am employed and call AAA for assistance. They came out about 8:30 a.m. and replaced the flat tire with the spare donut tire while I was teaching.

I called the dealership to confirm they had a matching tire in stock and they had availability to replace the tire at 3:45pm the same day. The receipt and photos are enclosed.

I am requesting reimbursement for the tire replacement of \$421.48, plus any additional city/court/fees/miscellaneous costs relating to the reimbursement of this claim, not to exceed \$50, unless an attorney is retained.

The potholes are extensive in that area and nearly unavoidable. The city put up a cone and barricade in two areas in close proximity immediately on the approach to the single entrance to the school parking lot. In order to avoid the potholes, drivers would need to cross over the center of the road, half into oncoming traffic, to completely avoid potholes on either side of the road. I do appreciate the prompt response in putting up the construction paraphernalia by the very next day. As of this moment, the holes are waiting to be filled.

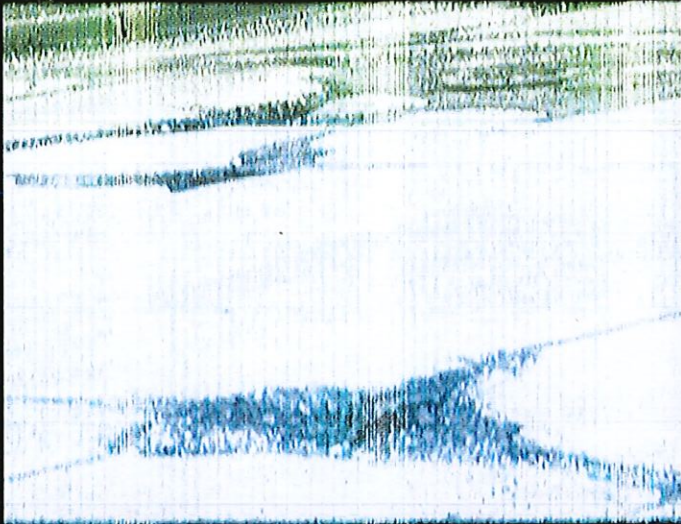
