

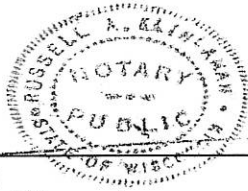

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,153,600 for a total estimated cost of \$1,197,100.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District
N. 37th St. - W. Florist Ave. to W. Douglas Ave. (ST211130123)
File Number 110831: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7' width of tree border area), and grading. (Assessable Reconstruction Paving Fund - \$26,500; Nonassessable Reconstruction Paving Fund - \$305,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2019 construction season.

6th Aldermanic District
N. 12th St. - W. Concordia Ave. to W. Keefe Ave. (ST211180222)
Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$11,300; Nonassessable Reconstruction Paving Fund - \$2,000) The total estimated cost for this project including the requested amount is \$13,300. This project is anticipated to be completed during the 2019 construction season.

N. 16th St. - W. Atkinson Ave. to W. Capitol Dr. (ST211160164)
Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$6,400; Nonassessable Reconstruction Paving Fund - \$2,000) The total estimated cost for this project including the requested amount is \$8,400. This project is anticipated to be completed during the 2019 construction season.

N. 21st St. - W. Nash St. to W. Vienna Ave. (ST211180269) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$4,400; Nonassessable Reconstruction Paving Fund – \$2,000) The total estimated cost for this project including the requested amount is \$6,400. This project is anticipated to be completed during the 2019 construction season.

8th Aldermanic District

S. 25th St. - W. Greenfield Ave. to W. Scott St. (ST211180273) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$7,200; Nonassessable Reconstruction Paving Fund – \$2,000) The total estimated cost for this project including the requested amount is \$9,200. This project is anticipated to be completed during the 2019 construction season.

12th Aldermanic District

S. 11th St. - W. Harrison Ave. to W. Lincoln Ave. (ST211150124) File Number 131585: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (4' width of tree border area), and grading. (Assessable Reconstruction Paving Fund – \$40,000; Nonassessable Reconstruction Paving Fund – \$735,000). The total estimated cost for this project including the requested amount is \$800,000. This project is anticipated to be completed during the 2019 construction season.

15th Aldermanic District

N. 41st St. - W. Meinecke Ave. to W. Wright St. (ST211190114) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund – \$7,800; Nonassessable Reconstruction Paving Fund – \$2,000) The total estimated cost for this project including the requested amount is \$9,800. This project is anticipated to be completed during the 2019 construction season.

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects: N. 37th St. (ST211130123); N. 12th St. (ST211180222); N. 16th St. (ST211160164); N. 21st St. (ST211180269); S. 25th St. (ST211180273); S. 11th St. (ST211150124); N. 41st St. (ST211190114) will be billed after January 1, 2021, but not before 12 months after the project contract has been completed;
