On Dec, 12, 2024, my wife and I, woke up to Raw Sewage and human waste, coming up in our basement, HAZARD waste, with EVERY thing mixed with it.

I go to ACE HARDWARE, to buy a basement Floor plug. When I returned, the sewage has rose to about 1 inch from wall to wall.

This was the beginning of something worse than a NIGHTMARE. This was REAL.

I ~~CALL~~ Called Housing Att. to see if I could get help with this situation. They told me there was nothing ~~they~~ they could do, for me to call Emergency No.

I called the No. they told me they could do nothing, because it was not in the house! I told them the Basement is part of the house.

They said Housing Att, Had me call them because they didn't want to

Deal with it. And they could do nothing to help unless the waste was in the part of the houses ~~were~~ where people lived.

By this time the smell is unbearable. My wife 70 year old
my son 44 year old Handycap
born with Spinal-bifida.
And myself 72 years old.

So I have no help!

I called my Alderman out of desperation.

Mr. Jackson came to my house to see if he could help, he saw my problem and called his plumber to my home. The plumber went to the basement and open the main drain to run a snake. When he removed the lid, waste water shot out under pressure, but he stayed and ran the snake out to the street.

He couldn't find the problem.
He said he went 100 feet out with snake

At this time the SEWAGE LEVEL is now 3 to 4 inches wall to wall.

The Ald. Mr. Jackson stayed there the whole time trying to help.

Fri Dec. 13, 2024

MR. JACKSON RETURNED TO TRY AND help. He called the City to check ~~the~~ the man holes around the ~~AREA~~ home. They told him there was no clog in these lines.

He then called Houeing Att. To send someone out. When they came out, they went through the same process as the plumber had.

With the same results, waste ~~is~~ filling up the basement wall to wall. I now ~~have~~ have six to seven inch. of hazer dust waste, in my basement.

I have a brand new furnace and a brand new hot water in the basement. I have Antick furnisher, clothes shoe's children's clothes and toys in the basement. All being affected in this

The Housing Att. People that came out said they went 160 ft. out and could find no blockage.

Sat, Dec. 14, 2024

The Smell is unbearable!

Mr. Jackson, called the City back out. The Ald. and myself stood outside talking to City Personnel. I tried to inform them that we had a lot of construction during the summer, and I saw some digging going on, on the side of the home. I went out and asked them why they were digging there, and I didn't think it had anything to do with the work being done on Hampton Av.

When they finished I went out and looked. They had covered it with a cover, that said Milw. Police + Fire Dept. When I told the City worker they should check that spot, they told me + Mr. Jackson, they were not going to open it because

it had milw. Police Dept. on the cover.

I asked why would the milw. Police need or Fire Dept need to have some pipe work under ground there in the first place.

SUN, DEC, 15, 2024

my wife and I try to deal with a bad situation. We now have 6 to 7 inch of pure haz. waste in our basement.

We can't use the furnace, or the hot water heater.

I go and buy a ten gal. wet vac. mop + mop heads. Bleach, Disinfectio Squeeges to push the waste.

I tried to hire some young people in the area to help get some of this mess out. No one could deal with it. Two young people tried to stick it out but they ~~can~~ couldn't handle it.

So my wife ~~tried~~ tried to help me set in up hurting her back I in up hurting my arm. My Doctor had told me not to lift nothing bigger ~~than~~ Than a gallon of milk.

I had to go and by 2 electric heater candles + incense.

I have been removing all my possessions that have been destroyed. I have ~~been~~ been hauling away haz. material for five days, and I still have 6-7 inc of haz. waste in the basement.

Mon, Dec. 16, 2024

Tus. Dec, 17 2024

With I and my wife about to panic both hurt, and feeling sick from breathing haz. waste for almost a week.

Wed. Dec. 18, 2024

The lady from the City, called and said, do you still have the plug in your basement. I told her yes

She Said Go and Remove The plug And the waste should start going down. So I did and it started go down.

She told my that they found The ~~the~~ Cause of the blockage and unblocked it.

She said, the people who were ~~digging~~ digging in the place where I pointed out to her almost one week before was where they found the blockage, and they had cleared it. And the people that did the work put the wrong cover over the spot I pointed out 1 week earlier. When they seen police and Fire Dept. stopped them for one week from checking it.

Thur, 19, 2024 until Now
I now have a ugly job To Remove The worse HAZ. waste, That has gotten on almost everything we had in BASEMENT

I hope this NEVER happens again, Because It has been too much to deal with for A, 72 yr old (WIFE) 70 yr old (SON HANDICAP) 44 yr old

I don't know what all we had to buy, I have some receipt, some got taken out with things we cared out.

We also payed people to try and help go get HAZ. waste out. once they took all they could take we payed them and thanked them for there help.

But it all end up on my wife and I.

Her with a hurt back, me with a hurt arm.

I didn't know, how to pay someone to help clear up HAZ. waste material with no protection for them to use.

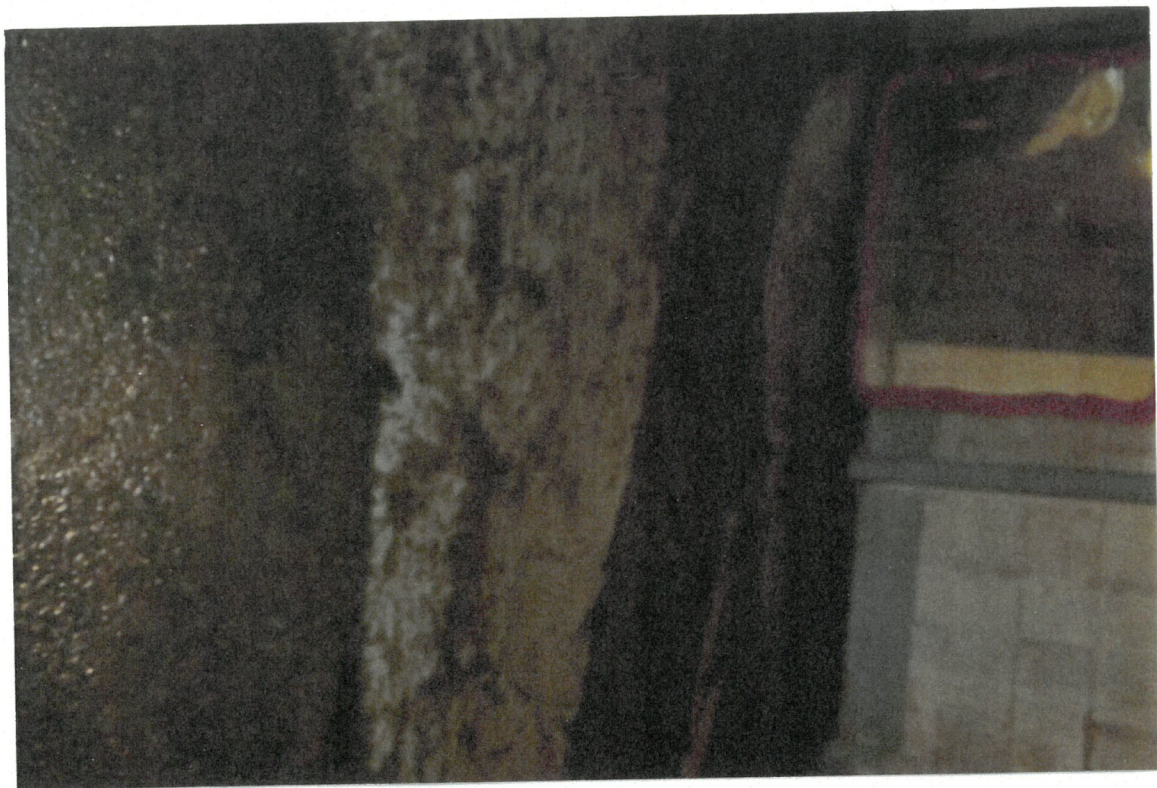
