DATE AND TIME OF EVENT GIVING RISE TO CLAIM:

April 16, 2010 at approximately 11:50 a.m.

LOCATION OF EVENT GIVING RISE TO CLAIM:

On the street in front of 1904 W. Grange Avenue, Milwaukee, WI 53221.

CIRCUMSTANCES OF EVENTS GIVING RISE TO CLAIM:

On April 16, 2010, Vicky was out jogging and as she was running by 1904 W. Grange Avenue (about a block and a half from her home), a large dark German Shepherd looking dog attacked her. Vicky put up her right arm to protect her face and the dog bit her elbow. The dog knocked her down in the street and then bit her right lower back side through her jacket just above her right buttock. The dog was an off duty canine unit attack dog as part of the Milwaukee Police Department. The incident was investigated by Sgt. Richard Jack. The attack dog was not on a leash or under control in violation of regulations.

Vicky Bontempo suffered a puncture wound to her right arm, abrasions on her left arm, and deep scratches and abrasions to her mid and lower right side of her back with additional puncture wounds on the lower right side of her back. Photographs taken by the Milwaukee Police Department depicting Ms. Bontempo's injuries are attached as Exhibit 1.


ITEMIZED STATEMENT OF RELIEF SOUGHT:

Money damages in the amount of \$50,000.00 for the property damage and personal injury to Vicky Bontempo, and damages in the amount of \$50,000.00 for the loss of society, companionship and other losses suffered by Kenneth Bontempo as a result of the injuries sustained by his wife.
