There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/26/24 at 9:02a.m., Milwaukee Police conducted a License Premise Check at 1556 N. 33rd St. Assisting in this were agents from Wisconsin Department of Revenue Alcohol and Tobacco and Department of Neighborhood Services. The following violations were found:

- Sole employee did not have a Class D Operator License
- No invoices for tobacco products (tobacco confiscated)
- Open packs of cigarettes near checkout possible single cigarette sales
- EBT's, Id cards and debit cards (EBT cards confiscated)
- Alcohol invoices not in sequence and separated by vendors

2. On 12/20/24 at 9:28p.m., Milwaukee Police were dispatched to a Shooting. The store was closed on arrival; however, it was determined it was an employee that was shot while enroute to assist with closing for the night. The employee stated they are part owner and attempted to allow officers to view video surveillance, however, did not know the password.
 3. On 02/06/25 at 7:25p.m., Milwaukee Police conducted follow up to view video surveillance regarding an earlier Theft. The employee on scene was cooperative, however, did not know how to access the camera system and stated they would advise the owner.

4. On 07/03/25 at 11:41a.m., Milwaukee Police conducted a License Premise Check. This was in regards to information received from Wisconsin Department of Revenue Alcohol and Tobacco. An Agent advised officers stolen beer was being sold from a U-Haul in the area of the business. The employee on scene stated they cameras were inoperable due to repairs being made on them because a new owner was buying the business. Two pallets of stolen beer were located in the business and seized.
5. On 09/07/25 at 8:32p.m., Milwaukee Police were dispatched to a Property Damage. Officers were advised a subject believed to have left their cell phone in the business, became irate and began to turn over shelves, causing damage. The employee stated the video surveillance were not functional. The officer could not locate the posted licenses.
6. On 09/08/25 at 3:54p.m., Milwaukee Police were dispatched to a Retail Theft. On arrival the employee pointed to a suspect, still on scene, and stated they took items without paying. A search incident to arrest revealed the suspect had a loaded BB gun concealed in their waistband, which was reported stolen.

On Friday, December 20, 2024, at approximately 9:28 P.M., Squad 3450 (P.O. Taylor ZUBE and P.O. Brandon BUELOW) were dispatched to 1556 N. 33rd St., located in the City and County of Milwaukee, regarding a Shooting Complaint. Squad 3211 (Sgt. Nicholas DANKERT) and Squad 3412 (Sgt. William KINGSTON) were also dispatched to the location.

Unknown male caller (920-757-4602) called police and was not answering questions, TC heard a male in the background state they were shot.

Upon their arrival, they observed the store to be closed and no interior lights on inside. P.O. ZUBE and P.O. BUELOW located four (4) 22 caliber casings were recovered in the street. No victim was located at the scene.

At approximately 10:57 P.M., P.O. Gregory JOHNSON and I (Squad 3441) were dispatched to Froedtert Hospital regarding a walk in shooting. The victim, Anton L. HAMILTON (b/m 3-24-1977) advised hospital staff that he was shot at N. 33rd St. / W. Galena St. This location is consistent with the shooting call that Squad 3450 initially responded to.

While on scene at the hospital, I spoke with Pierre O. LEE (b/m 2-18-1987), who stated that he and HAMILTON own the corner store (1556 N. 33rd St.) together. LEE stated shortly before 9:00 P.M., he was en route to the corner store to assist with closing it for the night. LEE stated he called the clerk to advise them that he was on his way there. LEE stated the clerk advised him that HAMILTON was already there to assist with closing. LEE stated he bypassed the corner store and began to head to his residence.

Detectives responded out to Froedtert Hospital and spoke with LEE regarding HAMILTON being shot. Detectives advised LEE that the shooting happened outside of the corner store and asked him about the video cameras on the exterior of the store. LEE advised detectives that there is one camera that works on the exterior and possibly caught the shooting. LEE was cooperative with the investigation and willing to show detectives the cameras. We conveyed LEE from Froedtert Hospital to 1556 N. 33rd St. to review the cameras. The one exterior camera was pointed towards the sidewalk/main entrance to the corner store. Video was unable to be reviewed on scene. Forensic Investigator Jennifer BEAMON (Squad 1926) responded to the scene and attempted to recover video using a USB drive but the DVR was password protected and LEE did not know the password. LEE advised detectives that he would speak with HAMILTON about the password and would let them know once he gets it.

While on scene, I observed the licenses posted and they were up to date. During our time inside the store, I did not observe any violations in the licensed premise.

On 07/03/2025 P.O Jasmine KING and I (squad 3272) conducted a business check at the address of 1556 N 33rd street in the City and County of Milwaukee.

Upon our arrival I observed a white brick building storefront with Galena Street Foods posted in front of the building. Once I entered the business I observed chore boy for sale at the front counter and the camera system done inside of the business. It should be noted Kevin BOOTHE (M/B 10/19/1973) the employee working at the business informed me that the cameras were being repaired due to a new owner buying the business. It should also be noted that I conducted this business check after receiving information from Ashley Schnering, Special Agent State of Wisconsin Division of Alcohol Beverage Bureau of Enforcement who informed me that stolen beer (Modelo Ultra Light) was being sold in the area from the back of a U-Haul. Agent Schnering also informed me that the stolen beer was located in the rear of the store two pallets worth. I was also informed that the store owner did not have invoices or receipts for the stolen beer. The beer was seized from the location.

While walking through the business I observed the business license up to date with the business agent JACKSON, KELLY J posted on the license. I did not observe any other signs of concern inside of the business. This business will be monitored further due to the criminal activity and contraband located at the business by Wisconsin Division of Alcohol Beverage Bureau of Enforcement.

Per the district community partnership unit this location is not designated nuisance premise at this time .

On Saturday, September 7th, 2025, at approximately 8:32 PM, Squad 3230 (PO Robin STOIBER and I) was dispatched to 1556 N. 33rd St, Galena Food and Liquor, which is located in the City and County of Milwaukee, Wisconsin for a Property Damage complaint.

Upon our arrival, we met with the caller Bernice ADAMS (b/f, 09-20-67), who stated that a woman she knows as "Maya/Mya" (b/f, approximately 25 years old, thin build, with red hair) stated that she lost her phone at the above listed location, and demanded to see their surveillance video. ADAMS stated she, along with other employees, looked for the phone inside of the location, however they did not locate it. ADAMS further stated that after informing "Maya/Mya" she did not locate the phone, "Maya/Mya" proceeded to push and turn over shelves with store product on it, with much of the product coming to rest on the ground, pushed a grill onto the ground that was outside of the store causing damage (approx. value \$200.00), and ultimately disrupting the normal business of the store. "Maya/Mya" was not on scene.

ADAMS informed officers the cameras located inside of the store were not functional. Officers advised ADAMS to do what is necessary to make the cameras functional.

ADAMS further stated she was unaware of the location of the business' license to operate, and that her brother, Kelly J. JACKSON (b/m, 12-27-69), is the owner of the business. Therefore, no license check could be conducted.

The business was cooperative during the investigation.

POINDEXTER was then taken into custody. During the search incident to arrest, PO FLORES and I observed and recovered a black BRB Elite 9mm pistol (serial # TG019-22C15728), which had been concealed underneath POINDEXTER's shirt and in the waistband of his pants (front right-side). 17 rounds were in the loaded magazine of the firearm with an additional round in the chamber. A records check revealed the gun reported as stolen
