

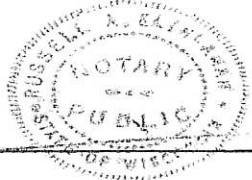

- 151199 - A substitute ordinance relating to revision of various provisions for purposes of correcting errors, clarifying language and eliminating obsolete provisions.
- 151449 - A substitute ordinance relating to the 1st Amendment to a Detailed Planned Development known as Good Hope Industrial Center for expansion of Hellermann Tyton's facilities at 6701 West Good Hope Road, located on the south side of West Good Hope Road, west of North 60th Street, in the 9th Aldermanic District.
- 151546 - A substitute ordinance relating to the change in zoning from Residential Office to a Detailed Planned Development known as 1840 North Farwell Avenue for a mixed use building at 1832-1840 North Farwell Avenue, located on the east side of North Farwell Avenue, south of East Kane Place, in the 3rd Aldermanic District.
- 151553 - A substitute ordinance relating to the change in zoning of 18 parks located in the City of Milwaukee from several zoning districts to Parks, in the 3rd, 4th, 9th, 10th, 11th, 13th and 14th Aldermanic Districts.
- 151613 - A substitute ordinance relating to parking controls.
- 151614 - A substitute ordinance relating to traffic controls.
- 151663 - A substitute ordinance to further amend the 2016 rates of pay of offices and positions in the City Service.
- 151664 - A substitute ordinance to further amend the 2016 offices and positions in the City Service.
- 151677 - A charter ordinance repealing an obsolete provision of the city charter relating to unclaimed orders.
