An ordinance relating to the amendment of the Official Map of the City of Milwaukee.

Body:

Whereas, The Mayor and Common Council of the City of Milwaukee do ordain as follows:

There is hereby added to the City of Milwaukee Code a new section to read as follows:

Section 113-32.0116 the Official Map, as mentioned and provided for in Section 113-32, is hereby amended so as to include the following additions as shown in the report on file in the City Clerk's office.

1. North-south alley in the block bounded by West Silver Spring Drive, West Thurston Avenue, North 41st Street and North 42nd Street. The vacation of the unimproved portion of the north-south 14-foot wide alley.

N.E. 1/4 Sec. 6, T.7N., R.22E.

1. Unimproved portion of pedestrian lane in the area bounded by West Cornell Street, West Glendale Avenue, North Green Bay Avenue and North 20th Street. The vacation of a 19.08 foot wide pedestrian lane.
